3. Grateful Thanks to USA President Mr Donald Trump, UK Prime Minister Sir Keir Starmer and Protection Fraud Network Top Agent Mr Peter Mandelson for the Treason Deal. It got Criminal Conspiracy Proof that is Relevant Evidence for Corruption Remedies in all Peace Plan Sovereignties. In January 2025, USA President Mr Trump represented the World War III Peace Plan States when he helped the UK Opposition Leaders use the Child Prostitution Scandal to extort Remedy Delivery Commitments from the UK Cabinet. They were Dismissal Executions on Monday 14th July 2025 against the Judiciary by Parliament and then on Thursday 17th July 2025 the Trial Listing of Framing Fraud 2023 0058 of Citizen Mr Akwasi Nkrumah as the Demonstration Case for Victim Identification and Case Remedies. They were Commitment Frauds. The Absolute Priority of the UK Cabinet was Remedy Denial Frauds. It needed Epstein File Concealment Frauds by the USA and Remedy Denial Frauds in the UK and Risk Control against 2023 0058 Case Collapse starting a Network Collapse. They made Lord Peter Mandelson the Concealment Manager and gave him the office of UK Ambassador to the USA. The Network Collapse Risk Control used Harassment Claim CM25F90597 + Protection Application Frauds by the Chronically Immature Mother of the 3 Nkrumah Children and the Claim Lawyers + Hearing Denial Frauds + Family Contact Restraint Frauds by the Family Court against Citizen Mr Nkrumah. They were Set Up Conditions for the Restraint Breach Framing Frauds needed for the Arrest Fraud that stopped Citizen Mr Nkrumah leaving the 2023 0058 Trial a free man, and the 2023 0058 Trial Event getting a Case Collapse starting a Network Collapse. The Exposure Risk Briefing by UK Ambassador Lord Mandelson to USA President Mr Trumps was that the Epstein Scandal was Sex Crimes + Minium Sentence Protection Frauds from the USA Authorities + Blackmail Fraud Business by UK Top Politicians that used Support Services by Mr Epstein and Customer Demand by Top Financiers who used Election Campaign Contributions to but Protection Frauds. It got Trade Negotiations and a Treason Deal. It got Big Bribes for USA President Mr Trump + Epstein File Concealment for the Protection Fraud Network + Defence Sabotage Frauds for Russia against Ukraine, Western Europe and NATO. The Treason Deal Proof Positive includes the Policy Reversal from the Epstein File Exposure to Concealment + Foreign Policy Management that Defence Sabotage Fraud Proof + Cohesion Successes by UK, Western Europe and NATO + Defence Sabotage Fraud Bribe Payment Refusals by Russia + Treason Liability Defence Plan of War Frauds to get War Hero Treason Immunity.

Very often, Stress Conditions get from Vulnerable People, firstly Nothing Happening Pretences and then Proof Positive Assertions, if there is any, and if not, Evidence Denials. The issues are ‘what was the Vulnerability Stimulus?’ and ‘why then?’ It is very simple. It is the Treason Deal + Treason Deal Failure + Treason Liability Defence Failure. The issue is ‘what got Treason Joint Liability for Family Members?’ It is ‘Bribery Money Laundering Arrangements + Delivery’.

Hertfordshire Police used the Stop Failure Framing Fraud NX18MZP for the Worcester 22CA1074323 Bench Warrant Forgery Enforcement Fraud. On Day 29 it got No Action on Investigation NX18MZP by Hertfordshire Police or on Bench Warrant Fraud 22CA1074323 by the Criminal Courts in Chelmsford and Worcester.
