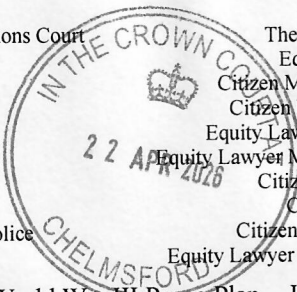

1. Polite Request that:

- 1.1. everyone considers Shared Celebrations that the World War III Peace Plan will get a Just World Order and High Status for the Goodwill Religious Leaders
- 1.2. everyone considers the using the Gaza Re-Development for Shared Celebrations
- 1.3. everyone considers using Unique Beautiful Gifts that will be Eternal Expressions of Genuine Care
- 1.4. everyone considers using Skill Sets preserved by King Charles using the Prince's School of Traditional Art to provide Unique Beautiful Minbars for Gaza Mosques
- 1.5. everyone considers Multi Faith Initiatives to finance the Unique Beautiful Minbars

2. Polite Request that the Duke of Westminster consider providing the Priming Finance that enables the Prince's School of Traditional Art and anyone else to meet the Skill Demand that might be got by Shared Celebrations for the Reasons:

- 2.1. It will be a Shared Celebration of everything that Queen Elizabeth, King Charles and the Royal Family have done to service the World War III Peace Plan
- 2.2. The Peace Plan Shared Celebration should not use Crown Money, Royal Money or State Money
- 2.3. The Westminster Estate is the Most Appropriate Source for the Priming Finance because Equity Lawyer Mr Edward Ellis made a Major Contribution to the Wealth Creation that in about 10 years enabled the Westminster Estate to increase from about 75% to 150% of the Royal Family Estate. In 1956 the Suez Scandal got the Dictator Governance Plan of the Western European States, and the Equity Governance Recovery Plan of the UK Gnostic Christians. It had a National Plan, and a North Shropshire Local Plan. Both needed Business Skills and Legal Skills. The Equity Lawyer understood the Plan Principles and Basic Skill Sets and decided to service Plan Execution before he left Primary School. He realised Ridicule Risk and Sabotage Risk needed Plan Secrecy. The Career Advice from a School Teacher was that he would be an Innovator + Entrepreneur and needed Legal Qualifications to get Personal Control of Business Defences. It got Advice Acceptance by the Equity Lawyer. The Ridicule Risk and Sabotage Risk was proportionate to the Management Capability. The more he knew the less he could tell. He got Law Qualifications and a Law Apprenticeship with a Small Local Firm. He wanted Anaerobic Decomposition Business Profits to provide the Financial Support + Business Connection that enabled the Equity Lawyer to get Law Practice Control without Law Practice Tedium. He attended Market Drayton Cattle Market often enough, but not too often, and used Social Connections to identify Farm Owner Managers who could service the Local Plan. It needed Anaerobic Decomposition of Farm Manure to get Environmental Benefits + Farm Cost Savings + Farm Production Profits + Intellectual Property Rights for Human Sewage Process Profits + Environmental Benefits + Foreign Earnings + Vehicle Tyre Reprocessing. It needed Trigger Conditions. In 1973 the Yom Kippur War got a Humiliating Defeat by Israel against 14 Arab States. In June 1974, the Oil Producing States got their revenge with an Oil Price Increase. It was the Trigger Condition needed for the Local Plan. He asked his brother to help him fill a 10 Gallon Heavy Iron Milk Churn with Pig Manure, turn it upside down, and put it in a 4 Foot Water Trough in a Sheltered Position. It was a Discrete Experiment that discovered the Ambient Temperature + Anaerobic Decomposition were enough to lift the Heavy Iron Churn the 4 inches off the Churn Lid. It did. It was the Support Evidence needed to get Research Co-operation from his brother and father. Everything that could go wrong did go wrong. Someone noticed. Local Gossip got an Event Report from the Farm Supply Salesman. It got Research Sabotage Plan by ICI and the Secret Service for the Farm Supply Manufacturers and State. It used a 500 Acre Farm on the Westminster Estate for Research Sabotage Frauds that did Inefficiency Reputation Damage to Anaerobic Decomposition. The Duke of Westminster realised the Farm Supply Manufacturers made more money out of the Agricultural Estate than he did. He made the Strategic Decision to use Farm Sale Proceeds for Development Finance that got a Rapid Increase in the Estate Assets. A Member of the Ellis Family made it his business to know someone in every village and suburb within 100 miles of his home. It was an Investigation Capability for the Citizen. Event Reports by him forced a Career Change by the Equity Lawyer to focus on Law Practice, service the National Plan before the Local Plan. The Equity Lawyer planned to use Business Profits to finance Economic Growth in Gaza with intent to change the Israeli Mindset. National Plan Successes by the Equity Lawyer motivated Sabotage Frauds by European Leaders against the Local Plan + Gaza People. The Westminster Estate can help make up for the losses.
