Claim Reasons:

1. In 2023, King Charles used Endemic Corruption Proof against the Judiciary to negotiate the World War III Peace Plan for Democratic States. The G& December Summit got Agreement Signatures. The Peace Agreement requires Sovereign States to destroy the Protection Fraud Networks that manage Endemic Corruption, recover control of State Budgets, resource World War III Defences and resource a Just World Order. The Management Agreement got Test Case Status for the UK, and Test Manager Status for the Coronation Oath Enforcement Authority. Delivery Commitments from Japan and the USA and Japan got Remedy Enforcement Damage Payments from Fujitsu and the Pharmaceutical Industry that finance Remedy Budgets needed for the Post Office Scandal and Contaminated Blood Scandal. It got an increase in the MP Retirement Rate, and Incredible Credible Choice for the 2024 UK General Election and a Split Conservative Values Majority Vote that enabled a Minority Vote to get a Landslide Governing Majority and Premier Office for Top Network Agent Sir Keir Starmer and Cabinet Office for Other Network Agents. The 2024 Parliament Session Grant from King Charles started the Dismissal Process against the Protection Fraud Agents who had Cabinet Control. The fact the Landslide Governing Majority had many Novice MPs created the need for International Support for Dismissal Execution. The Church of England Scandal was that Sex Crime Complaints by Victims and Bishops got Investigation Denial Fraud Proof against the State. It prepared for the Next Step in the Dismissal Process. USA President Mr Trump represented the Peace Plan States when he helped the UK Opposition Leaders use the Child Prostitution to extort Remedy Delivery Commitments from the UK Cabinet. It was Dismissal Executions on 14<sup>th</sup> July 2025 against the Judiciary and a start to Victim Identification + Case Remedies on 17<sup>th</sup> July 2025 using a Framing Fraud 2023 0058 Trial of Citizen Mr Nkrumah.
