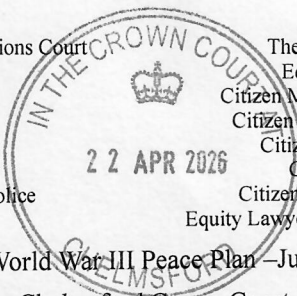

2. Within 14 Days All 22CA1074323 Case Records Discovery Order + Order Breach Contempt Penalty Warning for Equity Lawyer Mr Ellis that the Worcestershire Crown Prosecutor and Worcester Magistrates Court Chief Administrative Officer
3. Jurisdiction Trial Directions Hearing in Chelmsford crown Court at _____ on _____ 2026

Reasons:

1. King Charles used Endemic Corruption Proof against the UK Judiciary to negotiate the World War III Peace Plan for Democratic State. In December 2023 the G7 Summit got signatures on the Plan Agreements:
 - 1.1. The Peace Agreement requires Sovereign States to destroy the Protection Fraud Networks that manage Endemic Corruption, recover control of State Budgets, resource World War III Defences and resource a Just World Order
 - 1.2. The Management Agreement got Remedy Test Case Status for the UK and Test Case Manager Status for the Coronation Oath Enforcement Authority
 - 3.1. The Remedy Agreement got Remedy Enforcement against Fraud Profiteers and Penal Enforcement against Corrupt Leaders
 - 3.2. The Delivery Agreement got Delivery Commitments some of which were conditional
 - 3.3. The Publicity Agreement got Whole Plan Secrecy and Mass Publicity for Plan Stage Successes until there were enough for Whole Plan Publicity
2. Equity Lawyer Mr Ellis claims that:
 - 2.1. Crown Court Trial Fraud Proof for Citizen Ms Michelle Davies against the Osteopath General Council the Worcester Judges used the 22CA1074323 Trial Fraud Proof Set for the Equity Lawyer against the State is got Bribery Proof against Lord Mandelson and the Pharmaceutical Industry
 - 2.2. The Bribery Proof enabled USA President Mr Biden to manage Remedy Enforcement against the Pharmaceutical Industry that got Damage Payments that financed the Remedy Budget needed for the Contaminated Blood Scandal. The Corruption Exposure got by it and the Post Office Scandal enabled the 2024 General Election got a Power Transfer from the Protection Fraud Network Agents that controlled the Conservative Values Representation in Parliament to a Landslide Governing Majority controlled by Other Network Agents.
 - 2.3. The 2024 Parliament Session Grant started a Dismissal Process against them. Remedy Delivery Conditions got Condition Breaches, a Remedy Denial Fraud Finding by the Parliament Sessions Court against the Cabinet and the Default Dismissal Penalty against Prime Minister Sir Keir Starmer. The Landslide Majority created the need for International Support to manage Dismissal Execution against him.
 - 2.4. In January 2025, USA President Elect Mr Trump represented the Peace Plan States when he helped the UK Opposition Leaders extort Remedy Delivery Commitments from the Cabinet. They were Commitment Frauds. Prime Minister Sir Keir Starmer used the office of the UK Ambassador to the USA and Lord Mandelson as Negotiation Agent to get a Treason Deal with USA President Mr Trump. It got Big Bribes for USA President Mr Trump, Epstein File Concealment Frauds for the Protection Fraud Network and Defence Sabotage Frauds for Russia against Ukraine, Western Europe and NATO and Money Laundering Profits for the Trump Family. Remedy Delivery Failures in July 2025 got the September 2025 Corruption Publicity against Prime Minister Sir Keir Starmer and the Forced Resignation against the Deputy Prime Minister, the Ambassadorship Forced Dismissal against Lord Mandelson and Epstein File Disclosures that got the Mendelson Scandal. It and Defence Sabotage Failures were Treason Deal Failures and a Penalty Risk that got a Treason Partnership Collapse. USA President Mr Trump made a Defence Plan. It needed Iran War Frauds + Blitzkrieg Success + Total Victory + War Hero Status + War Hero Treason Immunity. It got Total Victory Failure + War Monger Status that increased the Treason Liability. It got a Confidence Collapse by Trump Family Members in the capacity of USA President Mr Trump to deliver Treason Money Laundering Immunity.
 - 2.5. The Iran War Frauds got a Dismissal Delay for Prime Minister Sir Keir Starmer.
 - 2.6. Treason Prosecutions in the UK and USA need the Worcester Court Fraud Proof that is Bribery Proof
