Brief Claim Governance Frauds did and do Life Ruin Damage. Law Profession Practice Disqualification Frauds +
Crime Framing Frauds + Civil Contempt Framing Fraud did and do Defamation Damage + Liberty Restraint Damage +
Estate Management Damage. Passport Denial Frauds did and do Identity Proof Denial Damage + Asset Freezing
Damage and enable Asset Theft Damage. Court Restraint Frauds did and do Remedy Denial Fraud Damage. A series of
Murder Conspiracies that used Poison Crimes + Medical Treatment Denial Frauds did and do Life Quality Damage. The
Fraud Motive was to stop the Equity Lawyer providing Support Services for the Corruption Remedy Process managed
by the Coronation Oath Enforcement Authority

The Context

1. The World War II Peace Settlement had Fundamental Flaws. The Human Rights Declaration omitted Case Priority Rights for the Victim and Citizen and Top-Level Corruption Controls for the People that are Credibly Independent of the State, Law Courts, Cabinet and Parliament. The Declaration Signatories gave and got Mutual Approval of the Fundamental Flaws and used them to develop Dictator Powers.
2. In all Declaration States the Politicians lost control of the Dictator Powers to Crime Partnerships of State Officers and Law Court Judges. They developed Protection Fraud Networks to provide Support Services and co-ordinate Endemic Corruption. They sell Market Frauds to Organized Crime, provide the Protection Frauds needed to manage them and trade Glittering Career Guarantees and Job Profits in exchange for Fraud Services by Corrupt Parliamentarians. Corruption Remedies needed a Top-Level Corruption Controller that was Credibly Independent of the State, Law Courts, Cabinet and Parliament.
3. The UK is unique. It is a Declaration Signatory and has a Credibly Independent Top-Level Corruption Control known as the Coronation Oath Enforcement Authority. The Dictator Governance Plan for Western Europe used Sabotage Frauds against it. Evidence Frauds denied a Reliable Supply of Admissible Evidence with intent that everyone forgets how to service it. Education Frauds denied any mention of it in Academic Curricula and Profession Qualification Curricula with intent everyone forget it existed. Queen Elizabeth needed Criminal Conspiracy Proof against a serving Prime Minister and confidence there would be a Reliable Supply of Admissible Evidence to revive active service of it.
4. In 2004, the preparations for the European Referenda got Election Fraud Conspiracy Proof against European Leaders including Prime Minister Mr. Blair. The Election Fraud Concealment Plan got a Criminal Conspiracy Proof Set against them. The Equity Lawyer got the Fraud Proof, informed Queen Elizabeth and gave her confidence he would provide a Reliable Supply of Admissible Evidence. She revived active service of the Coronation Oath Enforcement Authority and started a Corruption Remedy Process. It uses Research Investigations to discover the structure and strength of the Endemic Corruption Managers and then Remedy Delivery.
5. The Standard Process for Remedy Delivery is Dismissal Executions against the Judiciary by a United Parliament, Victim Identification, Case Remedies and the Cabinet as Negotiation Manager to get International Agreement by Democratic States for a Peace Plan and Just World Order. The Peace Agreement requires Sovereign States to destroy Protection Fraud Networks that manage Endemic Corruption, recovery control so State Budgets, resource War Defenses and resource a Just World Order. The Management Agreement gets Test Case and Test Manager The Remedy Agreement gets Remedy Enforcement against Fraud Profiteers and Penal Enforcement against Corrupt Leaders. The Delivery Agreement gets Delivery Commitments, some of which are conditional on Plan Stage Successes. The Publicity Agreement requires Whole Plan Secrecy and Mass Publicity for Plan Stage Successes, without disclosure that is what they are, until there are enough for Whole Plan Publicity.
6. A Parliament Unity Failure gets a Special Procedure. It uses Endemic Corruption Proof against the Judiciary and the Crown as Negotiation Manager to get International Agreement for the Peace Plan and Just World Order.
7. Contempt Claims 2022 002595 + 2022 003098 + Fraud Appeal 2023 000569 + Fraud Appeal 2023 0174 got Liability Frauds + Appeal Remedy Denial Frauds + Imprisonment Frauds against Equity Lawyer. They completed an Endemic Corruption Proof Set against the Judiciary. King Charles used it to get the World War III Peace Plan Agreements. Citizen Mr. David Cameron was the Negotiation Agent. 2 General Elections and Career Sacrifice trying to keep the UK in the European Union earned enormous respect from World Leaders. The quest 'who controls your state' got Power Boats by Democratic Leaders. He disclosed that a Renegade UK Judiciary use Court

Powers as a Private Business Asset, dump the Liability Costs on the Cabinet and make Just Governance impossible. It got Same Problem Admissions by All Democratic Leaders and Peace Plan Agreement from many of them.

8. The most notable exception is India. The Baby Sunaina Chaudhari Case motivated the Peace Plan Refusal and India joining Blatant Dictator Summit of China, Russia and North Korea. The Genome Project got High Market Prices for Human Organs that were Genetic Defect Proof. Killer Doctors used Development Defect Proof for Genetic Defect Diagnosis Frauds + Doomed Life Prognosis Frauds + Abortion Prescription Frauds that got the Abortion Material, and if that failed Full Anesthetic Cesarean Section Birth Prescription Frauds and used the Unconscious Period of the mother for Baby Murder and then Human Organ Theft. In 2000, the Sunaina Chaudhari Case got Health Records and Body Carcass that are Murder Proof + Human Organ Theft Proof against UK Health Authorities. The Death Inquest and Corruption Claims got Protection Fraud Proof against the UK State and UK Law Courts. The family kept the Body Carcass in the Local State Morgue. In 2006, Corruption Proof got a Dismissal Process and Forced 10 Months Retirement Notice from Prime Minister Mr. Blair. The Notice Period enabled use of the Leadership Contest for an Integrity Test of the Governing Majority. It discovered that more than half were Network Agents or Network Puppets. A Leadership Deal got Support Votes from Prime Minister Mr. Blair for Candidate MP Mr. Brown and Cabinet Office for Protection Fraud Network Agents. The most notable is Mr. Peter Mandelson. He used Cabinet Office held by him and others to manage Network Business Expansion Plans. The first was Performance Enhancement Drugs for Sport Professionals and Fitness Fanatics. The second was Industrial Scale Court Fraud Business Expansion Plan using Land Frauds for Big Owners against Small Businesses. The third was a Blackmail Frauds Business Expansion Plan. It used Minimum Sentence Protection Frauds from the USA for Mr. Epstein to get Support Services from him for the Blackmail Business. Blackmail Service Deals used Takeover Target Manager Lists from Top Financiers, Introduction Services by Mr. Mandelson, Hospitality Services + Sex Crime Entrapment Services + Sex Crime Framing Fraud Services by Mr. Epstein that got Business Profits for the UK Network. A Protection Fraud Deal got the office of Director of Public Prosecutions for Mr. Keir Starmer
9. The 2023 Peace Plan Management Agreement got Test Case Status for the UK and Test Manager Status for the Coronation Oath Enforcement Authority. The Delivery Agreement got Damage Payments from Fujitsu and the Pharmaceutical Industry that provided the Remedy Budgets for the Post Office Scandal and the Contaminated Blood Scandal. Corruption Exposure got an increase in the MP Retirement Rate, an Incredible Choice and Split Conservative Values Majority Vote that enabled a Minority Vote in the 2024 UK General Election to get a Landslide Governing Majority with many Novice MPs led by Top Network Agents and Premier Office for Sir Keir Starmer. The 2024 Parliament Session Grant from the Crown required 20,000 Political Prisoner Releases, Dismissal Executions against the Judiciary, Victim Identification and Case Remedies. Session Grant Condition Breaches got Remedy Denial Fraud Findings against the Cabinet and the Default Dismissal Penalty against the Prime Minister. The Landslide Majority with many Novice MPs created the need to get International Support for Dismissal Execution against the Network Agents in the UK Cabinet. The Church of England Scandal was that Sex Crime Complaints by Victims and Bishops got Investigation Denial Fraud Proof against the State. In January 2025, USA President Mr. Trump represented the Peace Plan States when he helped the UK Opposition Leaders use the Child Prostitution Scandal to extort Remedy Delivery Commitments from the UK Cabinet. They were Commitment Frauds. Their Absolute Priority was Epstein File Concealment Frauds. They made Lord Peter Mandelson the Concealment Manager and gave him the office of UK Ambassador to the USA. A Corruption Briefing by Ambassador Lord Mandelson to USA President Mr. Trump got a Treason Deal. It got Big Bribes for Mr. Trump, Epstein File Concealment Frauds for the UK Protection Fraud Network, Defense Sabotage Frauds for Russia against Ukraine, Western Europe and the North Atlantic Treaty Organization and Bribe Money Laundering for Trump Family Members. Deal Failures motivated a Treason Defense Plan for President Mr. Trump. It needed Iran War Frauds + Blitzkrieg Success + Total Victory + War Hero Status + War Hero Immunity. A Total Victory Failure got War Monger Status. The Peace Plan States needed Dismissal Execution against UK Prime Minister Sir Keir Starmer and All Network Agents that have UK Cabinet Office, and isolation of the USA President.

The Case

10. The Equity Lawyer provided Support Services for the Remedy Process and World War III Peace Plan. It motivated Ruin Frauds by the Protection Fraud Network against him. The Peace Plan needs the Governance Fraud Claim to discover whether it gets Remedy Co-operation from the High Court when the Dismissal Process against Network Agents in the UK Cabinet is in progress. It needs use of Civil Court Contempt Powers for Liability Investigations + Remedy Investigations + Special and General and Aggravated and Exemplary Damages + Reputation Restoration + Liberty Restoration + Estate Restoration.
