Human Rights Declaration Amendments - Case Priority Rights for the Victim and Citizen + Top Level Corruption Controls that are Credibly Independent of the State, Law Courts, Cabinet and Parliament.

REASONS:

1. Peace Plan State Leaders need State Offices and Law Officers to know something. King Charles represented the not only the UK, but all Peace Plan States, on the Short Notice State Visit to celebrate the 250th Anniversary of USA Independence.
2. Peace Plan had a series of Stage Successes. They created the need for the Short Notice Visit.
3. The Peace Plan needs to replace Dictator Governance with Equity Governance. It needs to destroy the Protection Fraud Networks that manage Endemic Corruption, recover control of State Budgets, resource World War III Defences and resource a Just World Order.
4. The Peace Plan got Corruption Remedy Test Case Status for the UK and Test Manager Status for the Coronation Oath Enforcement Authority. Commitment Deliveries by Japan and the USA got Remedy Enforcement against Fraud Profiteers. They got Damage Payments that financed Remedy Budgets for the Post Office Scandal and Contaminated Blood Scandal. Corruption Exposure got an increase in the MP Retirement Rate, and Incredible Choice for the 2024 General Election, and a Split Conservative Values Majority Vote that enabled a Minority Vote to get a Landslide Majority, that had many Novice MPs, led by Top Agents of the Protection Fraud Network and Premier Office for the Topmost Agent, Sir Keir Starmer. The 2024 Parliament Session Grant serviced a Dismissal Process against the Network Agents who had Cabinet Office. It required Remedy Delivery starting with 20,000 Political Prisoner Releases, Dismissal Executions against the Judiciary by Parliament, Victim Identification and Case Remedies. The Cabinet could not acknowledge any Political Prisoners because Sir Keir Starmer got Imprisonment Frauds against many of them when he was Director of Public Prosecutions. 3,500 Guilty Prisoner Releases for the Overcrowding Reason was a Grant Condition Breach. It got a Remedy Denial Fraud Finding by the Parliament Sessions Court against the Cabinet and the Default Dismissal Penalty against the Prime Minister. The Landslide Majority created the need to get Internation Support for the Dismissal Process. The Church of England Scandal was that Sex Crime Complaints by Victims and Bishops got Investigation Denial Fraud Proof against the State. It was a Test Case Stage that prepared for the Next Stage. The Peace Plan States used USA President Elect Mr Trump as their representative. They supported the UK Opposition Leaders in use of the Child Prostitution Scandal to extort Remedy Delivery Commitments from the UK Cabinet. They were Dismissal Executions against the Judiciary on Monday 14th July 2025 by Parliament, and use of Framing Fraud 2023 0058 of Citizen Mr Nkrumah to start Victim Identification and Case Remedies on Thursday 17th July 2025 by the Law Courts. They were Commitment Frauds. The Absolute Priority of the UK Cabinet was Remedy Sabotage. It needed Epstein File Concealment Frauds in the USA and a New Framing Fraud against Citizen Mr Nkrumah in the UK. It needed an Epstein File Concealment Fraud Deal with USA President Mr Trumps and Deal Secrecy from the Presidency Administration Staff and President's Private Business Staff. Deal Secrecy needed the Deal Negotiator to have Personal Access to USA President Mr Trump. Lord Peter Mandelson had managed Expansion Plans for Network Business. One used Minimum Sentence Protection Frauds from USA Authorities for Mr Epstein that got Support Services from Mr Epstein for a Blackmail Business for the UK Protection Fraud Network. Takeover Plans used Takeover Target Manager Lists provided by Top Financiers, Introduction Services by Mr Peter Mandelson, later Lord Mandelson, Hosting Services by Mr Epstein for Entrapment Frauds + Framing Frauds that got Sex Crime Blackmail Evidence for the Top Financier, Enormous Profits for the UK Protection Fraud Network and the motive and resources use Election Campaign Contributions to buy Protection Frauds. They made Lord Peter Mandelson the Concealment Fraud Manager and used a Security Clearance Failure Waiver Fraud to give him the office of UK Ambassador to the USA. It got the Person Access, Secret Negotiations and Treason Deal. It got Big Bribes for USA President Mr Trump, Epstein File Concealment Frauds for the UK Protection Fraud Network and Defence Sabotage Frauds for Russian President Mr Putin against Ukraine, Western Europe and the North Atlantic Treaty Organisation and Bribe Money Laundering for Trump Family Members.
5. Treason Deal got what appeared to be Stage Successes until the Remedy Delivery Commitment Failure in July 2025 by the UK Cabinet got Corruption Exposure in September 2025 against UK Prime Minister Sir Keir Starmer. It got the Tax Fraud Forced Resignation from the UK Deputy Prime Minister and used the Epstein Scandal to get the Mandelson Scandal, the Forced Dismissal from the Ambassador Office, and the Public Office Misuse Crime Arrest + Peerage Forfeit of Mr Peter Mandelson. It motivated a Treason Immunity Defence Plan. It needed War Frauds + Blitzkrieg Success + Total Victory + War Hero Status + War Hero Treason Immunity. A Total Victory Failure + War Monger Status + Peace Negotiations created the need to stop Just World Order Sabotage Frauds by Mr Putin + Sir Keir Starmer + Mr Trump. The Dismissal Process did more Credibility Damage to Sir Keir Starmer.
6. The State Visit enabled King Charles to help Mr Trump cope with the Peace Negotiations.
