  - 2.1. Please ask the Parliament Sessions Court to instruct the Cabinet to monitor the Group Response from State Officers and Law Officers and the Law Professions to the Dignity Recovery Proposals dated 6<sup>th</sup> May 2026.
  - 2.2. Please ask Professor Robert Barlett and Dr Gloria Moss if they will assist Dignity Recovery by the Academic Professions. Both did excellent work. Many others did. We must start somewhere. Let us start with them. Professor Barlett produced the tv series called the Normans. It ends with him explaining that the Ireland Invasion in 1171 by Henry II established the Colonial Mindset that Coloniser is superior to Colonised. He explained that the Colonial Mindset did Chronic Damage that affects us today. One of the ironies is that Henry II tried what we recognise as Change Management from Dictator Governance to Equity Governance. He used Jury Trials to get a Power Transfer for Crown Courts against Church Courts and for the Jury against the Judge. Professor Barlett has been justly recognised for his work. Dr Gloria Moss has not. The Professor Post required Management Research by that got Profession Publicity. She did Management Research that got Efficiency Findings on Every Measure for Distributed Systems against Concentrated Systems. They were Efficiency Findings for Equity Governance against Dictator Governance. It motivated a Ruin Fraud Conspiracy by the UK Dictator State against her. They stopped the Times Publicity and used a Redundancy Plan with her as the Sole Dismissal Target. It is an excellent case to service Dignity Recovery by the Academic Profession. If the universities cannot be trusted with Management Research, they cannot be trusted with anything else. Dignity Recovery needs Victim Identification + Case Remedies. The likelihood is it will find Intellectual Property that will resource Economic Recovery. The Market Exclusion Frauds against Advanced Electronic Signatures can serve as a Demonstration Case of Economic Damage. Dr Moss had a son who was 21 years old at the time. She feared that giving the Coronation Oath Enforcement Authority used of the case would motivate Penalty Frauds against her son.   - 2.3. Please note that the Corruption Case of Suzanne Kellner - Johnson has been known about for years. She is an Austrian National. Repatriation Blackmail by the UK State stopped her giving use of it the Coronation Oath Enforcement Authority until 4<sup>th</sup> May 2026. The Corruption Damage includes Mental Health Frauds that have done Mental Health Damage. The case will be excellent for setting an Incapacity Representation Precedent. Dr Julia Spviack discovered the case years ago. They have been friends ever since. Corruption Proof against the Law Professions and the Friendship Evidence validate a Representative Appointment of Citizen Dr Spivack for Citizen Victim Ms Keller – Johnson. Proposal Criticism Reserved Rights for Citizen Victim Ms Keller – Johnson when she is allowed Free Communication.
  - 2.4. Please ask the Parliament Sessions Court to make a Priority Decision for issue by the UK Cabinet of a UK Passport and Inheritance Tax Clearance needed for a Probate Grant of the Intestate Estate of the late Mr Charles Sydney Ellis, and issue by the High Court of the Governance Fraud Claim of the Equity Lawyer Mr Ellis v UK Cabinet. The Reason is that the Remedy Process needs a Corruption Damage Investigation. The Passport Denial Fraud prevents Money Laundering Compliance needed to identify and claim Fraudulently Frozen Assets and Stolen Assets. The easiest Target Assets are the Barclays Bank Account of the Equity Lawyer and the Natwest Bank Account and Endowment Policies of his late brother Charles Sydney Ellis. The Equity Lawyer arranged for Share Dividend Payments to go into the Barclays Bank Account.
