Upon the Court having Judicial Knowledge of the need for Dignity Recovery by the Authorities

1. Court Motion Enforcement Stay Witness Protection Order + Order Breach Contempt Penalty Warning for Citizen Witnesses Ms Michelle Davies, Ms Suzanne Kellner Johnson and Mr. Akwasi Nkrumah against the UK Cabinet.

Reasons:

1.1. Bribery Management by Protection Fraud Network Top Agent Mr Mandelson got Osteopath Misdescription Trial Frauds by the Worcester Criminal Judges. Fraud Orders by the Worcester Judges got Fraud Execution by Court Officers and then Confidence Collapses in the capacity of the Judiciary to manage Protection Frauds, Confidence Recovery in the capacity of the Coronation Oath Enforcement to manage and Protection Justice. They used Corruption Evidence Offers for the Citizen against the State as Remedy Co-operation Proof for the Coronation Oath Enforcement Authority. The Corruption Proof was a Written Admission that the Law Courts had No Record of Council Tax Liability Cases. It was Council Tax Liability Order Forgery Proof against Worcester City Council. The Epstein Scandal got the Mandelson Scandal. It created the need for the UK Cabinet to provide Reassurance Proof for the Protection Fraud Network. The UK Cabinet issued a Bankruptcy Enforcement Fraud Order to Worcester City Council for Council Tax Liability Order Forgeries. Bankruptcy Case 2026 0012 got service from the Worcester Judges until a Confidence Collapse got Case Process Refusal Fraud Proof against them.

1.2. Bribery Management by Network Drug Wholesaler Mr Benjamin Koomson for the Local Police, Local Child Protection Officers, Local Judges and Local Mental Health Officers got Child Prostitution Protection Fraud for him from All Relevant Authorities. The Blackmail Statement dated 14th October 2024 of Citizen Mr Akwasi Nkrumah enabled the Commissioner Rank of the Metropolitan Police to get Child Prostitution Protection Fraud Proof against the UK Cabinet. It was part of the preparation for Remedy Process Management in January 2025. USA President Elect Mr Trump was representative of the Peace Plan States when he assisted the UK Opposition Leaders use the Child Prostitution Scandal to extort Remedy Delivery Commitments from the UK Cabinet. They were Dismissal Executions on Monday 14th July 2025 against the Judiciary by Parliament and a Trial Listing on Thursday 17th July 2025 of Framing Fraud of the Framing Fraud 2023 0058 against Citizen Mr Nkrumah and use of it for Victim Identification and Case Remedies with Mass Publicity. They were Commitment Frauds. Their Absolute Priority was Remedy Sabotage Frauds. It needed Remedy Delivery Denial Frauds in UK and Epstein File Concealment Frauds in the USA. It needed Personal Contact with USA President Mr Trump that gave him the confidence he had enough Information Control to make a Treason Deal. They made Lord Peter Mandelson the Concealment Manager and gave him the office of UK Ambassador to the USA. It got the Personal Contact, Corruption Exposure Briefing and Treason Deal. It got Big Bribes for USA President Mr Trump, Epstein File Concealment Frauds for the UK Protection Fraud Network, Defence Sabotage Frauds for Russia against Ukraine, Western Europe and the North Atlantic Treaty Organisation and Money Laundering for Trump Family Members. The Remedy Delivery Failures got Corruption Exposure against the UK Cabinet, a Forced Resignation from the Deputy Prime Minister and Ambassador Office Forced Dismissal against Lord Mandelson and then a Forced Arrest for Public Office Misconduct and Forced Peerage Forfeit.

1.3. Bribery Investigation is needed to discover the precise management of the Ruin Fraud Conspiracy against Citizen Ms Suzanne Kellner – Johnson. The Fraud Proof got by Equity Lawyer Mr Ellis, Citizen Ms Davies and Citizen Mr Nkrumah get a Fraud Presumption in All Cases for All Citizens, including Ms Kellner - Johnson, against the UK Authorities. The Scheule contains Sample Communications from Citizen Dr Spivack that explain the case.
