Request whether the Requestees are willing to act on the Governance Fraud Claim Instructions, and if not, whether they can recommend anyone else who has the competence to do so?

Governance Claim Instructions of Citizen Ms Susanne Kellner – Johnson v Cabinet.

Brief Claim: Governance Frauds allowed Contempt Fraud Conspiracies against the Citizen Claimant. Theft Motivated Frauds by the Former Husband got from 1998 to 2026, Credible Neutrality Denial Frauds + Mental Health Frauds by the Investigators and Prosecutors, Service Denial Frauds by Defenders and Mental Unfitness Liability Adjudication Frauds by Trial Adjudicators, and Remedy Issue Denial Frauds by the Law Courts, that denied completion of UK Remedy Processes needed to qualify for issue of Corruption Remedy Claims in the European Court of Human Rights.

In 2007, No Case Record Evidence from Law Court Officers is Arrest Warrant Forgery Proof, or Arrest Warrant Pretence Fraud Perjury Proof against Yorkshire Police. The Common Law has Integrity Controls. One is that Fraud Proof of anything gets a Proof Burden Reversal for Fraud Victims against the Fraud Managers and Fraud Beneficiaries. It is managed by use of a Fraud Presumption of everything else for Fraud Victims against Fraud Managers and Fraud Beneficiaries that is subject to Rebuttal Proof Positive. It validates a Fraud Presumption of everything from 1998 to 2026 for the Citizen against everyone who has Manager Status and Beneficiary Status.

Medication Frauds did Personal Injury Damage + Grievous Bodily Harm Damage + Prescribed Drug Addiction Damage + Life Ruin Damage.

The Drug Withdrawal Treatment Decision got Small Dose Reduction Advice from the Qualified Expert, Dr Julia Spivack, that the Mental Health Team ignored. Withdrawal Negligence used Too Big Dose Reductions, triggered Psychotic Episodes and added to the Fraud Damage.

Remedies

1. Pending Remedies Enforcement Stay Protection Order + Mental Illness Detention Immediate Release Order for the Citizen against the Cabinet REASONS: The Common Law requires it
2. Contempt Remedy Investigation Order + Disclosure Order for the Citizen against the Cabinet that they do within 7 days, acting by the Cabinet Secretary file and serve a Statement that explains why the court should not make the Findings and Orders:
 - 2.1. Common Law Governance Finding for the Citizen against the Cabinet for the REASONS: In 2023, King Charles used Endemic Corruption Proof against the UK Judiciary to negotiate the World War II Peace Plan for Democratic States. The G7 December Summit got Agreement Signatures. The Peace Agreement requires Sovereign States to destroy the Protection Fraud Networks that manage Endemic Corruption, recover control of State Budgets, resource World War III Defences and resource a Just World Order. The Management Agreement got Test Case Status for the UK and Test Manager Status for the UK Coronation Oath Enforcement Authority and Governance Superiority for the Common Law against the Justice Management Regimes of the Peace Plan States.
 - 2.2. Priority Finding for the Citizen's Corruption Case against All State Cases. Reason: The Common Law requires it.
 - 2.3. Corruption Case Finding + Case Priority Finding + Fraud Finding + Contempt Liability Finding + Remedy Entitlement Findings + Damage and Causation Proof Burden Reversal Entitlement Findings for the Citizen against the State. Reasons:
 - 2.3.1. The Common Law has Integrity Controls. One is that Fraud Proof of anything gets a Fraud Presumption of everything else for Fraud Victims against Fraud Managers and Fraud Beneficiaries, that is subject to Rebuttal Proof Positive. In 2007, the No Case Record Evidence of Yorkshire Law Court Officers is Arrest Warrant Forgery Proof or Arrest Warrant Pretence Fraud Perjury Proof + Arrest Fraud Proof + Detention Fraud Conspiracy Proof for the Citizen against All Case Officers + Yorkshire Police + Bradford District Mental Health NHS Trust + Health Ministry + Cabinet.
 - 2.3.2. The Proof Burden Reversal validates an Authoritative Drug Withdrawal Management Opinion Finding for Dr Spivack and Malicious or Reckless Opinion Reject Presumption for the Citizen against Case Officers and All Relevant Authorities + Rebuttal Proof Positive Impossibility Finding
3. All Issue Appeal Rights Acknowledgement for the Citizen and Cabinet. REASON. The Common Law requires it
