Defendant UK Cabinet Interested Parties: Yorkshire Police + Ministry of Health + Ministry of Justice

Brief Claim: Context Explanation

1. The World War II Peace Settlement had Fundamental Flaws. The Human Rights Declaration of Case Priority Rights for the Victim and Citizen and Top-Level Corruption Controls for the People that are Credibly Independent of the State, Law Courts.
2. The Suez Scandal was a disgraceful end to the Colonial Era for the UK and France. They used the Fundamental Flaws to make a Governance Plan for Western Europe. It was for Dictator Governance by the State against Equity Governance using the Common Law. The Politicians lost control to Crime Partnerships of State Officers and Law Court Judges who developed Protection Fraud Networks to provide Support Services and manage Co-ordinated Corruption. They sold Market Frauds to Organised Crime, provide Protection Frauds for Corrupt Officers and traded Glittering Career Guarantees and Job Profits for Fraud Services by Corrupt Parliamentarians.
3. The Gnostic Christians made an Equity Governance Recovery Plan. It needed Protocol Notices from Media Managers and Opposition Leaders that Dictator Governance that Effective Accountability needed a Big Citizen to service the Equity Governance Recovery Plan.
4. The Protection Fraud Network sold Immunity Frauds for Health Frauds by the Pharmaceutical Industry + Drug Crimes and Child Prostitution by the National Network of Police Officers + Many Other Crime Businesses
5. Mental Health Frauds + Legal Incapacity Frauds were Protection Fraud Weapon against Exposure Risk Individuals.
6. A Drug Research Fraud Conspiracy by Psychiatrists and the Pharmaceutical Industry used Mentally Ill Patients. The Drug Research Frauds created the need for Permanent Control Frauds against Mental Health Fraud Victims. The Permanent Control Frauds used Permanent Health Frauds. Psychiatry Academics did not tell Academia Colleagues. In the 1980's a USA Law Professor wanted Law Students to get Evidence Experience. He told them to use Illness Pretences to get Illness Medical Records with intent to the Evidence Experience being the Record Correction Process. It got Mental Illness Diagnosis Frauds + Prescription Frauds that needed Permanent Protection Frauds. Disclosure of the Evidence Experiment discovered the mental Health Frauds. UK Prime Minister Mrs Thatcher and USA President Reagan did not have the confidence to manage Corruption Remedies against the Psychiatrist and Pharmaceutical Industry. The Scandal Response of the UK Prime Minister was to Mental Health Hospital Decommissioning Operation and Budget Starvation. It increased the Financial Dependency of the Psychiatry Profession on the Pharmaceutical Industry. It was a Psychiatry Management Power Transfer for the Pharmaceutical Industry against the State.
7. The Protection Fraud Network made a series of Business Expansion Plans. Research Investigations discovered that Industrial Scale Court Frauds needed Business Management Systems that serviced Evidence Exclusion Frauds on an Industrial Scale. Top Network Agents made a Profit Share Preservation Plan. It needed to avoid the Cabinet Profit Share reducing the Top Agent Profit Share. It delayed the Protection Fraud Network getting Cabinet Control.
8. The Protection Fraud Network sold Market Frauds for Drug Treatment against Other Treatment. One got creation of the General Osteopathic Council to manage Profession Governance Frauds against Registered Osteopaths.
9. In 1997, the UK General Election got a Landslide Governing Majority for Prime Minister Mr Blair and Cabinet Office for Network Agent Mr Peter Mandelson. They were Totally Corrupt. It did not get Cabinet Control for the Protection Fraud Network because Mr Blair would have demanded too much. Mr Mandelson used Cabinet Office to service the Network Business Expansion Plan for Physical Performance Enhancement Drugs, and managed Policy Waiver Fraud Marketing for Prime Minister Mr Blair. The Formula I Tobacco Advertising Waiver Fraud was a Marketing Tool. In 1998, a Corruption Scandal got the Forced Resignation of Mr Mandelson. He continued to function as Top Agent of the Protection Fraud Network and Fraud Marketer for Prime Minister Mr Blair.
10. The Genome Project got High Market Prices for Human Organs that were Genetic Defect Evidence. Killer Doctors used Development Defect Evidence for Genetic Defect Diagnosis Frauds + Doomed Life Prognosis Frauds + Abortion Prescription Frauds, to get the Abortion Material, and Full Anaesthetic Caesarean Section Birth Prescription Frauds and used the Unconscious Period of the mother for Baby Murder that got the Human Organs.
11. In 2000, Osteopath Governance Fraud Complaints in more than 200 Constituencies got a Corruption Debate in Parliament. By chance, it coincided with the Sunaina Chaudhari Case getting a Complete Set of Baby Murders + Human Organ Theft Conspiracy Proof against the National health Service. The Corruption Debate got an Investigation Commitment + Pending Investigation Adjournment + Trade Negotiations + Protection Fraud Bribes + Investigation Denial Frauds + Adjourned Debate Failure + Equity Governance Recovery Plan Protocol Signal from

Media Managers. It was Unusually Long Coverage by TV News of Prime Minister Questions, images of the House of Commons Chamber after the MPs had left and the Voice Over 'Election Campaign Contributions are coming in Unusually Early'.

12. In 2001, the Protection Fraud Network had a Business Expansion Plan that needed a Drug Production Business that produced a Reliable Supply of Top-Quality Drug that were Chemically Traceable so that Buffer Stocks could be used at any time for Career Sabotage Frauds against Honest Officers. It needed Sussex Water and therefore Sussex Sites. Bankruptcy Frauds 1991 191 got a Bankruptcy Estate that included Somersales Farm, London Road, Crowborough, East Sussex. They decided to use it as the Forst Production Site. Top Police wanted Protection Fraud Proof from Top Judges. The Judgment Fraud dated 8th June 2001, recited Fact Admissions + Intent Admissions that were Fraud Conspiracy Proof against the Petitioner and Trustee and made Remedy Restraint Frauds against the Victim. Top Police accepted it as Protection Fraud Proof. It got Drug Production on that site, and soon afterwards on other sites.
13. In 2003, the Quiet Man Speak of the Opposition Leader was an Equity Governance Recovery Plan Protocol Signal.
14. In 2004, the preparations for the European Referenda got Election Fraud Conspiracy Proof against European Leaders including UK Prime Minister Mr Blair. The Lawful Business of UK Citizens made inevitable exposure of the Election Frauds. They made an Election Fraud Concealment Plan. It got Criminal Conspiracy Evidence against the European Leaders, exposed Routine Drug Trafficking by the Protection Fraud Network, a Profit Share for Prime Minister Mr Blair and Trigger Conditions for the Equity Governance Recovery Plan. Equity Lawyer Mr Ellis gave the Criminal Conspiracy Proof against a serving Prime Minister to Queen Elizabeth. She used it to revive active service of the Coronation Oath Enforcement Authority and start a Corruption Remedy Process. It has continued ever since.
15. In 2023, the Remedy Process got Endemic Corruption Proof against the Judiciary. King Charles used it to negotiate the World War III Peace Plan. The G7 December Summit got Agreement Signatures. The Peace Agreement requires Sovereign States to destroy the Protection Fraud Networks that manage Endemic Corruption, recover control of State Budgets, resource World War III Defences and resource a Just World Order. The Management Agreement got Test Case Status for the UK and Test Manager Status for the Coronation Oath Enforcement Authority

Case Explanation

16. The Claimant is an Austrian Citizen and Health Professional. She married a UK Citizen. He had grown up in Bradford England, was a Technical College Teacher and had Local Connections in the Protection Fraud Network. They lived in Bradford. She had No Network Connections. They had one child. The Husband found someone else, wanted the house but not the child. In 1998, the Husband used Allegation Frauds against the Claimant with intent to get Mental Illness Findings Frauds + Permanent Custody Frauds and House Possession and then a House Title Transfer. He got Mental Illness Finding Frauds but did not get a Permanent Custody. It denied him the house. He needed Child Custody to get House Possession got Temporary Custody Frauds and then Intermittent Custody Frauds but not Permanent Custody Frauds. It motivated him to get Child Custody with intent to use it to get House Possession. It was not enough House Possession because the State needed it for her Intermittent Freedom.
17. Repeat Arrest Frauds + Repeat Detention Frauds did Repeat Kidnap Torture Damage and Repeat Medication Frauds did the Personal Injury Damage of Prescribed Drug Addiction. In 2016, the Claimant and Dr Julia Spivack became friends. The Claimant did not know about the Coronation Oath Enforcement Authority or the Corruption Remedy Process until Dr Spivack told them. UK to Austria Deportation Blackmail by Network Agents deterred the Claimant giving the Coronation Oath Enforcement Authority use of her cases.
18. Withdrawal Treatment Advice from Dr Spivack did not stop Medical Negligence that got Withdrawal Treatment Failures + Psychotic Episodes + Repeat Arrest Frauds + Detention Frauds.
19. In 2025 and 2026 the Remedy Process managed the Corruption Dismissal against Prime Minister Sir Keir Starmer. It got the Case Use Consent dated 4th May 2026 from the Claimant.
20. The World War III Peace Plan needs Precedent Cases. The Claimants Case is ideal for Remedy Precedents against Health Frauds + Imprisonment Frauds + Court Frauds.

Remedies: Corruption Claim Finding + Case Priority Finding + Fraud Finding + Contempt Finding + General and Special and Aggravated and Exemplary Remedy Orders + Reputation and Liberty and Estate Restoration Orders + Costs with Indemnity Assessment Orders for the Citizen Claimant against the Cabinet

Personal Liability Orders for the Citizen and Indemnity Orders for the Cabinet against All Responsible Individuals
