Dear Andy, After a lot of unhelpful people I found a very helpful nurse who passed an email that I wrote to Susanne. Below is her reply. I have 'phoned the Cinema and I am working with them. Do you have Julia Spivak's email address or 'phone number. Also Brian Daniels.

"Dear John Timbrell Esquire.

Thank you for your thoughtful message, a true God-send. Shortly after our last phone call my clinic mobile was confiscated and I was put into seclusion. Been in solitary confinement since 13:45 17th April.

I have extended family here, tried to get Beverly Bottomley appointed after 2 years to speak on my behalf but have not been able to do so. She doesn't know that I am here. I need photos of my smashed in door please. Please go online and ring Jack Bottomley (her son) who is manager at the Keighley Picture House (cinema) and tell his parents. Also please tell Dr. Julia Spivach (email) what has happened, she is my private physician. Please tell Buian Daniels and Andy Peacher also.

Last but not least, this nice chap with lots of crippling pain from chronic health conditions chatted me up in the corner shop of the bottom of my street. He will be really worried as we were chatting via email every day. His name is Mike, Michael Slattery, used to work for DWP, he may be able to help Julia and vice versa.

Can't get into my e-mails as in solitary confinement. Please ring Sutton-Lodge care home where he stayed for respite to get his contact details.

Hello Andy,

Thankyou for passing this stuff onto me.

I saw this coming because in the last few weeks Susanne's emails became increasingly florid and out of touch with reality.

Susanne told me in 2024 they were weaning her off the haloperidol depot injections which was great news at the time and they offered her two choices of schedule of withdrawal: one was to increase the interval of time between injections and the other was to gradually reduce the dose.

I advised Susanne to take the second option of gradually reducing the dose BUT to reduce the dose by smaller increments over a longer time period to minimise rebound psychotic episodes. I wrote a To Whom It May Concern letter for Susanne that she could give to any of the mental health team managing her case. I have attached this letter to this email.

I warned Susanne that the hardest part would be when she comes off the lowest dose and therefore off the drug completely. In my letter I made suggestions for some in-residence management to mitigate a rebound psychosis but instead of that they have let Susanne go into a full blown psychotic meltdown for which she has been hospitalised and no doubt she will be put back on the depot injections and back to square 1 - and these people call themselves "doctors" and delude themselves they are intelligent and qualified.

You have my permission to forward this email with the attached letter to the hospital where Susanne has been taken and to any of the community mental health staff or anyone officially dealing with her care. Please do not willy nilly send it to all and sundry on group emails or post it on the internet or anything like that please because A) **it is confidential information** and B) I don't want problems with the authorities. You may send it to John Timbrell. If possible can you also ask Susanne to add me to the list of approved persons who can enquire of the mental health staff about her care.

**Do you know where Susanne has been taken ?**

I see you copied me in emails with John Timbrell and I received an email from him this morning. The authorities started to investigate me after you posted a confidential phone call between myself and Susanne on the internet which I expressly told you not to do. I had years of additional stress and work because of that.

You came to my house so I could treat Arlene and you disappeared to go find midwife toads like some 10 year old schoolboy without leaving me and Arlene any way of contacting you and didn't say what time you would be back which was most rude.

You parked up in my driveway with an over inflated sense of entitlement and vastly outstayed your welcome.

You insisted you were a retired police officer but when I asked what division of the police you worked in you evaded the question.

You started trying to pass onto me your self-appointed role in Susanne's care so you can freenup your time to attend to your garden - as if I don't have a garden - and then insisted I am solely responsible for Susanne's health which is nonsense.

From the get go you had a general attitude of somehow "recruiting" me to help you with Susanne and telling me to write a report as if I'm your employee using a fraudulent authority as a police officer. It never occurred to me anyone would have the audacity to try to pass themselves off as a police officer when they have never been one.

Its my prerogative how I set my boundaries and who I chose to interact with or not.

Fuck off and leave me alone. Don't contact me again or mention my name anywhere. Julia

Yes Andy, my idea was the right idea but allopathic thinking is so crude and the NHS is such a rigid one-size-fits-all dinosaur assembly line which reflects the rigidity of allopathic thinking - if one can call it thinking !. These

people do not learn how to reason as osteopaths do - they cram rote learn diagnoses and treatment protocols. I impressed upon Susanne the great importance of a very gradual and slow withdrawal.

Towards end of March I started getting increasingly strange emails and text messages and voice messages both on my mobile and landline several times a day and often at an odd hour and I knew she had gone into a full blown psychotic meltdown which would inevitably lead to her being hospitalised again - I saw this coming but when Susanne is in an acute psychotic episode one cannot get through to her and if you try to tell her she is in a psychotic state she will just rail against it and risk losing her trust and I need her to be able to trust me because I need to get remedy for her case through the Royal Commission. I wish I was closer to her geographically so I could maybe do more to help her.

Hello Susanne,

I was informed by Andy Peacher that you have been hospitalised again. To be honest I saw this coming when you started sending a lot of strange emails and texts and phone calls at end of March- early April. Not your fault - they have reduced the dose of the haloperidol depots too rapidly so there is a rebound elevation of dopamine levels and resulting psychotic behaviour. I couldn't say anything to you at the time because I know only too well it would agitate you even more - best just to leave you to get through it. That's why I wrote the letter - attached - to advise the mental health staff that weaning you off the haloperidol depot has to be extremely gradual.

You need to put me on the list of approved persons whom the hospital will allow to communicate with you while you are inside.


I had an email from John Timbrell but I told him in no uncertain terms where to get off because he has caused trouble in the past by violating hospital rules when he posted on the internet a confidential phone call between you and I at the hospital that he had recorded - that sort of behaviour can only make things worse for you and it makes it more difficult for me to help you.

I will write to Clover Ward, Lynfield Mount and print off and send the attached letter to them so they know who I am.

Please let me know if there is anything you need and I will send it to you - for example stationery, postage stamps, toiletries etc.

I have just spoken with Ayla.

I am a friend of Susanne whom I have known for about 10 years now. Because of my background in psychopharmacology Susanne has requested my help in relation to her medication and mental health issues.

I have been there for Susanne when she has been admitted to the PICU on Clover Ward on many previous occasions and I have helped her out with practical things such as communicating with her mother in German and keeping her supplied with stationery etc.

In 2024 when Susanne told me the mental health team decided to wean her off the haloperidol depot injections I wrote a To Whom It May Concern letter with my thoughts on the matter which is attached to this email.

Susanne emailed me this morning and I have replied straightaway - this email exchange is below.

Susanne is lamenting that she has no change of clothes and she is worried about her houseplants and her front door which I believe was broken in by Police. Her neighbours in Victoria Street, Sutton in Craven don't help her with these things. I live in Bedfordshire and I don't have a car otherwise I would drive up to Yorkshire forthwith and tend to these practical things for her.

Would you be able to ask Susanne to add me to the list of persons who are allowed to have communication with her while she is in the PICU ?

It was Andy Peacher who alerted me that Susanne has been admitted to the PICU again therefore I have copied him in this email as a matter of courtesy.

My solicitor refuses to deal with a smashed in door and arbitrary arrest, 101 and 999 want to know nothing about it and tell me to take it up with the care trust, nowhere to go. Apparently my bedroom was ransacked. Computer and papers are still there. Given the state of the door, what was the locksmith doing there and where did that come from? Anyone can just come and smash my door in and drag me out. I have lived for 30 years in fear and terror of them coming for me, living alone is highly dangerous. And now of course they will want me to pay for the damage and for the boarding up, so who really deals with arbitrary arrest in this country? Any ideas welcome. My mum has dementia and can't handle anything, she just utters total disbelief, sadly I have no nearest relative, so nobody can help me. Most people are too thick to understand what's going on here!!!

Eight days in seclusion under the most horrific of circumstances, denial of all human rights, torture, GBH, gang rape, inhuman and degrading treatment, cuts and bruises, 2 broken toes and they kept me in there until the bruises faded so I had no evidence. Thankyou for replying to Susanne's email which is much appreciated by her friends such as myself.

We are honoured and relieved that someone from the CCHR has taken the trouble to reply - we are grateful. I know the CCHR is an offshoot or branch of the Church of Scientology set up to campaign against psychiatric abuse.

Both myself and Susanne are on your mailing list and have been collecting the CCHR's DVDs on psychiatric abuse and the dangers of psychiatric drugs. I have the Scientology App on my iPad for access to the films you produce exposing psychiatric abuse. I am a friend of Susanne. Susanne has asked me to draft a letter that she can show to those managing her haloperidol medication.

I was first asked to assist Susanne in her mental health case in 2016 because of my background in psychopharmacology. I was initially reluctant to get involved in any way until I realised that Susanne is such a highly intelligent and lovely person more than worth the effort.

I understand that Susanne has been under a Compulsory Treatment Order (Section 3 of the Mental Health Act) to receive depot injections of Haloperidol but now the mental health team have taken a decision to wean her off completely and permanently.

Because of my pharmacology background I understand the long term effects of dopamine antagonists used as anti-psychotic drugs. There is up-regulation of dopamine receptors which cause the patient to exhibit psychosis type behaviour when they try to withdraw from the drug.

Susanne informed me she has been given two choices of schedule for withdrawal as follows:

1. increase the interval between doses from 1 month to 6 weeks

or

2. reduce the dose from 40mg to 30mg to 20mg etc at monthly intervals.

Without hesitation I suggested to reduce the dose in 5mg increments if that is possible from 40mg to 35mg to 30mg to 25mg to 20mg and so on and perhaps also increase the dosing intervals as well.

I also have extensive training in various disciplines of natural medicine including a Masters Degree in Ayurvedic Medicine. Susanne has asked me if I can support her through the withdrawal using natural methods.

To this end I have recommended to Susanne to take Ashwagandha which has a dampening effect on central nervous system excitability and Brahmi which improves brain function. It is customary in Ayurveda that we tend not to give single herbs but a combination of several herbs which have a synergistic and complementary effect. So I have recommended the following herbs:

Ashwagandha - reduces central nervous system excitability

Bala

Brahmi - improves brain function

Gokshura

Gotu kola

Guduchi - to help the liver clear the drug

Jatamamsi

Jati-phala

Shankhapushpi

Shatavari

Triphala

Having witnessed what has happened in the past when Susanne has tried to withdraw from the haloperidol I am strongly of the opinion that Susanne should be offered the option of short term use of residential facilities if the withdrawal becomes overwhelming for her.

#### **Summary/overview of the case from the information provided by Susanne**

Susanne claims she has been a victim of a sustained campaign of harassment by police and mental health services (starting in 1998) including forced abduction from her home without prior warning, accompanied by violent physical assaults on her and violation of her dignity by West Yorkshire Police and detention in local psychiatric facility and Compulsory Treatment Orders (CTO) of forced injection of anti-psychotic medication.

Susanne claims the initial incident was in 1998 when police came to her home and dragged her out of the bath naked and forcibly took her to the psychiatric unit and at the same time her **3-year-old child** was smuggled out of the house.

The saga began after the break up of her marriage in 1998. False allegations were made by Bradford District Care NHS Foundation Trust AireWarfe Mental Health Service to get an order from the Court to have her forcibly abducted from her home and sectioned.

There is a formal written testimony from staff on the psychiatric ward testifying that Susanne was treated in an undignified manner by police officers before being brought onto the ward in handcuffs that caused her physical pain.

Susanne sent me a package of documents which I have read and attempted to analyse the case. The documents are mainly letters Susanne has written to the various authorities trying to obtain redress and their replies.

Susanne has also enclosed photographs of bruises on her body where she claims she was kicked and beaten by police officers and photographs of the inside of her home showing that it is clean and neat and organised.

When Susanne attempts to contact the authorities to complain about how she is being treated this triggers further abductions from her home without any prior warning, detentions and CTOs under the MHA.

She is currently injected with depot haloperidol every four weeks and is detained in the psychiatric facility to enforce this. Fortunately the psychiatric facility is only about 1½ miles from her home and she has recently been given leave from the psychiatric unit for 2 hours per day and she can walk home and back.

However if Susanne is seen to be having too much contact – with the outside world or seeking redress for her section then her means of communication – access to computers/internet, telephones, leave from the psychiatric unit etc are curtailed.

Susanne is an Austrian National who came to live in the UK because she married an Englishman.

Reading between the lines of the information I have been given by Susanne I suspect that Susanne's troubles may have been started by her former husband and with this in mind I phoned Susanne today (31/10/16) to ask for some more details about her personal life, marriage, husband etc.

She told me her former husband is John Douglas Johnson currently residing at 17 Fletcher Avenue, Silsden, Near Keighley, West Yorkshire BD20 0LA, which is only a few miles from Susanne's home in Sutton-in-Craven – the two villages are close neighbours.

Susanne said that she and her husband began their relationship as pen-friends and eventually arranged to meet and fell in love and married in 1984 or 1985. They have a daughter, Nicola, DOB 02/12/94.

I asked Susanne for her ex-husband's occupation and she said he is/was a teacher of Craft Design & Technology at St Bedes Catholic School in Bradford. St Bedes was originally a Catholic Grammar School for boys but in 2014 it merged with St Joseph's Catholic College for girls (which I attended in the 6th form from 1976 to 1978) to form St Bedes & St Joseph's Catholic College which is now the largest Catholic school in the country.

Susanne said her husband flies light aircraft as a hobby and is/was a member of a local private flying club.

Susanne said that not long after they were married her husband was in a gliding accident in which he sustained a head injury which resulted in brain injury which caused a personality change.

Susanne told me that her husband changed from being a loving person to being malicious. Susanne said "*he wanted to end the marriage and he tried throw her out of the house and tried to get her sectioned – he no longer wanted to support us [Susanne and her daughter] but I refused to leave*". Susanne claims she suffered mental cruelty from her husband as a result of the head injury.

The husband became depressed and suicidal and was under **Consultant Psychiatrist Dr Andrew Aspin** at Bradford District Care NHS Foundation Trust and this Dr Aspin was also involved in Susanne being Sectioned in 1998. Susanne said that her husband hated his job and did not want to go to work.

The marriage ended acrimoniously and Susanne claims her ex-husband then married his mistress. I asked Susanne if her husband was trying to get custody of their daughter and she said "*no he didn't want the child he was after the house*" which is why he tried to throw her out and he never paid any child support. However he had custody of their daughter in 2001 and Susanne claims she has not seen her daughter since.

Susanne has intimated that her husband has something to do with her being targeted by the mental health services. Susanne said that her husband knew a lot of the local lawyers. **Susanne said that when she was first sectioned a Social Worker Miriam Savage said privately to Susanne "I really do not want to do this but your husband knows some very powerful people"** (or words to that effect). Susanne claims this social worker subsequently suffered a nervous breakdown and was off work for a long time.

Certainly St Bedes was a prestigious Catholic Grammar School for boys being the Catholic equivalent of Bradford Boys Grammar School which was originally a direct grant grammar school but chose to become independent when the direct grant scheme was abolished. The girls equivalent of St Bedes was St Josephs Catholic College which I

attended. The husband being a teacher at St Bedes would have access to the old boy network and alumni in positions of influence.

Susanne refers to her Mental Health Tribunal Appeal being infiltrated by a **Theresa O’Keefe** – Mental Health Act Administrator of the Bradford District Care NHS Foundation Trust and also a **Polly English** to ensure Susanne lost the appeal.

**Polly English** died in April 2014. She was a Lib Dem Councillor for Sutton-in-Craven District Council and Skipton Town Council and a Non-Executive Director of Bradford District Care NHS Foundation Trust where she was also an Assistant Hospital Manager – prior to that she was chair of the North Yorkshire Police Commission. It sounds like there was subterfuge at a very high level and the normal protocols of the police and mental health services were bypassed.

I spoke to Susanne again on 1 November and got more details. Trying to get to speak to Susanne is difficult – I phoned the Heather Ward at 11:30 and was told to phone back at 3pm – I phoned at 15:05 and was told to phone back 1½ hours later – finally at about 16:30 I was allowed to speak to Susanne.

She told me her husband was brought up in Ulverston, Cumbria, his father was an antiques dealer and mother a housewife – he has 1 brother and 2 sisters. They are not a close knit family as the father does not like to socialise with the family – the Susanne’s ex-husband has very little contact with the family.

Susanne’s ex-husband is a member of the private flying club at Rufforth Airfield near York where he has a lot of solicitor contacts.

Susanne got her Decree Nisi 16/01/98 and the Decree Absolute followed about 3 or 4 weeks later.

Susanne claims that he wanted her and their child out of the house and Susanne refused to leave and so in 1997 her husband went to the GP Dr Bahra at Crosshills, Keighley and told lies which resulted in Susanne being sectioned and apparently this is a common ploy.

Susanne claims he husband wanted the former matrimonial home which was a bungalow in a secluded rural setting and sought custody of the child for the sole purpose of obtaining the matrimonial home.

Susanne is only allowed to talk on the phone for maximum 15 minutes at a time therefore I have to get the details a bit at a time and piece together the case. Susanne says that the staff often disconnect the call mid –sentence without warning.

2 November – I phoned the Heather Ward at 09:45 and was told to call back after 2pm as Susanne had already used her allowance of telephone for that shift. I telephoned about 14:15 and was told Susanne “is in group” and try again in about an hour – I telephoned again at about 15:15 and was told to try a little later as she was in baking – I telephoned again at 15:40 and was able to speak to Susanne.

I asked Susanne about her own family and her life before she came to the UK. She is from Tribuswinkel a small town near Baden and about 40 miles south-east of Vienna. Her Mother worked at the Co-op and became a manager there. Her father was a HGV lorry driver but was from a farming family – he had fought in the war and missed out on education. Susanne has 1 sister who is 1 year younger and is a nurse.

Susanne told me she has worked as a receptionist in a posh hotel, worked in a refugee camp in Austria, has lived in Tripoli in Libya for a year as a live-in house help for an Austrian diplomat. When Susanne returned to Austria she wanted to improve her English and worked as an au pair in the UK for 2 years. Then she worked for a British company in Austria and did translation work. She found an English pen-friend through pen pal magazine, who became her husband.

English is not Susanne’s native language but her command of English is exceptional and better than that of many native English speakers.

The information she sent me is very lucid, logical, organised – she is clearly highly intelligent, with a clear mind, focussed and eminently capable. She demonstrates this in her written English, her navigation of the legal system and her verbal fluency in a second language.

Susanne has filed claims against Tony Blair and her GP Dr G Cunliffe which were struck out by the local courts and she has made applications to the European Court of Human Rights which have failed because of the mental health status applied to her.

Susanne has embarked on a very logical and systematic path of seeking redress through the court system going as far as the European Court of Human Rights. The European Court of Human Rights will not accept her application

until she has exhausted all domestic remedies but the UK courts will not issue proceedings and the clause 5 (1) (e) precludes persons under section MHA as being of “unsound mind”. Thus the purpose of the mental health fraud being to prevent her obtaining any redress.

Susanne believes she has been subjected to this ongoing campaign of harassment because of her profession of holistic therapist but I think this is a red herring - after examining the documentation she has sent me **I would say this could be an open & shut child theft case using a mental health fraud triggered by the marriage breakup** and possibly engineered by the husband – a good quality child from a highly intelligent and competent mother and using Susanne’s profession for the basis of the mental health fraud.

They know Susanne is highly intelligent and that she would work out the steps she has to take to obtain redress. The UK courts have refused to issue proceedings against defendants and have issued strike out orders in response to claims she has filed in the UK courts. They have exploited her vulnerability as a Foreign National in that her biological family are in Austria and she has no family in the UK.

Consultant Psychiatrist Natalie Johnson, Community Psychiatric Nurse Jean Hunter and Care Co-ordinator David Inskip have come to Susanne’s home without and appointment of prior warning.

Susanne also refers to Dr Andrew Aspin, Consultant Psychiatrist as being involved in the incident where she was dragged out of the bath.

Dr G Cunliffe, her GP, has colluded and Susanne filed a claim against him but Keighley County Court refused to issue proceedings against him.

Susanne told me over the phone that on 9 April it wasn't the police who broke down her door and forcibly removed her from her house and took her to the hospital this time - it was a private security firm instructed by Social Services. Upon arrival Susanne was taken to the 136 Suite which is like police custody within the psychiatric hospital - she was kept there for 2 days with no police officers on duty - she was then escorted to Clover Ward without any clinical assessment ever having been carried out. **Update on Susanne Kellner-Johnson incarcerated in PICU Clover Ward, Lynfield Mount Hospital, Bradford, West Yorkshire**

There has been a significant development in Susanne's case.

I managed to speak to Susanne on the phone yesterday morning about 10am - it was quite a long conversation we had - and informed her that the previous day I had discussed her case with Edward as I had either copied or blind copied Edward in my emails to Susanne.

Susanne has always shied away from offering her case for the Royal Commission because she was blackmailed with deportation (being an Austrian national) and having her house confiscated if she continued to seek redress for the psychiatric abuse she has been subjected to since 1998 but she has given me enormous support in the

background that has enabled me to keep helping Edward - without Susanne's unwavering support I would not have survived this long.

If you don't know what Edward is doing go to [www.equitygovernance.uk](http://www.equitygovernance.uk). This is a process that was started by the late Queen Elizabeth II for remedying endemic corruption in Government and the Judiciary. Edward knew about the corruption control mechanism written into the Constitution that had fallen into disuse and sent evidence to Queen Elizabeth. He has been servicing the process ever since. I myself independently gathered evidence of pharmaceutical corruption and Edward found me and I have been co-managing the process with Edward ever since. I focus on gathering evidence of pharmaceutical corruption and Edward does everything else. The process uses live corruption cases to perform integrity tests to obtain corruption proof sets that are Guilt Proof and Unfitness Proof against Judges and Law courts and Parliamentarians. The process requires the Citizen to investigate corruption and give a Confidentiality Waiver and Privilege Waiver and Priority Waiver and they normally have to identify themselves.

I have attached one of the latest Royal Commission documents that details the current state of play and another one from July 2024 that furnishes more background.

**I explained to Susanne that Edward has said that we can use her case for the Royal Commission without identifying her and use her case to get Priority Remedy Delivery for her and similar victims. Susanne's reply to me over the phone was that she wants to be identified and wants to offer use of her case for the Royal Commission and we were trying to find a way for Susanne to give written Consent given that the Clover Ward are blocking all communication to and from Susanne. Edward drafted a short paragraph and emailed it to Susanne and myself. I telephoned Clover Ward at lunchtime and got to speak to Susanne when she happened to have a laptop in front of her and she received the email while I was on the phone with her and she replied giving consent. So we can now run with her case. I also forwarded to her the recent emails so she is up to date with what I have been doing to try to help her.**

So yesterday I got busy sending Edward the details of Susanne's case that I drafted in 2016.

Susanne was briefly given access to her phone yesterday and she sent me some texts.

**Susanne said she wants Andy Peacher and Brian Daniels at Citizen's Commission on Human Rights (CCHR) kept in the loop so I will forward to you the emails I have sent to Edward over the weekend. I replied and asked her if she also wants John Timbrell kept in the loop as well but I have not had a reply yet.**

She said that "they" are already trying to get Legal Incapacity status for her so they can seize control of her house etc - this is particularly worrying.

Given that Susanne tells me that the staff on Clover Ward are withholding all letters, parcels, emails, phone calls etc to Susanne from her friends and they will not post any letters from Susanne, the fact that I got to speak to Susanne on the phone twice yesterday for a substantial duration of time was a monumental achievement and I see it as an indication that I have gained the trust of the nursing staff and I wish to keep it that way. I do not want to be seen to be trying to take advantage of this trust, for Susanne's benefit. Therefore I will limit my phone calls to Susanne to deal with her Royal Commission case.

Dear Julia, Thank you so much for sending me the updates after this email.

I doubt if I could help Susanne on this occasion as I did previously because the judges are even more corrupt than they were then.

I have a thought that may be of assistance to you or anyone else helping Susanne. I have at least three times noticed that when Susanne becomes disturbed she cannot accept that she needs help. Each time she ended up in hospital. I know that

if I and others try to suggest to her that she needs help she gets very angry and abusive. On this last occasion when she sent off a large number of abusive emails I had a long talk with her. I discussed poisons medication which can be beneficial if given in low doses such as digitalis or atropa bella-donna. I discussed with her what we both knew that the haloperidol which was used to destroy the minds of Soviet dissidents might have a beneficial effect on her if given in small doses. I did not get an angry response because I was very gentle but I could not find a way to get her to accept that she needed help. I really do not have the answer but perhaps you might be more successful in getting her to recognise when she does need help. Thank you again for contacting me. Regards john.

Dear John,

Thankyou for your email. You are welcome.

I hope you don't mind I have taken the liberty of copying Andy Peacher, Brian Daniels at CCHR and Edward at Susanne's behest as she wants these individuals kept in the loop.

I hear what you say about Susanne's acute psychotic episodes which occur when the dose of haloperidol is reduced too much too quickly - the upregulation of dopamine receptors causes a rebound psychosis. The only way to avoid this is to wean her off in very small increments and very slowly to allow the receptors in the brain to adjust.

I wouldn't even try to reason with Susanne when she is in an acute florid psychotic episode - she is unreachable when she is in that state - she doesn't have any idea she is completely off her head. Its not her fault - any of us would be the same if we were on this drug and tried to come off it.

I am a homeopath and years ago I tried giving her Haloperidol in a 30C potency to try to clear the energetic signature of the drug. Belladonna is a good suggestion but the situation is too gross to deal with in this way.

I have suggested co-administration of Ayurvedic herbs that have a dampening effect on the brain while she weans off the haloperidol.

In my opinion what Susanne needs is to be able to go to a private rehab facility where she can just be allowed to get this drug out of her system in a safe environment. Every time she is hospitalised by Bradford District Care Trust she is injected with maximum dose of haloperidol and is then back at square one. She was almost completely off the haloperidol and I knew this could happen and in March before she started sending out the crazy emails and I really impressed upon her that the lowest dose of depot needs to be a maximum of 5mg and she needs to taper that off really gradually over the course of about 3 months. I did explain all this and set out a schedule in an email that she could show to the mental health team and several times I offered to write to the psychiatrists etc on Susanne's behalf.

They perpetrate these mental health frauds against people for the following reasons:

1. They want to completely destroy the victim's life and if they commit suicide they want the reason for suicide officially recorded as an inherent mental illness not because they were subjected to character assassination, dispossessed and disenfranchised and left unable to function in society.
2. They want to prevent the victim seeking redress in the Law Courts. There is Clause 5 in the European Court of Human Rights Application Form which states that people with a mental illness diagnosis are barred from filing a Claim.
3. They want to destroy the reputation and credibility of the victim so they will be ostracised professionally and socially - especially if they are whistleblowing about corruption.
4. They want to be able to gaslight the victim - particularly if they are whistleblowing against corruption so they can say that the victim is delusional.

Susanne told me she has instructed you to act for her re suing Bradford District Care Trust/NHS but she is currently incarcerated in the Psychiatric Intensive Care Unit (PICU), Clover Ward in Lynfield mount Hospital and the nursing staff will not allow her to contact you.

I am a friend of Susanne - I have known her for about 10 years now. I help her as far as I am able with her troubles with the mental health authorities.

On Monday 4 May I telephoned the Clover Ward at Lynfield Mount Hospital and managed to speak to Susanne.

**Susanne told me that she wants to sue Bradford District Care Trust for psychiatric abuse and the resulting sequelae that have ruined her life and that she had instructed you to act for her.**

Susanne told me the staff on Clover Ward are preventing her from communicating with the outside world including any legal representatives she has and therefore **Susanne asked me to contact you and "work with you" on her behalf and I said they will not communicate with me unless you give them Consent and Confidentiality Waiver. Yesterday I received a bundle in the post from Susanne and included was handwritten signed Consent which I have attached to this email. She also wants me to contact a barrister Stephen Simblet KC, Garden Court Chambers, 9 Carmelite Street, LONDON, EC4Y 0DR**

I have also attached a **To Whom It May Concern** letter I drafted for Susanne in October 2024 for her to show to the mental health team after the psychiatrists informed Susanne of their decision to wean her off her depot haloperidol injections as I have a background in psychopharmacology although I retrained in natural medicine.

I stated my opinion that to wean Susanne off the depot haloperidol too rapidly would likely precipitate an overwhelming psychotic episode and it would seem that indeed the dose of haloperidol has not been reduced as gradually and slowly as it should have been and Susanne was taken into Lynfield Mount Hospital (Clover Ward PICU) on 9 April on a CTO3 recall and remains there still.

Although I am Bradford born and bred I have lived in the South East since 1984. I almost never go to Bradford so I am not local to Susanne and I do what I can to help her from where I live in Bedfordshire. I have never actually met Susanne in person.

I first became aware of Susanne's case in 2016 and although initially I was reluctant to get involved I am now glad that I did. In 2016 Susanne sent me her bundle of papers showing how this saga began and her strenuous efforts to take her case up through the Courts. I collated and organised this information and drafted a **Case Chronology (timeline)** and **Case Analysis** and an **inventory of culpable parties** therefore I have a good understanding of the case.

Susanne and I have kept in touch closely ever since - Susanne emails me several times a week and sometimes more than once a day and she shares with me details of her daily life.

Yesterday I received in the post a bundle of 30 sheets, some of it double sided - I collated and organised the material and scanned it all into my PC last night. **Susanne has asked me to send this to you.** I thought it best I introduce myself first before landing several megabytes into your inbox.

Susanne has offered use of her case as a Test Case for the Coronation Oath Enforcement Authority which oversees a Corruption Remedy Process which is managed by Equity Lawyer Mr Edward Ellis who is copied in this email. Mr Ellis used to practice as a Solicitor specialising in criminal law but is no longer registered with the SRA. He does not use the professional title Solicitor but describes himself as an Equity Lawyer.

There is a lot of psychiatric abuse perpetrated against completely sane decent people - especially it is used routinely as a weapon against whistleblowers on corruption and those who stand up to corrupt practices and bullying by statutory authorities e.g Dr Rita Pal vs GMC - including myself - I have been on the receiving end of bullying and psychiatric abuse because I spoke out against corruption but nowhere near to the extent that Susanne has.

I have just spoken to Susanne on the phone - I phoned the Clover Ward on 01274 363 195 and the staff allowed me to speak to Susanne.

I told Susanne about our conversation yesterday about using her case for the Royal Commission without identifying her. **Susanne has told me that she now wishes to be identified and to offer use of her case for the Royal Commission. She said she is going to try to borrow someone's laptop today and send an email with a makeshift consent form.**

Susanne told me that the hospital staff are preventing her having contact with the outside world - they will not post her letters, they withhold from Susanne letters, parcels, emails and phone calls to her from her friends. I was lucky to get tom speak to her.

**Susanne told me she wants to sue Bradford District Care Trust / NHS and North Yorkshire Police.** She told me that she was busy getting on with her day at home when they (presumably the police) came without presenting any arrest warrant or hospital recall documentation and broke her door down and dragged her through broken glass.

Susanne had instructed a local Solicitor Alastair Bateman but the hospital staff will not allow Susanne to have contact with him. Susanne has asked me to work with this Solicitor to help her but I said that they won't allow that unless they have consent and confidentiality waiver from you.

Susanne said that the hospital have increased the dose of haloperidol from 15 mg per month to 400 mg per month - she is being forced to take oral doses every day otherwise they will inject her.

Please find attached all the Court documents there are in the Bundle of a total of 44 pages that Susanne sent me in 2016. Other documents are letters to/from MPs and Prime Ministers, Bradford District Care Trust/NHS and so on and photographic evidence of abuse against Susanne.

On 29/01/2007 Keighley County Court issued **Strikeout Order**

On 27/04/2009 Keighly County Court **refused to issue proceedings**

On 14/10/2009 Skipton Magistrates ordered that Susanne was unable to take care of herself in her home despite photographic evidence of a very clean, tidy and orderly home.

Susanne tried to file a case with the European Court of Human Rights **Application no. 60383/15**. But there is a clause on the application form Clause 5(1)(e) that precludes persons with a mental health diagnosis from making a Claim. I know this to be true because I started an application to ECHR for my own case and came up against Clause 5(1)(e).

Also before a citizen of an EU member state can file a claim with the ECHR they must be able to demonstrate that they have exhausted all domestic remedies. Susanne wrote to Prime Ministers who referred her letter to the Home Office who referred her to the Independent Police Complaints Commission who we all know are not going to take action against themselves. Susanne has also written to MPs and filed complaints to Complaints Manager at Bradford District Care Trust/NHS via an Independent Complaints Advocacy Team. Susanne has exhausted all the avenues in the UK as I did with my own case. Susanne has also tried to draw public attention to her plight.

The reason why they use these mental health frauds is to prevent the victim obtaining redress through the ECHR. The victim is then left going through an endless circle of trying to seek redress in the UK when all complaints to MPs and central government ultimately get referred back to the organisations that caused the abuse.

I see parallels with my own case and it is driven by misogyny. In Susanne's case her husband wanted rid of her and used his social contacts with people of influence to perpetrate a mental health fraud. In my case it was the GP John Lockley who didn't like me because I am a teacher of Transcendental Meditation and after my husband left me there was no obstacle. Also probably the fact that I was patently doing a far better job for my patients than the GPs probably ruffled a few feathers in the local medical community.

Dear Julia,

I am reading through the recent emails and considering the options. Since Susanne's mother has dementia, I don't perceive the hospital will entertain any communication from her. That's a tricky situation.

Is Susanne detained under s.2 or s.3 at present? Does she have any prediction of when she might be discharged?

Regarding the damage at her home; it might be worth contacting the CQC which administers the MHA and see what advice can be obtained from there. The liability for repairs should lie with the perpetrator of the criminal damage. I suspect it will be considered collateral damage but unless challenged, nothing will change and Susanne will be left with the liability.

I will make some enquiries.

Thanks for sharing the documents Julia. It looks like a CTO recall. I don't see mention of s.3 or s.4 but it may have developed into a s.3 detention.

As you know, the recall is usually due to noncompliance with the CTO requirements, turning up at the psychiatric unit for "treatment."

In other instances reported to me, patients are detained until they are "drug-compliant" (I hate that term) and are then released. I suppose the question in present time is as follows: is Susanne drug-compliant right now?

Thank you for the letter to Susanne's mother. I don't know very much about the CCHR Austria team. Did you hear back from them?

By the way, I had a conversation with the CQC. The person I spoke to thought the liability concerning damage to Susanne's door fell to the police since it would have been a forced entry by the police.

Hello Brian,

Yes it was a CTO recall. **But** they were in the process of weaning her off the drug completely - she was down to 15mg haloperidol depot injection a month from having been on about 40mg per month. I know how important it is to reduce the dose of these types of drugs very gradually otherwise too rapid withdrawal can precipitate a rebound psychosis which is exactly what Susanne was experiencing and it is **THEIR FAULT** for reducing the dose too quickly - their ineptitude. They are complete morons. Especially as I had written a letter for Susanne to give to the mental health "professionals". Now Susanne is back where she started and will have to wean off all over again and they will let it happen again because they are unbelievably stupid. Susanne is trapped in this eternal cycle unless we can get her a payout to pay for residential rehab.

Truth be told the "doctors" are pretty clueless about the drugs they prescribe and even the disease processes they purport to treat and not just in psychiatry its right across the board. In my time as a practising osteopath I rescued many people from certain death from the incompetence of medics. One GP told me quite matter of factly "we only know about 5% about how the body works". They have managed to thrive because they offer the lure of the quick fix but this is only masking the symptoms. They learn by copying other people and if they don't toe the line they don't get promoted - there is a lot of pressure on them to prescribe drugs - the NHS is heavily subsidised by Big Pharma.

**I feel very strongly that we should file a formal complaint against the BDCT/NHS and make a complaint to the General Medical Council against the medical staff - the psychiatrists etc who oversee Susanne's drugs.**

No way should Susanne have to pay £250 to have her door repaired/replaced. No it wasn't the police who broke down the door this time, Susanne says it was a private security firm instructed by Social Services.

No I haven't heard back from CCHR in Austria yet.

Hi Brian,

I just realised there may have been some misunderstanding re your statement yesterday: "In other instances reported to me, patients are detained until they are "drug-compliant" (I hate that term) and are then released. I suppose the question in present time is as follows: is Susanne drug-compliant right now?"

Susanne is always "drug-compliant" because she is forced to because she has depot injections of haloperidol - she is not taking the drug orally. Once a month the community nurse comes to Susanne's home and injects her. Susanne always cooperates because she knows full well if she didn't cooperate she would be held down by a team of people and jabbed. **Therefore it is not possible for Susanne to be drug non-compliant** When Susanne is at home I am in regular contact with her by email on a more or less daily basis so I know the ins and outs of her daily life.

Susanne was not recalled on 7 April because she was not drug-compliant it was because she was in an acute psychosis because the morons in charge of her drug administration were not reducing the dose gradually enough. I drafted a schedule of how to reduce the dose - by what increments and over what timescale. It is important to understand this. Susanne was never mentally ill in the first place - her ex-husband suffered a head injury in a gliding accident which changed his personality - he changed from being a loving husband to being a cruel tyrant - this is quite common in a frontal lobe damage. The husband took a mistress and ended the marriage to Susanne and wanted to dispossess Susanne of her share of the marital assets and custody of their daughter - he used his social and professional contacts to run a mental health framing fraud against her. He got the GP to agree she is mentally ill and got people high up in social services and NHS to do his bidding - reading between the lines I suspect he had information he could use to blackmail them - this is only speculation on my part I have no proof. I have all Susanne's documentation she gave me in 2016.

**Brian - Susanne is convinced that CCHR in Austria are the only people who can help her - personally I don't know because I don't know the CCHR that well - I don't know what powers they have if any. Do you think you could give CCHR in Austria a nudge re my email I sent them yesterday ?**
