

1. Endemic Corruption relies on Evidence Frauds. Fraud Proof of anything gets a Proof Burden Reversal for the Fraud Victim against the Fraud Manager and the Fraud Beneficiary. It is managed by use of Fraud Proof of anything to get a Fraud Presumption of everything else for the Fraud Victim against the Fraud Manager and Fraud Beneficiary.
2. In 2004, Top Level Corruption Proof got by Equity Lawyer Mr Ellis enabled Queen Elizabeth to revive active service of the Coronation Oath Enforcement Authority and start a Corruption Remedy Process. The Equity Lawyer has provided Support Services ever since. He made Policy Decisions.
 - 1.1. One replaced Credibility Irrelevance Proof with Credibility Proof for the Victim for Remedy Precedents.
 - 1.2. Another reduced reliance on Election Communications Sabotage Fraud Presumptions.
 - 1.3. Another reduced reliance on Sex Crimes until the Remedy Process was well advanced. It was a Risk Control against Conflict Recusals from Jury Office by Lord Bishops. It explains why the Equity Lawyer gave so much attention to the Family Sabotage Frauds + Child Thefts against Citizen Mrs Theodorou and her 6 Children and not the Child Prostitution Cases.
 - 1.4. There were more.
3. In 2023, Endemic Corruption Proof against the UK Judiciary enabled King Charles to negotiate the World War III Peace Agreement for Democratic States. It got International Support for Remedy Management. Remedy Enforcement against Fraud Profiteers financed the Remedy Budgets needed for the Post Office Scandal and Contaminated Blood Scandal.
4. Corruption Exposure got an increase in the MP Retirement Rate, an Incredible Choice for the 2024 General Election and Split Conservative Values Majority Vote that enabled a Minority Vote to get a Landslide Governing Majority, Cabinet Control for the Protection Fraud Network that manage Endemic Corruption Manager, Cabinet Office for Network Agents and Premier Office for Network Agent Sir Keir Starmer.
5. The 2024 Parliament Session serviced a Dismissal Process against the Network Agents. The Corruption Remedy Conditions required Remedy Delivery of 20,000 Political Prisoner Releases, Dismissal Executions against the Judiciary by Parliament, Victim Identification and Case Remedies. Grant Condition Breaches got Remedy Denial Fraud Findings against the Cabinet and the Default Dismissal Penalty against Prime Minister Sir Keir Starmer.
6. The Dismissal Process needed International Support. One preparation was the Church of England Scandal that Sex Crime Complaints by Victims and Bishops got Investigation Denial Fraud Proof against the State. Another preparation was the Blackmail Statement dated 14th October 2024 of Citizen Mr Nkrumah It was Additional Defence Evidence for Citizen Mr Katsiaounis in the 01YE1544123 Criminal Investigation of Rape Allegation Frauds. It got Child Prostitution Protection Fraud Proof against All Relevant Authorities including the Cabinet.
7. In January 2025, International Support helped the UK Opposition Leaders use the Child Prostitution Scandal to extort Remedy Delivery Commitments from the UK Cabinet. They were Commitment Frauds. The Remedy Delivery Failures in July 2025 got Fraud Findings against the Cabinet and Corruption Publicity in September 2025. The Epstein Scandal got the Mandelson Scandal and Corruption Dismissal Scandal. It was everything used to get Dismissal Delays. One required Proposer + Seconder Support from 20% of Governing Majority MPs. Another was a Parliamentary By Election Candidacy Refusal by the Governing Majority Party against Manchester Mayor Mr Burnam. The 2026 Council Election Defeats got a Confidence Collapse in Leadership Challenge Sabotage Frauds. The Proof Positive is the Makerfield By Election Candidacy from the Governing Majority Party for Mr Burnam.
8. Change Management needs Remedy Delivery. It is Dismissal Executions against the Judiciary by Parliament, Victim Identification and Case Remedies.
9. The By Election Campaign will get Forced Decisions by All Candidates for or against Remedy Delivery and Forced Decisions by Media Managers for or against Remedy Delivery Publicity. The By Election Result will get Forced Decisions by Labour MPs for or against Remedy Delivery.
10. Meanwhile, the Remedy Process needs more preparations for Remedy Delivery. It is time to draw attention to Electronic Communication Frauds. The most recent are:
 - 10.1. The Equity Lawyer relies on the City Library for Email Attachment. On 18th May 2026 he arrived late. He launched 2 Draft Emails, one for the Public Domain Address Lists and the other for the MP Address List entered the Address Lists + Subject + 2 Attachments in case he was Timed Out and could use the mobile to enter content and send. He sent both at 17.12 on Monday 18th May 2026. There were 2 Attachment Removals from the Public Domain Address List. There was No Attachment Removal from the MP Address List.
 - 10.2. The Encrypted Protected Email at 11.39 from the Harassment CM25F90597 Claimant Lawyers. It validates the Unencrypted Communications Demand by Equity Lawyer Mr Ellis and Citizen Mr Nkrumah
