Harassment CM25F90597 Unencrypted Communications Demand for the Citizen Defendant against the Claim Lawyers

REASONS:

1. In 2023, Citizen Mr Nkrumah and Equity Lawyer Mr Ellis got completion of an Endemic Corruption Proof Set against the UK Judiciary. King Charles used it to negotiate the World War III Peace Plan for Democratic States. It got International Support for Corruption Remedies. Remedy Enforcement against Fraud Profiteers financed Remedy Budgets for the Post Office Scandal and Contaminated Blood Scandal. Corruption Exposure enabled the 2024 General Election to get a Power Transfer to a Landslide Governing Majority, the Premier Office for Top Network Agent Sir Keir Starmer and Cabinet Office for other Network Agents. Parliament Session Grant Breaches got Remedy Denial fraud Findings against the Cabinet and Default Dismissal Penalty against the Prime Minister. Dismissal Execution needed International Support. The Church of England Scandal was that Sex Crime Complaints by Victims and Bishops got Investigation Denial Fraud Proof against the State. The Blackmail Complaint Statement dated 14th October 2024 of Citizen Mr Nkrumah got Child Prostitution Protection Fraud Proof against All Relevant Authorities including the Cabinet.
2. In January 2025, USA President Elect Mr Trump acted as World War III Peace Plan Representative when he helped UK Opposition Leaders use the Child Prostitution Scandal to extort Remedy Delivery Commitments from The UK Cabinet. They were Dismissal Executions against the Judiciary on Monday 14th July 2025 by Parliament and then use of a Trial Listing on Thursday 17th July 2025 of Framing Fraud 2023 0058 against Citizen Mr Nkrumah to start Victim Identification and Case Remedies with Mass Publicity. They were Commitment Frauds. Their Absolute Priority was Remedy Sabotage. It needed UK Protection Frauds and USA Protection Frauds.
3. The UK Protection Frauds were the Harassment Framing Fraud Claim CM25F90597 + Without Hearing Interim Family Contact Restraint Frauds + Final Hearing Denial Frauds by Claimant Ms Mukasa, Claimant Lawyers Morgan Wiseman and the Family Court. They were Set Up Conditions for the Restraint Breach Framing Frauds 01KW1226225 + 01KW1237025 by Ms Mukasa, State School Officers, Metropolitan Police, Essex Police, Crown Prosecutors, the Magistrates Court and Crown Court. All of it was a Risk Control against a 2023 0058 Trial Collapse for the Citizen against the State causing a Total Collapse of the Protection Fraud Network. It needed an Arrest Fraud that stopped Citizen Mr Nkrumah leaving the court a free man, and then Investigation Custody Frauds + Charge Frauds + Remand Imprisonment Frauds.
4. The USA Protection Frauds were Sex Crime Blackmail Business Concealment Frauds + Defence Sabotage Fraud Concealment for the UK Protection Fraud Network. It needed Epstein File Concealment Frauds by the USA President Mr Trump. His Election Campaign Commitments included Epstein File Exposure. The Concealment Frauds needed a Policy Reversal. They needed Personal Access for a Fully Informed Individual and USA President Mr Trump for Trade Negotiations to get a Treason Deal. It needed to get Big Bribes for USA President Mr Trump, Epstein File Concealment Frauds for the UK Protection Fraud Network, Defence Sabotage Frauds for Russia against Ukraine, Western Europe and NATO and Money Laundering by Trump Family Members because reliance on anyone else was an Exposure Risk. The UK Cabinet made Lord Peter Mandelson the Concealment Manager and gave him the office of UK Ambassador to the USA. It got the Personal Access and the Treason Deal.
5. Everything that could go wrong for the Treason Deal Partners did go wrong. The Defence Sabotage Frauds against Ukraine and Western Europe and Sovereignty Demands for Canada and Greenland were intended to get a NATO Collapse. They failed. They united Ukraine, Western Europe and NATO. They isolated USA President Mr Trump.
6. In July 2025, the Remedy Delivery Failures by the UK Cabinet and the Epstein Scandal got Remedy Denial Fraud Findings by the Parliament Session Court against the UK Cabinet, the Default Dismissal Penalty against Prime Minister Sir Keir Starmer, the September 2025 Corruption Publicity, the Forced Resignation of the Deputy Prime Minister, the Remedy Commitment Delivery by the France of Prison Cell Enforcement against Corrupt Former Prime Minister Mr Sarkozy, the Forced Ambassador Office Dismissal against Lord Mandelson, a Remand Imprisonment Release for Citizen Mr Nkrumah, 01KW1226225 + 01KW1237025 Unused Material Notices for All Evidence, Family Contact Restraint Breaches by CM25F90597 Claimant Mr Mukasa, Epstein File Disclosures, Mandelson Scandal, Public Office Misuse Investigation Arrest and Peerage Forfeit against Mr Mandelson and Leadership Contest Sabotage Frauds by the Network until Election Defeats made Dismissal Execution inevitable.
7. Confidence Collapses got Innocence Pretence Frauds + Family Arrangement Proposals by Ms Mukasa and Encrypted Communications from the Claim Lawyers that the Remedy Managers cannot trust.
