 The Treason Crimes
  1. Treason Conspiracy by the Cabinet of Prime Minister Mr Boris Johnson was to commit Breach Frauds of Parliament Session Grant Conditions. They required Remedy Delivery. It was Dismissal Executions against the Judiciary by a United Parliament, Victim Identification, Case Remedies and an International Agreement for a World War III Peace Plan for Democratic States. There were many Remedy Delivery Denial Frauds. One was Release Denial Frauds against 20,000 Political Prisoners. The reason given was Release Cost exceeded Imprisonment Fraud Costs. It got Fraud Benefits for Corrupt Individuals. It denied State Budget Savings and Honest Rewards for Honest Individuals. The Breach Frauds got Remedy Denial Fraud Findings by the Crown and Parliament Sessions Court against the Cabinet and Default Dismissal Penalty against Prime Minister Mr Johnson
  2. The 2021 Treason Conspiracy by the Opposition Minority, Led by Sir Keir Starmer, denied the Dismissal Support that Governing Majority MPs needed. They used the Covid Regulation Breach Party Scandal for Dismissal Effort Pretences. They kept Prime Minister Mr Johnson in power from September 2021 until the 2 Parliamentary By-Election Defeats in June 2022 got Mass Resignations from Ministerial Office. The Dismissal Delay got Fraud Benefits for Corrupt Individuals and denied State Budget Savings and Honest Rewards for Honest Individuals.
  3. The Treason Conspiracy created the need for the Crown to get International Support for the Dismissal Execution against Corrupt Cabinet Officers. It needed New Endemic Corruption Proof against the Judiciary and use of by the Crown to negotiate the World War III Peace Plan for Democratic States. The Peace Agreement required Sovereign States to destroy the Protection Fraud Networks that manage Endemic Corruption, recover control of State Budgets, resource World War III Defences and resource a Just World Order. The Management Agreement got Test Case Status for the UK and Test Manager Status for the Coronation Oath Enforcement Authority. The Remedy Agreement got Remedy Enforcement against Fraud Profiteers and Penal Enforcement against Corrupt Leaders. The Delivery Agreement got Delivery Commitments some of which were conditional on Plan Stage Successes. The Publicity Agreement required Whole Plan Secrecy until there were enough Plan Successes to validate Whole Plan Publicity. In 2023, Citizens got the Endemic Corruption Proof. King Charles got the Peace Plan Agreements. The December G7 Summit got Agreement Signatures. Delivery Commitment Deliveries by Japan and the USA got Remedy Enforcement against Fraud Profiteers. It financed Remedy Budgets for the Post Office Scandal and Contaminated Blood Scandal. Corruption Exposure got an increase in the MP Retirement Rate, an Incredible Choice, and a Split Conservative Values Majority Vote enabled a Minority Vote to get a Landslide Majority led by Sir Keir Starmer and controlled by the Protection Fraud Network that managed Endemic Corruption.
  3. The 2024 Treason Conspiracy by the Cabinet of Prime Minister Sir Keir Starmer was to commit Breach Frauds of Parliament Session Grant Conditions. They were Repeat Delivery Denial Frauds to those committed by the Cabinet of Prime Minister Mr Johnson. It got Remedy Denial Fraud Findings against the Cabinet and the Default Dismissal Penalty against Prime Minister Sir Keir Starmer. Dismissal Execution needed International Support.
  4. The 2025 Treason Conspiracy by the Cabinet of Prime Minister Sir Keir Starmer was to commit Breach Frauds of the Remedy Delivery Commitments that the UK Opposition Leader and USA President Elect Mr Trump got in January 2025 by use of Child Prostitution Scandal. They were Commitment Frauds. Their Absolute Priority was Remedy Sabotage Frauds in the UK and USA. The Delivery Commitments required a Trial Listing of Framing Fraud 2023 0058 of Citizen Mr Nkrumah to start Victim Identification and Case Remedies. The UK Remedy Sabotage Frauds were New Framing Frauds against him the Case Collapse of the State getting a Total Collapse of the Network. The USA Remedy Sabotage Frauds needed Elstein File Concealment. Lord Mandelson was the Concealment Manager. He was given the office of UK Ambassador to the USA. It got Personal Access for him to USA President Mr Trump and Trade Negotiations that got a Treason Deal. It got Big Bribes for USA President Mr Trump, Epstein File Concealment Frauds for the UK Protection Fraud Network, Defence Sabotage Frauds for Russia against Ukraine, Western Europe and NATO. UK Remedy Delivery Denial Frauds got the Epstein Scandal + Mandelson Scandal + Treason Exposure Risk. The USA President made a Self Defence Plan. It needed War Frauds + Blitzkrieg Damage + Total Victory + Dictated Peace Terms + War Hero Treason Immunity. It failed. Leadership Contest Frauds got Dismissal Execution Delays. Corruption Remedies need the Election Neutral Issue Agreement.
