Best Advice is that Investigators, Prosecutors, Defenders, Judges and Endemic Corruption Remedy Managers:

1. Ask the UK Law Society:

- 1.1. Does the Legal Service Act 2007 create Prosecution Powers for Unqualified Legal Service Crimes?
- 1.2. How many times have Citizen Case Papers supported Unqualified Legal Service Crime Complaints against Equity Lawyer Mr Ellis?
- 1.3. Did Crime Complaints get Criminal Prosecutions against Equity Lawyer Mr Ellis, and if not why not?

*[Law Society Officers might not know, or might not dare say, Parliament Sessions Grants included Prosecution Prohibitions that forced Prosecution Restraint Orders from the Cabinet against the Law Society]*

2. Ask anyone:

- 2.1. Does Science Teacher Mr Benjamin Koonson provide Management Services for Wholesale Distribution of Illicit Drugs in Dagenham for Northeast London and Essex, and Bribe Money Laundering for Local Police, Local Child Protection Officers, Local Mental Health Teams and Local Judges?
- 2.2. Did the Blackmail Fraud Complaint Statement dated 14<sup>th</sup> October 2024 of Citizen Mr Nkrumah make Child Prostitution Allegations against the Chronically Immature Mother and Drug Wholesaler Mr Koomson?
- 2.3. Did the Blackmail Statement get Child Prostitution Protection Fraud Proof against All Relevant Authorities?
- 2.4. Did Commissioner Rank Officers use it to get Child Prostitution Protection Fraud Proof against the Cabinet?
- 2.5. Did the World War III Peace Plan States and UK Opposition Leaders in January 2025 use the Child Prostitution Protection Fraud Scandal to extort Remedy Delivery Commitments from the UK Cabinet?
