Representations

The Case Papers do the work. The No Jurisdiction Plea + No Liability Plea mandate a Contempt Investigation for Citizen Mr Pead against the State. A Contempt Investigation Failure will be Corruption Proof against the Investigators, Prosecutors, Supervision Judges and Plea Judges.

It does not matter how much Mr Pead says, is not allowed to say, or forgets to say. He does not have to prove anything. Fraud Proof of anything gets a Proof Burden Reversal for the Fraud Victim against Fraud Managers and Fraud Beneficiaries that is subject to Rebuttal Proof Positive. Equity Lawyer Mr Ellis provided Support Services for the Corruption Remedy Process managed by the Coronation Oath Enforcement Authority. He recruited Citizens, provided Case Management Services and got Endemic Corruption Proof. It got a Proof Burden Reversal for All Citizens in All Cases. In 2023, the Crown used it to negotiate the World War III Peace Agreement for Democratic States.

Meanwhile, Citizen Mr Pead got Endemic Corruption Proof against the Authorities. He did not know it got a Proof Burden Reversal for him against the Authorities. He did not know how to use it for Remedy Management.

The Endemic Corruption Proof got by Mr Pead is a Comparator Proof Set to that got by the Corruption Remedy Process. The start coincided with the Corruption Dismissal Case against Prime Minister Mr Blair and lasted 20 years.

The Remedy Process Cases discovered that Protection Frauds continued if it had the support of one or more Top Officers. Relevant Cases got Case Priority. Old Cases have Relevant Status if they affected a Current Top Officer.

In 2013, Mr Pead took an interest in the Tony Martin Case. In 1998, a Murder Protection Fraud for Police Officers used the Murder Victim's Body for a Murder Framing Fraud against Mr Martin. It was a Notorious Case that got Public Support. The Protection Fraud Proof against the Judiciary is Appeal Decisions that are Self Evidence Fraud Proof. It used a Diminished Responsibility Trial Issue Waiver Fraud for an Appeal Manslaughter Finding Fraud + Early Release. The Ruin Fraud Conspiracy against Mr Pead has continued for 20 years and continue in 2026. Investigation is needed to discover whether it is the 1998 Murder Framing Fraud or the 2006 Sex Crime Protection Fraud, or both are Old Cases with Relevant Status that got Protection Frauds from Top Network Agents.

In 1997, the UK General Election got a Landslide Governing Majority, Premier Office for Mr Blair and Cabinet Office for Network Agent Mr Mandleson. He serviced the Business Expansion Plan for Performance Enhancing Drugs Supplies to Sport Professionals and Fitness Fanatics. A Corruption Dismissals in 1998 and 2001 did not stop him functioning as a Top Network Agent.

In 2004, the European Referenda Frauds exposed the Protection Fraud Network, got a Network Business Profit Share for Prime Minister Mr Blair and the Corruption Remedy Process for the People

In 2006, the Remedy Process got the Forced 10 Months Retirement Notice from Prime Minister and a Leadership Contest that discovered more than half the Governing Majority were Network Agents or Network Puppets. A Leadership Deal got Support Votes from Prime Minister Mr Blair and Cabinet Office for Network Agents, including Mr Mendelson. He used Cabinet Offices and Puppet Cabinet Officers to manage Business Expansion Plans: Land Frauds for Big Owners against Small Businesses + Sex Crime Blackmail Frauds used Minimum Sentence Protection Frauds from the USA for Mr Epstein, and Support Services from him that got Blackmail Profits for the UK Network + Family Sabotage Frauds and Child Thefts that got Big Budgets and Budget Fraud Profits and Expatriation Frauds that got Money Laundering Services from Sovereign States + Land Thefts for Network Agents against the State.

Peace Plan Leaders want Contempt Investigations to discover what influence the cases of Tony Martin and Brian Pead had on Network Agent Careers and Many Scandals. The 2026 Arrest Fraud against Mr Pead after Fraud Orders from the Prime Minister got Service Refusals by State Officers is evidence a Norfolk Officer is a Top Network Agent.
