

Trial Video Link OBJECTION Response of Citizen Mr Nkrumah

29th May 2026

1. The No Jurisdiction Plea + Criminal Conspiracy Counter Charge by the Citizen mandate a Contempt Investigation.
 - 1.1. The Allegations are that on 12th June 2021 a Motor Trial got Fraud Proof against the Judge. He used Public Gallery Clearance Fraud to remove an Independent Witness to the Remaining Trial Frauds.
 - 1.2. It needed a Public Gallery Criminal Trespass + Assault Framing Fraud by Essex Officers.
 - 1.3. Public Gallery Valid Entry by a State Officer needs either an Entry Invitation by the Public Gallery Clearance Order or Public Gallery Clearance Order. They did not have either.
 - 1.4. A Valid Trial needed Public Gallery Access for the Citizen
 - 1.5. A Public Gallery Clearance Power Title Conditions are:
 - 1.5.1. A Trial Disturbance by one or more Public Gallery Witnesses
 - 1.5.2. Disturbance Remedies that are proportionate in the circumstances of the case
 - 1.5.3. A Court Room Pronouncement of a Public Gallery Vacation Order against Responsible Individuals
 - 1.6. The Public Gallery Entry Title Conditions for the State are
 - 1.6.1. An Entry Invitation from a Public Gallery Occupant who has Citizen Status
 - 1.6.2. A Public Gallery Vacation Order
 - 1.7. The Execution Officers need to explain
 - 1.7.1. The Invitation Proof Deficit
 - 1.7.2. The Vacation Order Deficit
 - 1.7.3. Why the Entry Deficit + Order Deficit should not get a Fraud Conspiracy Finding + Criminal Contempt Liability Order against them and everyone else responsible for the Prosecution and Trial
 - 1.7.4. What they know about
 - 1.7.4.1. Crime Protection Frauds for them against Citizen Mr Nkrumah
 - 1.7.4.2. all Crime Framing Frauds against Citizen Mr Nkrumah that provided Protection Frauds for them
2. Corruption Exposure by Citizen Mr Nkrumah and the Ruin Fraud Conspiracy against him contributed to the Endemic Corruption Proof Set against the UK Judiciary. In 2023, King Charles used it to negotiate the World War III Peace Agreement for Democratic States. The Peace Agreement requires Sovereign States to destroy the Protection Fraud Networks that manage Endemic Corruption, recover control of State Budgets, resource World War III Defences and resource a Just World Order. The Management Agreement got Test Case Status for the UK, Test Manager Status for the Coronation Oath Enforcement Authority, Common Law Governance of Top-Level Corruption Controls for the Peace Plan States, Test Case Interested Party Status and Test Case Public Gallery Observation Rights for Peace Plan States.
