1. Most Recent Events:

- 1.1. In 2026, Email Filing Denial Fraud by the Magistrates Court at Kings Lynn
- 1.2. On 2nd June 2026, 36CJ2485825 Case Paper Filing Denial Fraud by the Kings Lynn Magistrates Court Officers who claimed they had Case Paper Filing Denial Fraud from Norfolk Crown Court Officers.

2. Event Witnesses:

- 2.1. All who did an Email Address Internet Search that returned: “King’s Lynn Magistrates’ Court does not provide a direct public email address. For queries, document submissions, or case updates, contact the Courts and Tribunals Service Centre (CTSC) by phone or visit the court in person.’

4. General Motives: Protection Frauds for Endemic Corruption Managers:

- 4.1. The Protection Fraud Network manages Endemic Corruption. It uses Cabinet Office and the Judiciary to provide Protection Frauds for Crime Businesses managed by State Officers and Law Court Judges.
- 4.2. The Network had a Costs Control Policy.
 - 4.2.1. It used Paedophile Entrapment and Paedophile Framing Frauds to get Blackmail Victims. It used Appointment Frauds for Blackmail Victims to get Puppet Officers and a Reliable Supply of Fraud Services at No Profit Share Cost.
 - 4.2.2. The Protection Fraud Reassurance for the Puppet Officers was:
 - 4.2.2.1. Use of Young Children and Disabled Adults to service the Sex Crime Carvings of Puppet Officers
 - 4.2.2.2. It used Paedophile Protection Frauds for Notorious Celebrities was the Constant Protection Fraud
- 4.3. The Network had a series of Business Expansion Plans
 - 4.3.1. Top Police + Top Customs + Top Judges used Customs Officers for Tobacco Duty Evasion Crimes + Drug Import Crimes and Police Officers as Distribution Managers
 - 4.3.2. Performance Enhancing Drugs for Sport Professionals and Fitness Fanatics
 - 4.3.3. Industrial Scale Court Frauds that used Management Systems for Evidence Exclusion Frauds for:
 - 4.3.3.1. Land Frauds for Big Owners against Small Businesses
 - 4.3.3.2. Land Thefts for Network Agents against the State
 - 4.3.3.3. Everything Else
 - 4.3.4. Sex Crime Blackmail that used Paedophile Minimum Sentence Frauds from the USA for Mr Epstein that got Support Services from him
 - 4.3.5. Family Sabotage Frauds + Child Thefts to get Big Budgets + Budget Fraud Profits and Expatriation Frauds to get Money Laundering Services by Sovereign States for Top Network Agents
