Polite Request:

1. Who has Disclosure Authority to identify the Security Guard who was the Event Witness for the Case Papers Filing Refusal Fraud on 2nd June 2026 by Kings Lynn Magistrates Court?
2. If it is you, are you willing to identify the Event Witness?

 - 3.1. Event Witness Identification Authority Requests of the Security Managers and the Magistrates Court Officers
 - 3.2. Disclosure of the Request Responses

REASONS:

1. In 2023, the Coronation Oath Enforcement Authority got Endemic Corruption Proof against the UK Judiciary.
2. King Charles used it to negotiate the World War III Peace Plan. In December 2023, the G7 Summit got Agreement Signatures.
 - 2.1. The Peace Agreement requires Sovereign States to destroy the Protection Fraud Networks that manage Endemic Corruption, recover control of State Budgets, resource World War III Defences and resource a Just World Order.
 - 2.2. The Management Agreement got Test Case Status for the UK, Test Manager Status for the Coronation Oath Enforcement Authority, Interested Party Status for the Peace Plan States and a Top-Level Corruption Control Standard that uses the Common Law.
 - 2.3. The Remedy Agreement got Remedy Enforcement against Fraud Profiteers and Penal Enforcement against Corrupt Leaders.
 - 2.4. The Delivery Agreement got Delivery Commitments some of which were conditional
 - 2.5. The Publicity Agreement required Whole Plan Secrecy and Plan Stage Success Publicity, without disclosure that is what it is, until there is enough for Whole Plan Publicity.
3. The Test Case used Remedy Delivery by Japan and the USA to finance the Remedy Budgets for the Post Office Scandal and Contaminated Blood Scandal. Corruption Exposure got an increase in the MP Retirement Rate, and Incredible Choice and Split Conservative Values Majority Vote that enabled a Minority Vote to get Landslide Governing Majority, Cabinet Office for Top Network Agents and the Premier Office for Topmost Network Agent Sir Keir Starmer.
4. The 2024 Parliament Session Grant started a Dismissal Process against the Network Agents that have Cabinet Office. The Corruption Remedy Conditions required 20,000 Imprisonment Fraud Releases, Dismissal Executions against the Judiciary by Parliament, Victim Identification and Case Remedies. The Network had used Keir Starmer and the office of Director of Public Prosecutions to commit thousands of Imprisonment Frauds. The Cabinet dare not admit any Imprisonment Frauds. The 3,500 Guilty Prisoner Releases for the Overcrowding Reason was a Grant Condition Breach. It got a Remedy Denial Fraud Finding against the Cabinet and Default Dismissal Penalty against Prime Minister Sir Keir Starmer. The Landslide Majority created the need for International Support for Dismissal Execution.
5. The Peace Plan States made a Dismissal Plan.
 - 5.1. The Church of England Scandal was that Sex Crime Complaints by Victims and Bishops that got Investigation Denial Fraud Proof against the State.
 - 5.2. In January 2025, the Peace Plan States used USA President Elect as their representative to support the UK Opposition Leaders in use of the Child Prostitution Scandal to extort Remedy Delivery Commitments from the UK Cabinet. They were Commitment Frauds. Their Absolute Priority was Remedy Sabotage Frauds. They needed Epstein File Concealment Frauds, made Lord Mandelson the Concealment Manager and gave him the office of UK Ambassador to the USA. He negotiated a Treason Deal. It got Big Bribes for USA President Mr Trump, Epstein File concealment Frauds for the UK Cabinet and Defence Sabotage Frauds for Russia against Ukraine, Western Europe and NATO.
6. Everything that could go wrong for the Treason Deal Partners did go wrong. Remedy Denial Frauds got the Epstein Scandal + Epstein Scandal + Starmer Scandal. USA President Mr Trump used War Frauds against Iran in hope of getting War Hero Status and Treason Immunity. He failed.
