Appeal Grounds: Fraudulent Breach of Natural Justice + Human Rights + Overriding Justice Objective

Appeal Issues:

1. Criminal Conspiracy by Renegade State Officers and Renegade Law Officers:
 - 1.1. to service the Governance Frauds by Renegade Politicians that replaced Equity Governance using the Common Law with Dictator Governance by the State
 - 1.2. to replace Dictator Governance with Predatory Governance that delivers Endemic Corruption
 - 1.3. to provide Protection Frauds for the Endemic Corruption Managers
 - 1.4. to use Career Bribery + Career Blackmail that gets Defence Case Sabotage Frauds by State Approved Professionals against Corruption Victims
 - 1.5. to resist Corruption Remedy Process managed by the Coronation Oath Enforcement Authority that got the World War III Peace Plan for Democratic States. In December 2023, the G7 Summit got Agreement Signatures:
 - 1.5.1. The Peace Agreement requires Sovereign States to destroy the Protection Fraud Networks that manage Endemic Corruption, recover control of State Budgets, resource World War III Defences and resource a Just World Order
 - 1.5.2. The Management Agreement got Test Case Status for the UK and Test Manager Status for the Coronation Oath Enforcement Authority, Interested Party Status for the Peace Plan States and Common Law Governance of the Top Corruption Controllers of Peace Plan States
 - 1.5.3. The Remedy Agreement got Remedy Enforcement against Fraud Profiteers and Penal Enforcement against Corrupt Leaders
 - 1.5.4. The Delivery Agreement got Delivery Commitments some of which are conditional
 - 1.5.5. The Publicity Agreement got Whole Plan Secrecy and Stage Success Publicity without disclosure that is what it is until there is enough for Whole Plan Publicity
 - 1.6. to manage Sabotage Frauds against the World War III Peace Agreement
 2. Criminal Conspiracy by Endemic Corruption Managers to use Oppression Frauds against Citizen Mr Pead:
 - 2.1. to deliver Murder Protection Frauds for the Corrupt Officers who in 1999 used the Murder Victim's Dead Body + Investigation Powers + Prosecution Powers + Adjudication Powers for a Murder Framing Fraud + Imprisonment Frauds against Mr Tony Martin and then responded to the Corruption Outrage of the People with an Appeal Fraud that changed the Conviction Fraud from Murder to Manslaughter + Early Release
 - 2.2. to deliver Sex Predation Protection Fraud for the Corrupt Officers who in 2006 used a Disabled Child as a Sex Predation Tool that motivated a Criminal Investigation by Headmaster Mr Brian Pead and a Ruin Fraud Conspiracy against him. In 2013 he started Corruption Complaints + Corruption Publicity for Mr Tony Matrtin.
 3. In 2019, Citizen Mr Pead discovered the Coronation Oath Enforcement Authority and Corruption Remedy Process. Chronic Corruption Stress had done Remedy Co-operation Incapacity Damage. It denied the Coronation Oath Enforcement Authority use of the Endemic Corruption Proof against the Judiciary got by the cases of Mr Pead.
 4. In 2025 and 2026 the Corruption Remedy Test Cases got as series of Confidence Collapses + Fraud Service Refusals by State Officers and Law Officers. The Stalking Harassment Framing Fraud 36CJ2485825 get a Fraud Presumption that someone involved in the 1999 Murder is a Top Endemic Corruption Manager in Norfolk.
 5. On 17th May 2026, a Help Request by Mr Pead via the website 'equitygovernance.uk', and Case Management Advice from Equity Lawyer Mr Ellis enabled Citizen Mr Pead to use the 36CJ2485825 Plea Hearing on 4th June 2026 to get Criminal Conspiracy Proof against the Investigators + Prosecutors + Supervising Judges + Case Judges
 6. Unfinished Business Notice + Comparator Case Notice for the 1999 Norfolk Murder + 1999 Jill Dando Murder
