Corruption Remedy Publicity for World War III Peace Plan States using the Cyprus Case + UK Case

**The Cyprus Case.** In the 16<sup>th</sup> century, the Say Family were Muslim Turks who helped colonise Cyprus for the Byzantine Empire. They became fully integrated with the Greek Cypriots. The Say Family Farm was 10 miles from nearest Cypriot Turks. They had 200 sheep that produced milk and cheese all year round and employed 2 – 300 Crop Workers for up to 3 months of the year. They were the biggest business in the village. The Greek Orthodox Church was dependent on them for Charity Donations. In 1974, the Greek Coup caused big disturbances in Cyprus. The Say Family fled to the Muslim Area. Greek Cyprus took what it claimed was Protective Custody of the Vacant Farm. Protective Custody Release Failures were Land Frauds by Greek Cyprus against the Say Family. It gets worse. There is oil in the sea between Turkey and Cyprus. Turkey wanted an unfair share of the oil. They needed a weak Cypriot State to get it. Turkey and Greece were NATO Members. It did not stop Turkey from using the Greek Coup for a Plunder Invasion and creation of the North Cyprus State. It was a Weak Pariah State and unable to enforce Oil Rights. In the Cold War the Communists and Reactionaries both gave Opposition Status to the Moderate Conservatives. The Claimant's father was a Moderate Conservative MP. He argued for a United Cyprus. It got Pariah Status for the Say Family in North Cyprus and a Forced Resignation of the Claimant from employment as a State Bank Manager. He took his Bank Manager Skills to the Production Line and then the Vegetable Market. A friend got employment for him in a UK Fast Food Shop. In March 1987, he migrated to the UK with his wife and eldest child with nothing. He started work the next day.

**The World War III Peace Plan needs a Precedent Set with Case Remedies including Immunity Deals. The Cyprus Farm Case of the Say Family against Greek Cyprus is excellent for a Land Frauds Remedy Precedent. The Say Family had Fully Integrated Status + Vulnerable Minority Status + War Refugee Status + Land Fraud Victim Status. The Peace Plan States will use the Remedy Precedent everywhere they have influence.**

**The UK Case.** The Protection Fraud Network used Cabinet Office and the Judiciary to provide Protection Frauds for Crime Business managed by State Officers and Law Officers. Top Police, Top Customs and Top Judges had the biggest Tobacco Smuggling Business and then became the Top Drug Dealers. They use Police Officers as Distribution Managers. They sold Bespoke Court Frauds. In the 1980's the Network made a Business Expansion Plan for Industrial Scale Court Frauds. It needed Case Management Research to discover what was needed to manage Industrial Scale Frauds and then Cabinet Control for Expansion Delivery. Stage One was Land Frauds for Big Owners against Small Businesses. Stage Two was Land Thefts for Network Agents against the State. The sale of Town Centre Estates from the New Towns Commission to Land Securities got a Big Business for the Case Management Research. In March 1987, the Claimant, his wife and child migrated with nothing worked hard and saved £20,000 in two years. He produced Business Accounts, filed them with the Inland Revenue, got a Temporary National Insurance Numbers for him and his wife, paid what the UK State wanted and got a Permanent National Insurance Numbers. He bought the 1<sup>st</sup> Business. It was a Fast-Food Shop Freehold in the Corby Suburbs. He trebled the turnover in three months, paid taxes and national insurance and got a Success Reputation with the Corby Business Community. He bought the 2<sup>nd</sup> Business was a Fast-Food Shop Lease in Corby Town Centre with Land Securities the Lessor. Land Securities made a Land Theft Plan. It used the Local Managers as Theft Managers. It used Police Dogs and Immigration Officers for Illegal Immigrant Raids on both the café and house + Deportation Fraud + Lease Forfeit Possession Fraud + use of the Business Profit Proof to set a Very High Rent for the New Lease and use that for Rent Increase Frauds against Corby Businesses and then Nationwide. It failed. The Claimant informed the Immigration Officers that the 1960 Cyprus Peace Agreement was signed by Greece, Turkey, the UK and USA got UK Citizen Rights for him and his family. They thanked him and said they would use the information to close hundreds of cases. The Claimant remained in UK and carried on business. Land Securities used his case for Case Management Research of every combination of Legal Action and Fraud Agent. They did not use any for Possession Enforcement because there were more Research Tests.

The Claimant has 16 Big Boxes of Case Papers. They are the Victim Records of the Industrial Scale Court Fraud Research managed by Land Securities. It discovered that Business Management Systems were designed for Remedy Management. Industrial Scale Court Frauds needed Business Systems that manage Evidence Exclusion Frauds needed to get Protection Frauds. The Network used Top Accountants to make that the Business Standard. The Land Frauds Business Expansion Plan needed Cabinet Control. Top Network Agents needed a Risk Control against the Cabinet Profit Share reducing Top Agent Profits.

The Northampton Telegraph was one of the Fraud Agents serviced the Research Frauds against the Claimant. They published Propaganda Frauds for Land Securities and the Other Fraud Agents and committed Response Denial Frauds against the Claimant.

The 1997 General Election got a Landslide Governing Majority led by Prime Minister Mr Blair and Cabinet Office for Top Network Agent Mr Peter Mandelson. They were Totally Corrupt. The Predictable Greed of Prime Minister Mr Blair denied him a Network Profit Share and denied the Network Cabinet Control. Mr Mandelson sold Policy Waiver Frauds for Prime Minister Mr Blair and managed the Network Business Expansion Plan for Performance Enhancement Drugs to Sport Professionals and Fitness Fanatics. It classified Honest Competitors who had Influencer Status as an Exposure Risk and managed Ruin Frauds against them. Mr Mandelson did not have enough Cabinet Control for the Land Frauds Business Expansion Plan. In 1998, a Corruption Scandal got Forced Dismissals. In June 2001, the General Election got Cabinet Office for him again, but he lost it before the year end.

In 2004, the preparations for the European Referenda got Election Fraud Proof against the European Leaders. They wanted Inconsistent Things. They wanted Dictator Powers and a Referenda Majority. They needed Dictator Power Concealment Frauds to get the Referenda Majority. The Lawful Business of UK Citizens made inevitable exposure of the Election Frauds. They made an Election Fraud Concealment Plan. It used Sabotage Frauds against the Lawful Business. They were Imprisonment Frauds against two Lawful Business Managers. They used Netherlands Judge Trials because UK Jury Trials were an Exposure Risk. They needed Extradition Frauds against the Lawful Business Manager who was a UK Citizen. They did not have an Extradition Treaty or time to make one. The 1<sup>st</sup> Extradition Fraud failed. It used Armed Dutch Police on UK soli to supervise UK Customs and Kent Police in a Kidnap Extradition Fraud against the UK Citizen. UK Customs knew that all States used Kidnap Extradition Frauds. It was the first Joint Kidnap Extradition fraud by EU States. They did not believe that is what it was. A complex series of events discovered the Extradition Target would have nothing to do with drugs for profit, when threatened with violence or under police supervision. It got Incredible Target Status for the UK Citizen in Drug Investigations. The Top Drug Dealers used his addresses as Decoy Addresses in the Carrier Movement Records for more than 70 Drug Shipments because, if anything went wrong, the Incredible Target Status would ensure Decoy Address Enquiries would get Dead End Results. The Extradition Fraud Set Up Period coincided with the next Drug Shipment Period. They believed it was cover for a Decoy Address Investigation. They got TV News Coverage of a Big Drugs Bust and International Co-operation and took control to manage Decoy Address Investigation Sabotage Frauds. The UK Citizen was in a UK Prison with UK Jury Trial Rights and an Investigation Record that was Innocence Proof for him and Guilt Proof against the Fraud Conspirators. It discovered the Top Police, Top Customs and Top Judges were the Top Drug Dealers and exposure the Protection Fraud Network. The 2<sup>nd</sup> Extradition Fraud got Immunity Frauds for the Top Drug Dealers, Election Fraud Concealment Services for the EU Leaders, an Extradition Treaty for the UK and Netherlands, use of it for the 1<sup>st</sup> Extradition Warrant against the UK Citizen, a Network Profit Share for Prime Minister Mr Blair, Cabinet Control for the Network and Criminal Conspiracy proof that Equity Lawyer Mr Ellis and Queen Elizabeth used to revive active service of the Coronation Oath Enforcement Authority and a Corruption Remedy Process for the People.

In 2006, the Remedy Process got a Corruption Findings + Forced 10 Months Retirement Notice from Prime Minister Mr Blair. It enabled use of the Leadership Contest to discover more than half the Governing Majority were Network Agents or Network Puppets. A Leadership Deal got Support Votes from Prime Minister Mr Blair for Candidate Mr Brown and Cabinet Office for Network Agents including Mr Peter Mandelson, who needed a peerage. He used it for the Land Frauds Business Expansion Plan Stage One, that got a Possession Fraud against the Claimant, and the Sex Blackmail Business that used Support Services from Mr Epstein and then in 2014, Family Sabotage Frauds + Child Thefts. Land Frauds Stage Two was delayed until 2016 when he managed it for Prime Minister Mrs May.

**The World War III Peace Plan needs a Precedent Set for Case Remedies including Immunity Deals. The UK Frauds are excellent for the purpose. It needs Case Preparations for Remedy Action and Media Publicity. It needs to cover the Entire Process from Industrial Scale Fraud Research to Expansion Plan Management, Remedy Process Management and Peace Plan Management.**
