Other Needs

The Coronation Oath Enforcement Authority are managing a Corruption Remedy Process. They need a Case Transfer from the Magistrates Court to the Crown Court at Chelmsford. They need Joint Case Management of Framing Fraud 22CA1074323 against Equity Lawyer Mr Ellis with Framing Fraud 41CT1354426 against Citizen Mr Coyle. The need Case Priority for 22CA1074323 because it will get Corruption Findings + Remedy Investigation for the Equity Lawyer and a 41CT1354426 Charge Withdrawal + Corruption Counter Charge Admission + Remedy Investigation Consent for Citizen Mr Coyle by the State. It will get use of both cases for a Budget Fraud Investigation that discover the Investigation Fraud Costs + Prosecution Fraud Costs + Trial Fraud Costs.

The Coronation Oath Enforcement Authority need Court Room Events to get Audio Records that are Personal Responsibility Proof against Identifiable Individuals for Known Court Frauds. They need it because Endemic Corruption uses Record Frauds by the State and Law Courts. They need Budget Fraud Proof, and both cases are excellent for the purpose.

Sample Budget Frauds: Investigation Budget Frauds + Custody Budget Frauds

In 2023, Bribery Management by Lord Peter Mandleson for the Pharmaceutical Industry got the Osteopath Misdescription Trial Frauds in Worcester Criminal Courts. Equity Lawyer Mr Ellis attended to get the Trial Fraud Proof against the Crown Court. The Trial Judges issued Court Exclusion Frauds against Equity Lawyer Mr Ellis were executed by Court Officers. Valid Process needed a Court Session and a Court Room Access Rights Trial that would have discovered the General Rule is Court Room Exclusion against Fact Witnesses because of the Fact Evidence Change Risk and the Rule Exception for Jurisdiction Witnesses because Official Records are the Fact Evidence and there is No Evidence Change Risk. It did not get Valid Process. It got Public Gallery Criminal Trespass by West Mercia Police fort the 22CA1074323 Arrest Fraud + Investigation Frauds. Crown Court Audio Record Production Demands by the Equity Lawyer got Audio Record Evidence Concealment Fraud Proof against the Crown Court, West Mercia Police and Crown Prosecutors. The Defence Statement + Audio Record Production Application + Bail Surrender got Confidence Collapses + Bail Surrender Failure Action Refusals by the State and Magistrates Court. In 2026, management of the Stop Failure 41CT1354226 Investigation validated the Framing Fraud Investigation by Equity Lawyer Mr Ellis. The Custody Budget Fraud Proof includes Cell Design that services Oppression Frauds. There is a No Wash Basin for use before eating or after toilet use. It creates the need for a Hand Wash Service Call or Tooth Cleaning Service Call + Officer Supervision of the Communal Basin Visit for Handwashing + Unfit Toothbrush Provision for Tooth Cleaning.

The Security Budget Fraud Proof includes the use of a Large Security Van to move 2 Harmless Prisoners about 50 yards across the road from the Police Station to the Magistrates Court, and then Magistrates Court Security Army.

There were Zero Justice Management Costs. All Costs were Fraud Costs. The Peace Plan States need a Precedent Case for Fraud Costs Recovery from Fraud Managers and Fraud Beneficiaries.

Queen Elizabeth, and then King Charles, needed Endemic Corruption Proof against the Judiciary to negotiate the World War III Peace Plan for Democratic States. It needed Corruption Proof against Northern Ireland to get a Peace Settlement Revision. The Ruin Fraud Conspiracy against Citizen Mr Coyle got Corruption Proof that did not meet the Corruption Remedy Proof Standard and was therefore Inadmissible Evidence for the Coronation Oath Enforcement Authority. Mr Coyle did not know his father provided Paedophile Entrapment Services + Paedophile Framing Fraud Services for the Protection Fraud Network in Northern Ireland. His father thought he did know. In 2014, the Corruption Remedy Process managed by the Coronation Oath Enforcement Authority made so much progress the Protection Fraud Network needed a Business Expansion Plan to avoid Total Collapse. They used Family Sabotage Frauds + Child Thefts to get Big Budgets + Budget Fraud Profits and Expatriation Frauds to get Money Laundering Services by Sovereign States. Lord Mandelson was an Expansion Plan Manager. The Protection Fraud Network in England needed Commitment Proof from Northern Ireland. They were given Ruin Frauds managed by the father against Citizen Mr Coyle: Family Sabotage Frauds + Mental Illness Custody Frauds + Forced Medication Frauds. His friend, Corruption Victim Mr David Barr made an Escape Plan via Eire to England where he discovered a Corruption Victim Community.

In June 2016, a Community Member introduced Mr Coyle to Equity Lawyer Mr Ellis. The Context Disability and Communication Disability made it very difficult to get a Case Explanation from Mr Coyle. He got enough for Integrity Tests in 2016 that got Fraud Proof against the father that met the Corruption Remedy Proof Standard. The Case Details came out over years. They enabled Integrity Tests to get it against the Former Wife, State and Law Courts.

The Disabilities of Citizen Mr Coyle were an Investigation Asset for the Equity Lawyer. Mr Coyle got access to Corruption Victims who did not know who to trust, passed on the information and enabled Timely Intervention by the Equity Lawyer that got Case Management Authority. Some of the Corruption Victims needed Crisis Conditions to give Case Co-operation with an Immediate Crisis Limit. Citizen Mr Coyle used access to Corruption Victims to give Crisis Warnings to the Equity Lawyer. Citizen Mr Coyle identified Corruption Victims in Northern Ireland. Citizen Mr David Barr was one. His case got a Complete Set of Endemic Corruption Proof against the State and Law Courts in Northern Ireland for the Peace Settlement Revision that prepared for the World War III Peace Plan

In 2023, King Charles negotiated the World War III Peace Plan for Democratic States. The Peace Agreement requires Sovereign States to destroy the Protection Fraud Networks that manage Endemic Corruption, recover control of State Budgets, resource World War III Defences and resource a Just World Order. The Management Agreement got Corruption Remedy Test Case Status for the UK and Test Manager Status for the Coronation Oath Enforcement Authority, Interested Party Status for the Peace Plan States and the Common Law for the Top Corruption Controllers.

The Peace Plan States led by USA President Mr Biden made a Test Case Management Agreement. It needed Remedy Delivery Commitments and Defence Budget Commitments that forced the UK Cabinet to choose between Just Remedies by Total Termination of Budget Frauds against the State, and Total Destruction of the Protection Fraud Network or Enforcement Frauds for Business As Usual. They knew that USA President Elect was Chronically Immature and a Corruption Risk. Various Events got the 3.5% Defence Budget Commitment. In January 2025, They used him as Peace Plan Representative to support the UK Opposition Leaders in use of the Child Prostitution Scandal to extort Remedy Delivery Commitments from the UK Cabinet. They were Dismissal Execution on Monday 14th July 2025 against the Judiciary by Parliament and a start to Victim Identification and Case Remedies on Thursday 17th July 2025 using the Framing Fraud 2023 0058 Trial of Citizen Mr Nkrumah. They were Commitment Frauds. The Absolute Priority of the UK Cabinet was Remedy Sabotage Frauds. They needed Epstein File Concealment Frauds from USA President Mr Trump. They made Lord Peter Mandelson the Concealment Manager and gave him the office of UK Ambassador to the USA. It got Personal Access to USA President Mr Trump and Trade Negotiations. A Treason Deal got Big Bribes for USA President Mr Trump, Epstein File Concealment Frauds for the UK Cabinet, Defence Sabotage Frauds for Russia against Ukraine, Western Europe and NATO and Money Laundering for Trump Family Members because State Officers and Trump Employees were an Exposure Risk. Deal Failures motivated a Treason Defence Plan by USA President Mr Trump. It needed Iran War Frauds + Massive Bombardment + Total Victory + War Hero Treason Immunity. It got War Monger Status and added War Budget Fraud Proof to the other Budget Fraud Proofs. The Peace Plan States need UK Budget Fraud Proof against Mr Mandelson and Prime Minister Sir Keir Starmer to prepare for the Treason Investigations by the UK Parliament and USA Senate. Cases 22CA1074323 + 41CT1354226 + the Nkrumah Cases got Recent Fraud Proof that link to Old Fraud Proof and can service the Treason Investigations.
