Upon reading the Harassment 36CT2485825 Court File and Defence Papers dated 25 May, 1,2,3,4,5 and 21 June 2026.

1. Court Motion Conflicted Interest Finding + Conflict Jurisdiction Disqualification Finding + Remedy Only Jurisdiction Limit Finding + Contempt Investigation Order for Citizen Mr Pead against the State
2. Contempt Investigation Resource Reference to Parliament. REASON: Conflict Disqualification against the Cabinet
3. Pending Remedies Enforcement Stay Protection Orders for All Citizen Witnesses against the State
4. Polite Request that Citizen Defendant Mr Pead and Citizen Witness Mr Iain McMaster prepare to service the Contempt Investigation by Voluntary Filing and Voluntary Service within 14 days a Statement that explains when he discovered the Coronation Oath Enforcement Authority, the Corruption Remedy Process and World War III Peace Plan for Democratic States and that it got Corruption Remedy Test Case Status for the UK, Test Manager Status for the UK Coronation Oath Enforcement Authority, Interested Party Status for the Peace Plan States and Common Law Governance of the Top Corruption Controllers + when he realised that the Peace Plan needs use of Corruption Cases and the Common Law for Integrity Tests of the UK Authorities and serviced the Integrity Tests
5. Immunity Order for Former Prime Minister Mr Brown in exchange for Remedy Co-operation that includes Full Disclosure about the 2006 – 2007 Leadership Deals that got Support Votes and Premier Office for him
6. Contempt Investigation Directions Hearing at noon on 2nd July 2026

REASONS:

1. In 2023, King Charles used Endemic Corruption Proof against the Judiciary to negotiate the World War III Peace Plan for Democratic States. The Peace Agreement requires Sovereign States to recover destroy the Protection Fraud Networks that manage Endemic Corruption, recover control of State Budgets, resource World War III Defences and resource a Just World Order. The Management Agreement got Corruption Remy Test Case Status for the UK and Test Manager Status for the UK Coronation Oath Enforcement Authority.
2. The Peace Plan needs Precedent Cases that use Corruption Remedies for the Case Victims and Budget Fraud Recovery for the State against Fraud Managers and Fraud Beneficiaries. Useful Cases will be:
 - 2.1. Notorious Cases that got Trial Fraud Proof + Censorship Fraud Proof against the Authorities
 - 2.2. Censorship Fraud Cases that denied Fraud Exposure needed to get Notorious Case Status.
3. Sample Notorious Cases:
 - 3.1. On 26th April 1999, Paedophile Scandal preparations by BBC Journalist Jill Dando motivated a Paedophile Protection Fraud Plan by the UK Prime Minister Mr Blair. It used a Murder Conspiracy against Jill Dando and Assassin Hosting Services by the UK Secret Service + Execution Services by a Foreign Secret Service Agent + Murder Framing Frauds against Disabled Victim Mr Barry George that included Bullet Chemical Discharge Expert Opinion Frauds + Other Evidence Frauds. The Framing Fraud Scandal got a Forced Retrial Acquittal + Immediate Release on 20th August 2008. Censorship Frauds prevented use of the Framing Fraud for the Protection Fraud Scandal against Former Prime Minister Mr Blair
 - 3.2. On 20th August 1999, Murder Protection Frauds for Norfolk Police by the Judiciary used a Murder Investigation Denial Fraud that enabled a Murder Framing Fraud against Farm Owner Mr Tony Martin that used the Victim's Body + Murder Time Fabrication Frauds. Fraud Publicity got Notorious Case Status. Public Outrage forced an Appeal Fraud Plan. It used a Mental Incapacity Trial Issue Waiver Fraud + Diminished Responsibility Finding Fraud + Conviction Reduction from Murder to Manslaughter + Early Release + Censorship Frauds to prevent exposure of the Protection Fraud Scandal. A Junior Officer who has Murder Liability rose in the ranks, became a Top Agent of the Protection Fraud Network in Norfolk, and has procured or managed Protection Frauds from 1999 to 2026. They used Ruin Fraud Conspiracies against the Legal Service Charity Lawyer Mr Iain McMaster, who procured Appeal Services from Independent Counsel, and Scandal Publicist Mr Brian Pead who wrote the book entitled Murder Hoax. The Harassment Framing Fraud 36CT2485825 got a Defence Plan by Citizen Mr Pead that used the Plea Hearing on 4th June 2026. It got Conflict Jurisdiction Fraud Conspiracy Proof against the Crown Prosecutor and Magistrates Court until the Defence Case Papers got a Confidence Collapse + Conflict Disqualification Finding + Remedy Only Jurisdiction Limit Denial Fraud + Contempt Investigation Denial Fraud + Jurisdiction Deficit Case Transfer Fraud + Norwich Crown Bail Return Date on 2nd July 2026. It will get Just Remedies or Fraud Enforcement.

- 3.3. On 20th October 2000, the Human Organ Theft Murder of 5 months old baby Sunaina Chaudhari discovered that a Development Defect put the stomach in the Left Lung Cavity where it stunted Stomach Growth + Lung Growth and Killer Doctor used Development Defect Scan Evidence for Defect Remedy Denial Frauds + Genetic Defect Diagnosis Frauds + Doomed Life Prognosis Frauds + Abortion Advice Frauds with intent to get the Abortion Material + Full Anaesthetic Caesarean Section Advice Frauds with intent to use the Unconscious Period of the mother for Baby Murder to get the Human Organs + Genetic Defect Human Organ Sale Profits. It failed. Advice Rejection by the mother, got a Natural Birth that was Genetic Defect Disproof and a Development Defect Remedy Operation, and Medical Records that were Murder Conspiracy Proof. The Hospital Discharge ignored a Ranitidine Use Prohibition for anyone under the age of two years and used a 9 Microgram Ranitidine Dose to get Muscle Relaxation, and then, when the Case Review got a Healthy Baby Finding for Operation Success Statistics, a 33 Times Increase to 300 Microgram Lethal Dose with intent to get Heart Relaxation + Oxygen Starvation + Home Death. It failed. An Emergency Admission for an Admission Reduction to 23 Times Reduction to a 90 Microgram Lethal Dose with intent to get a Slower Murder + Hospital Death + Munchausen by Proxy Murder Framing Fraud against the mother. It got a Murder Success by Framing Fraud Failure. Murder Conspiracy Questions by the Maternal Aunt got a Framing Fraud Termination + Opinion Fraud from Great Ormand Street Hospital that used 5 Doctors and 2 Signatures for a Genetic Defect Diagnosis Fraud + Doomed Life Prognosis Fraud + Mercy Killing Prescription Fraud to get a Child Protection Fraud by the Magistrates Court + Immediate Murder. The Murder Records were Murder Conspiracy Proof. Remedy Action Records were Protection Fraud Proof against the Law Courts and the Financial Records of the Pharmaceutical Industry + Governing Majority Election Campaign Fund + Prime Minister Mr Blair were Murder Protection Fraud Proof against the Cabinet and Parliament.
- 3.4. Additional Evidence Rights Reserved for the Citizen
4. In 2004, the preparations for the European Referenda got Election Fraud Conspiracy Proof against European Leaders including Prime Minister Mr Blair. The Lawful Business of UK Citizens made inevitable the exposure of the Election Frauds before the 2005 European Referenda. The European Leaders made an Election Fraud Concealment Plan. It used Imprisonment Frauds against two of the Lawful Business Managers. Everything that could go wrong for the European Leaders did go wrong. It got Crime Protection Fraud Proof against all of them.
 5. In 2006, Sex Complaints by a Disabled Student got an Investigation Reference to Headmaster Mr Brian Pead, and a Ruin Fraud Conspiracy by the Protection Fraud Network against him. He did not know about the Coronation Oath Enforcement Authority or the Corruption Remedy Process.
 6. In 2006, the Remedy Process got a Forced 10 Month Retirement Notice from Prime Minister Mr Blair. It enabled use of the Leadership Contest for an Integrity Test of the Governing Majority. It discovered more than half were Network Agents or Network Puppets. A Leadership Deal got Support Votes for Candidate Mr Brown, Murder Protection Frauds + Other Protection Frauds for Prime Minister Mr Blair and Cabinet Office for Network Agents including Mr Peter Mandelson.
 7. In 2023, King Charles negotiated the World War III Peace Plan for Democratic States. It got Corruption T=Remedy test Case Status for the UK and Test Manager Status for the Coronation Oath Enforcement Authority.
 8. The Peace Plan States used Various Events to get the UK 3.5% Defence Budget Commitment. In January 2025, they support the UK Opposition Leaders in use of the Child Prostitution Scandal to extort Remedy Delivery Commitments from the UK Cabinet. A Treason Deal got Big Bribes for USA President Mr Trump, Epstein File Concealment Frauds for the UK Cabinet, Defence Sabotage Frauds for Russia against Ukraine, Western Europe and NATO and Money Laundering for Trump Family Members because State Officers and Trump Employees were an Exposure Risk. Deal Failures motivated a Treason Defence Plan by USA President Mr Trump. It needed Iran War Frauds + Massive Bombardment + Total Victory + War Hero Treason Immunity. It failed. It got War Monger Status and added War Budget Fraud Proof to the other Budget Fraud Proofs. The Peace Plan States need UK Budget Fraud Proof against Mr Mandelson and Prime Minister Sir Keir Starmer to prepare for the Treason Investigations by the UK Parliament and USA Senate.
 9. Cases 22CA1074323 + 41CT1354226 + 36 CT2485825 + Nkrumah Cases + Other Cases got Recent Fraud Proof that link to Old Fraud Proof and can service the Treason Investigations. On Thursday 18th June 2026, the UK By-Election got Viable Conditions for a UK Leadership Contest. The Peace Plan needs Election Integrity Tests to get Case Priority Rights for the Victim and Citizen and Top Corruption Controllers that are Credibly Independent of the State, Law Courts, Cabinet and Parliament. The 36CT2485825 Framing Fraud Defence is an Integrity Test.
