1. The World War III Peace Settlement had Fundamental Flaws. The Human Rights Declaration omitted Case Priority Rights for the Citizen and Top Corruption Controllers that are Credibly Independent of the State, Law Courts, Cabinet and Parliament. The Declaration Signatories gave and got Mutual Approval of the Fundamental Flaws and used them to develop Dictator Powers. In every Declaration Signatory the Politicians lost control to Crime Partnerships of State Officers and Law Court Judges. They developed Protection Fraud Networks to provide Support Services and manage Co-ordinated Corruption.
2. The UK was unique. It was a Declaration Signatory and had a Top-Level Corruption Controller with Credible Independence of the State. It is the Coronation Oath Enforcement Authority.
3. The Dictator Governance Plan for Western Europe used Sabotage Frauds against the Coronation Oath Enforcement Authority. Evidence Frauds denied a Reliable Supply of Admissible Evidence. They got a Dormancy Period for it. Education Frauds omitted any mention of it in Academic Curricula and Profession Qualification Curricula so that everyone forget it existed.
4. The Equity Governance Recovery Plan needed Criminal Conspiracy Proof against a serving Prime Minister to end the Dormancy Period and revive active service of the Coronation Oath Enforcement Authority, and then a Reliable Supply of Admissible Evidence to service a Corruption Remedy Process. It needed Research Investigations to discover the structure and strength of the Endemic Corruption Managers and then Remedy Delivery. The Research Investigations discovered the Protection Fraud Network. Corruption Case Management by Citizens uses the Common Law to force everyone in the decision process to choose between Just Remedies or Enforcement Frauds. Confidence Collapses that ripple up the Command Chain. They start with Personal Responsibility Refusals for Fraud Completion. The Protection Fraud Network uses Career Blackmail and Career Bribery to get Fraud Completion by someone else.
5. The Standard Procedure for Remedy Delivery is Dismissal Executions against the Judiciary by a United Parliament, Victim Identification, Case Remedies and an International Agreement to resource a Just World Order. A Parliament Unity Failure creates the need for a Special Procedure to get International Support for Remedy Management. It needs Endemic Corruption Proof against the Judiciary, and use of it by the Crown to get International Support.
6. In 2023, King Charles negotiated the World War III Peace Plan for Democratic States. It got Corruption Remedy Test Case Status for the UK and Test Manager Status for the UK Coronation Oath Enforcement Authority. The Peace Agreement requires Sovereign States to destroy the Protection Fraud Networks that manage Endemic Corruption, recover control of State Budgets, resource World War III Defences and resource a Just World Order. The Management Agreement got Test Case Status for the UK and Test Manager Status for the Coronation Oath Enforcement Authority. The Remedy Agreement got Remedy Enforcement against Fraud Profiteers and Penal Enforcement against Corrupt Leaders. The Delivery Agreement got commitments some of which were conditional. The Publicity Agreement requires Whole Plan Secrecy and Mass Publicity for Plan Stage Successes, without disclosure that is what they are, until there are enough for Whole Plan Publicity. Commitment Deliveries by Japan and the USA got the Damage Payments that financed the Post Office Scandal and Contaminated Blood Scandal. Corruption Exposure enabled the 2024 General Election to break Network Control of Parliament using the Conservative Party and get Set Up Conditions to break it using the Labour Party.
7. The Test Case became a Pincer Operation. Democratic State Leaders manage the UK Cabinet into making International Commitments that require Total Destruction of the Protection Fraud Network that manages Endemic Corruption. Citizens used Corruption Cases for Confidence Testing of State Officers and Law Officers.
8. Financing the 3.5% Defence Budget Commitment needed an end to Budget Frauds against the State. In January 2025 the Peace Plan States and UK Opposition used the Child Prostitution Scandal to extort Remedy Delivery Commitments from the UK Cabinet. It forced the choice of Remedy Action against Network Agents, or Protection Frauds for Network Agents. They chose the Protection Frauds. They needed Epstein File Concealment, made Lord Mandelson the Concealment Manager and gave him the office of UK Ambassador to the USA. He negotiated the Treason Deal. It got Big Bribes for USA President Mr Trump, Epstein File Concealment for the UK Cabinet and Defence Sabotage Frauds for Russia against Ukraine, Western Europe and NATO. Treason Deal Failures got Epstein Scandal + Mandelson Scandal + Starmer Scandal + UK Leadership Scandal.
9. The Peace Plan got Prison Cells for Sarkozy and Donaldson and a Forced Resignation from Starmer. The Judiciary has a choice. They can use the Crown Court Hearings on 2<sup>nd</sup> and 6<sup>th</sup> July 2026 to start Victim Identification and Case Remedies or gamble that the UK Leadership Farce will get Protection Frauds.
