Trial Unreadiness Notice of the Assault Framing Frauds 2023 1180 [Public Gallery] + 2023 0043 [Stolen Property Recovery Denial Fraud]

1. The Common Law resources Responsibility Management. The Common Law provides the Public Gallery so that the Citizen can observe Open Session Cases. State Officers commit Criminal Trespass if they enter the Public Gallery without a Personal Invitation from the Citizen or Public Gallery Clearance Pronouncement in Open Court by the Judge and Order Proof to get Investigation Powers + Prosecution Powers. State Offers who accept a Private Invitation surrender State Powers on entry of the Public Gallery. Case Disclosure by the State do not contain a Public Gallery Clearance Order Proof needed as Legal Title Proof of Investigation Powers + Prosecution Powers + Adjudication Powers.
2. The Common Law give Case Priority to the Corruption Cases of the Citizen against All Cases of the State. Framing Fraud Counter Charges of the Citizen are Corruption Cases. They have Case Priority against All Cases of the State
3. The Case Disclosures on 19th June 2026 by the State omit Case Records that are Production Order Proof + Order Breach Contempt Proof against the State.
4. The Disclosure Failures are Disclosure Fraud Proof for the Citizen against the State.
5. Common Law Corruption Controls:
 - 5.1. use Fraud Proof of anything for a Proof Borden Reversal for the Fraud Victim against the Fraud Manager and the Fraud Beneficiary. The State Investigators, Crown Prosecutors and Law Courts are both Fraud Managers and Fraud Beneficiaries.
 - 5.2. use Conflicted Interests for Conflict Jurisdiction Disqualifications + Remedy Only Jurisdiction Limits. The Disclosure Fraud by the Crown Prosecutor is a Conflict Jurisdiction Disqualification against the State and Law Courts. Other Cases got Similar Fact Fraud Proof.
6. The Case History includes the 01KW1226225 + 01KW1237025 Secret Hearing Frauds used for the Trial Denial Fraud. The 01KW1226225 + 01KW1237025 Trial Appearance 8th June 2026 by Citizen Mr Nkrumah discovered the 2023 1180 + 42MR1372521 Secret Hearing on 9th June 2026 before Resident Judge Ms Dean. The Secret Hearing Appearance by Citizen Mr Nkrumah got Oral Notice that it was for both 2023 1180 + 2023 0043 but the Order Print by Judge Dean ignores 2023 1180. The Case Disclosures by the State omit the Case Orders dated 9th June 2026 or any other Case Orders.
7. The Disclosure Service Email on 19th June 2026 from the Crown Prosecution Service was forwarded at 03.50 on 24th June 2026 by Citizen Mr Nkrumah to Equity Lawyer Mr Ellis. He did not see the Forwarded Email until after he had produced the Cases 36CT2485825 + 2023 1180 + 01KW01410721 Filing Notice + Service Notice dated 24th June 2026 of Equity Lawyer for Citizens Mr Pead and Mr Nkrumah. That is why the Unreadiness Notice is not included.
8. Equity Lawyer Mr Edward Ellis is Jurisdiction Witness for Citizen Mr Nkrumah. He has End Stage Kidney Failure. And Dialysis Treatment 3 times a week. He does not have the energy or money for Court Appearances that get Trial Unreadiness Findings.
9. The Trial Unreadiness Notice will get either Missing Material Admissions by the State or identify the Missing Material Proof needed as Fraud
10. Additional Representation Reserved Rights for the Citizen against the State

Remedy Proposal

1. Fraud Admission + Contempt Liability Admissions by the State for the Citizen against the State
2. Charge Dismissals + Defence Costs with Indemnity Assessment + Contempt Counter Charge Liability Order + Reputation and Liberty and Estate Restoration Orders + Special and General and Aggravated and Exemplary Damages Order + Counter Charge Liability Costs with Indemnity Assessment for the Citizen against the State
3. Remedy Investigation Order + Investigation Resource Reference to Parliament
4. Indemnity Order for the State against Fraud Managers and Fraud Profiteers.
5. Indemnity Investigation Order to identify Liable Individuals + Investigation Resource reference to Parliament
6. Investigation Directions Hearing at noon on July 2026
