The UK Coronation Oath Enforcement Authority needed International Support for Remedy Management. In 2023, King Charles negotiated the World War III Peace Plan for Democratic States. The Peace Plan Agreements got Corruption Remedy Test Case Status for the UK, Test Manager Status for the Coronation Oath Enforcement Authority, Interested Party Status for the Peace Plan Signatories and conversion from Dictator Governance to Equity Governance Common Law governance via the Top Corruption Controllers.

The change from Dictator Governance to Equity Governance is a Management Challenge. The most efficient way to do it is a Common Law Invalidity Presumption for the Citizen against All Legislation + All Regulation + All Policy + All Precedent that supported Dictator Governance subject to Rebuttal Proof Positive. The Equity Lawyer has used Corruption Remedy Test Cases to demonstrate the need for the Common Law Invalidity Presumption.

Delivery Commitments by Peace Plan States got Remedy Enforcement against Fraud Profiteers. It financed the Remedy Budgets for the Post Office Scandal and Contaminated Blood Scandal. Corruption Exposure enabled the 2024 General Election to break the Conservative Party as a Parliament Control Agent for the Protection Fraud Network. The challenge then was breaking the Labour Party as a Parliament Control Agent for the Protection Fraud Network.

The Peace Plan States helped to get Set Up Conditions for Total Destruction of the Protection Fraud Network. They extorted a 3.5% Defence Budget Commitment that forced the choice between Total Termination of Budget Frauds against the UK State for Commitment Delivery, or a Commitment Breach. They supported the UK Opposition Leaders in use of the Child Prostitution Scandal to extort the Remedy Delivery Commitment. It was Dismissal Executions on 14<sup>th</sup> July 2025 against the Judiciary by Parliament, and use of Framing Fraud 2023 0058 Trial Listing on Thursday 17<sup>th</sup> July 2025 for Victim Identification for Citizen Mr Nkrumah and Case Remedies. They were Commitment Frauds. Their Absolute Priority was Remedy Sabotage Frauds. They needed Epstein File Concealment Frauds. They made Lord Mandelson the Concealment Manager and gave him the office of UK Ambassador to the USA. He negotiated the Treason Deal. It got Big Bribes for USA President Mr Trump, Epstein File Concealment Frauds for the UK Cabinet and Defence Sabotage Frauds for Russia against Ukraine, Western Europe and NATO.

Deal Failures motivated USA President Mr Trump to make a Treason Defence Plan. It needed Iran War Frauds + Massive Bombardment + Total Victory + Dictated Peace Terms + War Hero Status + War Hero Immunity. It failed. The Total Victory Failure got added War Crimes Liability to Treason Liability.

The Peace Plan States need UK Test Case Management that get Criminal Conspiracy Proof that can be used for Treason Impeachment of USA President Mr Trump.

Honest Deals that trade Immunity Terms for Remedy Co-operation can be used to get Full Disclosure about Leadership Deals + Election Deals + Governance Frauds + Treason Deals.

The Top Rank Targets are Top Fraud Profiteers, Mr Mandelson, Sir Tony Blair, Mrs Teresa May and Sir Keir Starmer. The Middle Rank Targets are Mr Johnson and Ms Truss. Lower Rank Targets are Mr Brown and Mr Corbyn. The Negotiation Plan is Negotiation Authority Publicity + Negotiation Offers to all + use of Offer Responses to decide Negotiation Management.

Former Prime Minister Mr Brown managed Corrupt Policies. One was a Dormant Account Theft Permit for Banks against Citizens in exchange for use of Theft Proceeds for Bank Profits + Economic Growth Pretence Frauds. He can give evidence about the European Referenda Election Fraud Conspiracy, the Leadership Deal that got Support Votes for him and Cabinet Office for Mr Mandelson, and the Appointment Frauds that got the office of Director of Public Prosecutions for Mr Keir Starmer.

Former Opposition Leader Mr Corbyn made an Election Deal with Former Prime Minister Mr Johnson. They needed Candidacy Sabotage Frauds against Citizen Mr Adam Mustafa to stop him standing for the Nantwich and Crewe Constituency in the 2019 General Election. Cheshire Police ignored Car Ownership Proof and used a Car Theft Pretence fraud for and Arrest Fraud + Mental Illness Reference Fraud + Detention Fraud + Forced Medication Fraud until after the General Election. Start with that. Go on to other things. Someone will crack. Use the Crack Evidence to get Treason Conspiracy Proof against the rest.
