1. Contempt Fraud Conspiracy Case Finding + Case Priority Entitlement Finding for the Citizen against the State
2. Contempt Investigation Order + Investigation Resource Reference to Parliament. Reason: The Case Issues get a Conflict Jurisdiction Disqualification + Remedy Only Jurisdiction Limit for the Citizen against the Cabinet
3. Enforcement Stay Protection Order + Order Breach Contempt Penalty Warning for the Citizen against the State
4. Negotiation Authority for Equity Lawyer Mr Edward Ellis to investigate the exchange of Immunity Terms for Remedy Co-operation with the Contempt Fraud Conspirators. They are: Former Prime Minister Mr Blair + Mr Brown, Mrs May, Mr Johnson, Ms Truss + their Attorneys General + Prime Minister Sir Keir Starmer + Attorney General Lord Hermer KC + Opposition Leader Mr Corbyn + Former Lord Mandelson + Former Top Judges + Top Judges + All Case Officers in All Cases
5. Investigation Directions Hearing at noon on July 2026

REASONS

1. The Protection Fraud Network uses Cabinet Office and the Judiciary to provide Protection Frauds for Crime Businesses managed by State Officers and Law Court Judges. They started with Tobacco Smuggling and then Drug Smuggling. They used Police Officers as Distribution Managers. Top Drug Sales went with Protection Frauds that included Child Prostitution.
2. The Network had a Business Expansion Plan for Industrial Scale Court Frauds. It needed a Big Business to conduct Case Management Research for Industrial Scale Frauds. The sale of Town Centre Estates by the New Towns Commission to Land Securities got a Big Business to conduct the Research Frauds. They did not have a Management Plan. The Group Board gave Land Fraud Orders to Local Managers. At the time they appeared to be in control. With hindsight everything that could go wrong for them did go wrong. Corby Town Centre had a Successful Immigrant, Mr Can Say. He was a Cypriot Turk. His family had moved from Turkey to Cyprus in the 17th century and were Fully Integrated. They had for generations, and possibly centuries, owned good land with a reliable water supply in a Greek Area, 10 miles from the nearest Cypriot Turks. They had a flock of 200 sheep and crops that employed 2-300 people for up to 3 months a year. They had the biggest business in the area. They made substantial Charity Contributions to the Greek Orthodox Church. Deep Sea Oil Reserves motivated Turkey to make an Oil Exploitation Plan. It needed a Pluder Invasion of Cyprus, establishment of a North Cyprus State that had No International Recognition and could not enforce the Deep-Sea Oil Rights or stop Oil Theft by Turkey. In 1974, the Greek Coup got Civil Unrest in Cyprus that forced Cypriot Turks and Cypriot Greeks to leave areas where they were in a minority. The Greek Cyprus State took what it claimed was Protective Custody of the Family Farm and did not return it. The Say Family had Pariah Status in the North Cyprus State because the father became an MP and argued for a United Cyprus. The son was a Bank Manager. The Communists got control and got a Forced Resignation from the son. He, his wife and son migrated to the UK with nothing. Two years later they had saved £20,000. He produced Business Accounts, filed them with the Inland Revenue and got National Insurance Numbers for him and his wife. He bought a Fast-Food Business in Corby Suburbs and trebled the turnover in 3 months. It became an informal social centre. It got a Success reputation. He bought a Town Centre Business and improved it. The Local Managers made a Land Fraud Plan. It needed an Illegal Immigrant Raid + Deoortation Fraud + Lease Forfeit Fraud + use of the Profit Accounts of the Successful Immigrant for a New Lease at a Very High Rent as a benchmark for Rent Increase Frauds in Corby and then Nationwide. It failed. The Successful Immigrant told the Immigration Officers that the 1960 Peace Agreement was signed by Greece, Turkey, UK and USA and got UK Citizen Rights for him. They thanked him and said it enabled them to close his case and hundreds more. Land Securities took control from the Local Managers. They used every combination of Legal Action + Fraud Agent, did not complete Lease Forfeit Frauds so they had Continuing Possession for the Next Test Case. The Successful Immigrant has a Complete Set of the Victim Records of the Court Fraud Research Test Cases. The Test Results discovered that Industrial Scale Court Frauds needed a change in Business Systems from Reliable Accounting that enables Problem Identification and Remedy Management to Evidence Exclusion Frauds that enable Protection Frauds. The Network used Global Accountants to change the Business System Standard. The Business Expansion Plan Stage 1 was Land Frauds for Big Owners against Small Businesses. Stage 2 was Land Thefts for Network Agents against the State. The Business Expansion Plans needed Cabinet Control + a Cabinet Profit Share Limit.
3. The 1997 General Election got a Landslide Majority led by Prime Minister Mr Blair. He was Totally Corrupt. He gave Cabinet Office to MP Mr Peter Mandelson and used him as Marketing Agent for Policy Waiver Frauds. The Network did not use him for Cabinet Control because Predictable Greed would get Big Profit Share Demands by

him and Profit Share Reductions for Top State Officers + Top Judges. They used Cabinet Officer Mr Mandelson for a Business Expansion Plan: Performance Enhancing Drugs. It classified Honest Competitors with Influencer Status as an Exposure Risk and managed Ruin Frauds against them. Citizen Mr Nkrumah was one. The Copyright Framing Fraud was the Ruin fraud against him. In 1998 and 2001, Corruption Scandals got Forced Dismissals of Mr Mandelson from Cabinet Office. He remained a Top Agent. In 2004, the preparations for the European Referenda got Election Fraud Conspiracy Proof against European union Leaders including Prime Minister Mr Blair. The Lawful Business of UK Citizens made inevitable exposure of the Election Frauds in time to influence the Referenda Result. The Election Fraud Concealment Plan used Sabotage Frauds against the Lawful Business. They were Imprisonment Frauds against two Lawful Business Managers. At the time they appeared to be in control. With hindsight everything that could go wrong for them did go wrong. The 1st Effort revealed Top Police, Top Customs and Top Judges were the Top Drug Dealers and had Protection Frauds from Cabinet Officers and the Judiciary. The 2nd Effort got Immunity Frauds for the Top Drug Dealers, Election Fraud Concealment Services for the European Leaders, a Network Business Profit Share for Prime Minister Mr Blair, Criminal Conspiracy proof against a serving UK Prime Minister that enabled Equity Lawyer Mr Ellis and Queen Elizabeth to revive active service of the Coronation Oath Enforcement Authority and start a Corruption Remedy Process. Research Investigation discovered the structure and strength of the Protection Fraud Network. The Standard Process for Remedy Delivery is Dismissal Executions against the Judiciary by a United Parliament, Victim Identification and Case Remedies and a Peace Plan for Democratic States to win World War III and establish a Just World Order. A Parliament Unity Failure gets a Special Procedure. The Citizen and Equity Lawyer get Endemic Corruption Proof against the Judiciary. The Parliament Session Court uses it to validate Negotiation Authority for the Crown to get the World War III Peace Plan for Democratic States.

4. The Remedy Process got Corruption Proof against the State, Remedy denial Fraud Proof against the Law Courts and Protection Fraud Proof against the Cabinet and Default Penalty of a Dismissal Decision against Prime Minister Mr Blair. He was allowed to sign a 10 Month Retirement Notice so that the Leadership Contest could be used of an Integrity test of the Governing Majority. It discovered more than half were Network Agents or Network Puppets. A Leadership Deal got Support Votes from Prime Minister Mr Blair for Candidate Mr Brown, Protection Frauds for Prime Minister Mr Blair and Cabinet Office for Protection Fraud Network Agents including Top Agent Mr Mandelson. No one wanted him as MP. In October 2008 he was given a peerage so he could take Cabinet Office. He managed Business Expansion Plans. One was Land Frauds Stage 1. It needed Business Priming Cases that identified and rewarded Corrupt Professionals and identified and penalised Honest Professionals. Land Securities managed the Town Business Priming Cases. It got the Possession Fraud against the Successful Immigrant. Land Agents managed the Rural Business Priming Cases for Big Owners against Farm Tenants. At the time they appeared to be in control. With hindsight everything that could go wrong for them did go wrong. The Successful Immigrant and Farmer Mr Charles Sydney Ellis were clever enough to decide Case Management that denied Rapid Closure before the 2010 General Election took Cabinet Control for the Network. It delayed Land Fraud Stage 2 until Prime Minister Mr Cameron lost office.
5. Between 2010 and 2015 Prime Minister Mr Cameron, Deputy Prime Minister Mr Clegg and Opposition Leader Mr Miliband did everything the Parliament Sessions Court required them to do. The 2015 Parliament Session grant got Set Up Conditions for Remedy Delivery and a Test case Year. The European Referenda Commitment got the Election Victory for Mr Cameron. He knew that the Dismissal Executions would get Corruption Exposure and an increase in the Leave Vote. He used the Test Case Year for the European Referenda, led the Remain Campaign, lost and resigned. It got a Leadership Contest. Leadership Deals got Massive Bribes from the Protection Fraud Network for Key Influences and Support Votes for Candidate MP Mrs May because she was a Network Agent. Lord Mandelson managed the Expansion Plan for Land Frauds Stage 2. London and Quadrant Housing Association was the Big Business that managed the Priming Case. It used many thousand Forged Tenancies. Forgery Complaints by Citizen Mr Nkrumah motivated a Ruin Fraud Series against him. Competent Defence by him got Official Records that were Fraud Conspiracy Proof. The Fraud Cases of Citizen Mr Nkrumah and others got Endemic Corruption Cases against the Judiciary. In 2023, King Charles used it to negotiate the World War III Peace Plan for Democratic States. The Management Agreement got Corruption Remedy Test Case Status for the UK and Test Manager Status for the Coronation Oath Enforcement Authority. The Peace Plan needs the Witness Protection for Low Rank Criminal Ms Mukasa, Middle Rank Criminals such as Mr Koomson and Case Officers to get Admissible Evidence against Top Criminals Mr Mandelson, Sir Keir Starmer and USA President Mr Trump.
6. The Peace Plan States need Notorious Cases for Remedy Publicity. The 1st Ruin Fraud Series from 2006 to 2012 against Citizen Mr Pead provided Protection Frauds for Notorious Celebrities. In 2013, he met Farmer Mr Tony Martin and wrote the book Murder Hoax. It explains that a Murder Framing Fraud against Mr Martin provided Murder Protection Frauds for Norfolk Police. It motivated the 2nd Ruin Fraud Services from 2013 to 2026 against Citizen Mr Pead. The Peace Plan States need a Credibly Independent Agent to have Immunity Negotiation Authority to identify Corrupt Leaders and manage Penal Enforcement against them.
