Polite Request that you ask the Family Members for the Contact Details of the Probate Estate Representatives

REASON:

1. Lee has a series of cases that got Endemic Corruption Proof against the Judiciary. He wanted to service the Corruption Remedy Process managed by the Coronation Oath Enforcement Authority but did not know how to do it. He got lost in Case Details. He did not know how to make the Case Documents Admissible Evidence for the Crown and Parliament Sessions Court.
2. Lee was unlucky. He bought a Registered Title. He thought it was of a Long Leasehold Title of a Residential Flat on a Council Estate. It was not. It was the Crime Proceeds of Land Theft by Corrupt Officers against Hackney Council.
3. Lee and Can Say were friends. Years before they met each other, they were Separate Victims of Land Frauds. The Protection Fraud Network had a Business Expansion Plan. Stage 1 was Land Frauds for Big Owners against Small Businesses. Stage 2 was Land Thefts for Network Agents against the State.
4. Stage 1 got Victim Status for Can Say. Stage 2 got Victim Status for Lee.
5. Can Say has 16 Big Boxes of Case Records that are Corruption Proof against Land Securities, the State, Law Courts, Cabinets and Parliaments
6. Lee's Probate Estate has Many Records that are Land Theft Proof for Lee and Hackney Council against Corrupt Officers, Law Court Judges, Cabinets and Parliaments. Many are Paper Documents. Others are Email Records. It is the Registered Title that purports to be a Long Lease of a Residential Flat. It is not. It is the Crime Proceeds of a Trial Land Theft by Corrupt Officers against Hackney Council. Government Policy used Discount Incentives for Council Tenants to buy Council Property with Discount Clawback on sales within 3 years. Corrupt Officers used Tenancy Record Frauds to get a Tenancy Discount + Long Lease Pretence Frauds to get the Registered Title Fraud and an Immediate Marketing. It was a Defective Title. A Sale Success needed Service Frauds by a Buyer Lawyer against a Naïve Buyer. Lee was the Naïve Buyer and clever enough to notice Maintenance Account Frauds and courageous enough to manage Fraud Remedy Actions that lasted the 39 years of the rest of his life. The Protection Fraud Network used Court Frauds + Costs Frauds + Charge Frauds against the Registered Title.
7. In 2016 Lee met Equity Lawyer Mr Edward Ellis. He told him about the Coronation Oath Enforcement Authority and the Corruption Remedy Process. Lee gave use of his cases to the Corruption Remedy Process. He meant well but did not know how to co-operate. A lot of it was Corruption Stress. The Remedy Process has an Incomplete Set of the Fraud Proof got by Lee.
8. In 2019, Can Say met the Equity Lawyer. He told him about the Coronation Oath Enforcement Authority and the Corruption Remedy Process. Can gave use of his cases to the Corruption Remedy Process. He meant well but did not know how to co-operate. A lot of it was Corruption Stress. In 2025, Can had recovered enough to enable the Equity Lawyer to discover what examine the Case Records and linked the cases of Can and Lee.
9. In 2023, the Case Records of Lee, Can and many others got Endemic Corruption proof against the Judiciary. King Charles used it to negotiate the World War III Peace Plan for Democratic States. The Peace Agreement requires Sovereign States to destroy the protection fraud Networks that manage Endemic Corruption, recover control of State Budgets, resource World War III Defences and resource a Just World Order. The Corruption Remedy Management Agreement got test Case Status for the UK, Test Manager Status for the Coronation Oath Enforcement Authority, Interested Party Status for the Peace Plan States and the Common Law for Peace Plan States via the Top Corruption Controllers. Commitment Deliveries by Japan and the USA got remedy Enforcement from Fraud Profiteers that financed Remedy Budgets for the Post Office Scandal and Contaminated Blood Scandal. Corruption Exposure got an increase in the MP retirement Rate, and Incredible Choice and Split Conservative Values Majority Vote that enabled a Minority Vote to get a Landslide Governing Majority led by Top Network Agent Sir Keir Starmer. The Peace Plan States serviced the Dismissal Process against him. They procured the 3.5% Defence Budget Commitment that needed Total Termination of Budget Frauds. They helped UK Opposition Leaders use the Child Prostitution Scandal to extort Remedy Delivery Commitments: Dismissal Executions against the Judiciary by Parliament, Victim Identification and Case Remedies. They were Commitment Frauds. Their Absolute Priority was Epstein File Concealment Frauds. A Treason Deal got Big Bribes for USA President Mr Trump, Epstein File Concealment Frauds for the UK cabinet Defence Sabotage Frauds for Russia against Ukraine, Western Europe and NATO and Money Laundering Profits for the Trump Family Members. Deal Failures got the Epstein Scandal + Mandelson Scandal + Starmer Scandal + Leadership Farce Scandal + Treason Scandal Iran War Scandal.
10. Lee got Remedy Priority Rights for the Probate Estate. Remedy Delivery needs the Coronation Oath Enforcement Authority to have the Electronic records + Paper Records of All Cases.
