In 2004, the preparations for the European Referenda got Election Fraud Proof against European Leaders including Prime Minister Mr Blair. **Claim:** Conspiracy to use offices of State, Law, Cabinet, Northern Ireland Assembly and UK Cabinet to commit Justice Process Contempt Frauds to the Treason Standard

#### Brief Particulars

1. Endemic Corruption Proof against the State and Law Courts in Northern Ireland supported Corruption Complaints by the Citizen Claimant as Lagan Valley Constituent. The got a Surgery Meeting + Fraud Findings + Remedy Commitments from MP Mr Jeffery Donaldson. They were Commitment Frauds. He was a Top Agent of the Protection Fraud Network. They use Cabinet Office and the Judiciary of the UK Sovereignty and Constituent States to provide Protection Frauds for Crime Partnerships of Fraud Profiteers, State Officers and Law Court Judges.
2. The World War II Peace Settlement had Fundamental Flaws. The Human Rights Declaration omitted Case Priority Powers for the Victim and Citizen, and Top Corruption Controllers that were Credibly Independent of the State,

Law Courts, Cabinet and Parliaments. The Declaration Signatories gave and got Mutual Approval of the Fundamental Flaws and used them to develop Dictator Powers. International Agreements required Declaration Signatures. It used the fundamental Flaws to establish a Dictator Standard for Democratic States.

3. The UK is unique. It is a Declaration Signatory with a Top Corruption Controller that is Credibly Independent of the State, Law Courts, Cabinet and Parliament. It is called the Coronation Oath Enforcement Authority. The Citizen has Investigation Jurisdiction. The Qualification is a Confidentiality Waiver, Privilege Waiver, and Priority Waiver as Case Owner for the People. It enables use of the truth, whole truth and nothing but the truth for Integrity Tests of the Authorities that get Corruption Remedy Standard Proof Sets. The Equity Lawyer has Integrity Test Management Jurisdiction. The Qualification is the commitment and competence to manage Integrity Tests that get Corruption Remedy Standard Proof Sets. The Crown has Prosecution Jurisdiction. It is the power to make Trial Orders by the Parliament Sessions Court of Corruption Cases against the State and Unfitness Cases against Officers and Authorities. The two Lord Archbishops have Court Lawyer Jurisdiction, one for the Trial Court and the other for the Appeal Court. The 24 Lord Bishops are the Jury Panel. They provide up to 12 Trial Jurors and up to 12 others as Appeal Jurors. When they are busy, they provide 2 Trial Juries of up to 8 and 1 Appeal Jury of up to 8. The Corruption Remedy Proof Standard eliminates the need for witness Attendances, Credibility Findings and Personal Case Presentation. Trial Orders can get Trial Verdicts in 7 days and Appeal Decisions in 10 days. The Ultimate Sanction is a Forced General Election got by Parliament Time Expiry or a Parliament Session Refusal with Mass Publicity for Corruption Proof. It gets an increase in the MP Retirement Rate and Power Transfer to one or more New Governing Majority until one manages Remedy Delivery: Dismissal Executions against the Judiciary by a United Parliament, Victim Identification and Case Remedies.
4. The Dictator Governance Plan for Western Europe used Sabotage Frauds against Leadership Competitors. They used Sex Crime Investigation Denial Frauds against Religious Leaders. The intent was to do Reputation Damage. They used Evidence Frauds and Education Frauds against the Coronation Oath Enforcement Authority. The intent was that Judgment Service Penalty Frauds denied a Reliable Supply of Admissible Evidence for Parliament Session Decisions until everyone forgot how to service it. The Education frauds denied any mention of it in Academic Curricular and Profession Qualification Curricula. The intent was that everyone for get it existed.
5. The Dictator Governance Plan had Inconsistent Priorities. It needed Referenda Majorities for Dictator Powers and Electronic Signature Dictator Power Concealment Frauds to get Referenda Majorities. The Gnostic Christians made an Equity Governance Recovery Plan. It had two strategies. One was for the Citizen to develop Advanced Electronic Signature Technology, provide Sophisticated Services that enabled Proseperous Classes to manage Tax Haven Estates from their homes and use Taxation Starvation to force conversion from Dictator Governance to Equity Governance. The other was to wait until a serving Prime Minister was dependent on the Protection Fraud Networks, get Criminal Conspiracy Proof, use it to revive active service of the Coronation Oath Enforcement Authority, start a Corruption Remedy Process and get an International Agreement for a Just World Order. Equity Lawyer Mr Ellis serviced both strategies. In 2004, Referenda Fraud Proof got revived active service of the Coronation Oath Enforcement Authority and the Corruption Remedy Process.
6. The UK Protection Fraud Network had a Costs Control Policy. It used Entrapment + Framing Frauds to get Sex Crime Blackmail Victims + Office Appointment Frauds that got Puppet Officers who provided Reliable Fraud Services at No Profit Share Cost. Mr Patrick Coyle did not know his father, Mr John Coyle, was the Sex Crime Blackmail Manager for Northern Ireland. In 2014 the father feared Corruption Exposure by the son and managed a Family Sabotage Frauds + Child Thefts + Life Ruin Frauds against the son. Good Friend Mr David Barr managed the Corruption Emigration for the son from Northern Ireland, via Eire to England where he provided Remedy Process Support Services for the Coronation Oath Enforcement Authority.
7. Deal Frauds by Top Network Agents got Appointment Frauds + Glittering Careers for Corrupt Officers in exchange for Protection Frauds. A Deal Fraud by Cabinet Officer Mr Peter Mandleson got the office of Director of Public Prosecutions for Keir Starmer in exchange for Protection Frauds. Deal Frauds got Northern Ireland Judicial Office + Promotion Frauds for a Corrupt Lawyer in exchange for Court Frauds that financed Bad Debt Repayments to the Bank of Ireland. The Ruin Fraud against Disabled Mr David Barr got Endemic Corruption Proof against the Corrupt Northern Ireland Judge + Protection Fraud Network.
8. The Remedy Commitments + Sample Treason Claim + Negotiation Offer were Set Up Conditions for World War III Peace Plan Remedy Precedents that benefit Former MP Sir Jeffery Donaldson and everyone else.
