

Oral Representations Request for Peace Plan Leaders of Citizens Mr Pead and Mr Nkrumah

Need: *The World War III Peace Plan Leaders are managing a Corruption Remedy Process. The UK is the Remedy Test Case. It started in 2004. Research Investigations discovered that Endemic Corruption Managers had Total Control. Corruption Remedies needed International Support. In 2023, King Charles got International Support. It is the World War III Peace Agreement for Democratic States. The Peace Plan Leaders have managed Corruption Exposure. It is the Epstein Scandal + Mandelson Scandal + Starmer Scandal + UK Leadership Farce Scandal + Treason Deal Scandal + Iran War Frauds Scandal. They want Remedy Delivery. Endemic Corruption validates the Standard Procedure for Remedy Delivery. It is Dismissal Executions against the Judiciary by a United Parliament that gets Mass Outrage, and use of a Framing Fraud days later for Victim Identification and Case Remedies that are Outrage Mitigation. Remedy Co-operation by the Peace Plan States validates the Reverse Procedure.*

*The Set-Up Conditions are use of Fraud Proof for Known Court Fraud Findings + Victim Identification Findings by King Charles and the Parliament Sessions Court, and then Fraud Hearings.*

*They get Audio Records that are Trial Fraud Proof for Scandal Victims against Trial Judges or Remedy Proof for the Trial Judges against Endemic Corruption Managers.*

*The Trial Fraud Proof is Audio Records of the Scandal Victims making or attempting to make Oral Representations that get Remedy Denial Fraud Proof against the Trial Judges*

OR

*Fraud Finding + Victim Status Finding + Case Orders that is Remedy Proof for the Trial Judges.*

*Preferably both.*

Urgency: The Peace Plan Leaders prefer to have Remedy Proof from the UK Judiciary in time to influence the USA Voters in November 2026 and get a Treason Impeachment Majority in the USA Senate. It will get either Forced Remedy Co-operation from USA President Mr Trump or a Treason Impeachment against him.

Qualifiers: Fraud Findings + Victim Status Findings + Competent Advocate Findings by King Charles and the Parliament Sessions Court got Publicity Candidate Cases for the Peace Plan Leaders. Trial Listings for Candidate Cases get Publicity Qualification Cases for the Peace Plan Leaders.

Cases: Candidate Cases are the Harassment Framing Fraud 36CT2485825 in Norwich Crown Court + Assault Framing Frauds 2022 0043 + 2023 1180 in the Central Criminal Court

Hearing: The Candidate Case Hearing on 2<sup>nd</sup> and 6<sup>th</sup> July 2026 are Publicity Qualification Opportunities

Request: Citizens Mr Pead and Mr Nkrumah will please file Advance Notice of Prepared Oral Representations for the hearings on 2<sup>nd</sup> and 6<sup>th</sup> July 2026 and then get an Audio Records of them making or attempting to make Oral Representations for use as Scandal Publicity with Remedy Denial Fraud Proof against the Trial Judges.
