Let us make the best of what we have. The Common Law has given us Equity Governance. It needs Jurisdiction Separation and Risk Controls against use of Jurisdiction Offices by Chronically Immature Personalities.

Risk Control Failures enabled Chronically Immature Personalities to get High Office in the UK and USA that was needed for the Treason Deal. It got Big Bribes for USA President Mr Trump, Epstein File Concealment Frauds for the UK Cabinet, Defence Sabotage Frauds for Russia against Ukraine, Western Europe and NATO and Money Laundering Profits for Trump Family Members because State Officers and Trump Employees were an Exposure Risk.

Peace Plan Successes got Deal Failures: Epstein Scandal + Mandelson Scandal + Starmer Scandal + UK Leadership Farce Scandal + Treason Deal Scandal + Iran War Frauds Scandal.

Peace Plan Successes will get Remedy Delivery sooner or later. Endemic Corruption validates the Standard Procedure. It is Dismissal Executions against the Judiciary by a United Parliament and days later, use of a Framing Fraud Trial for Victim Identification and Case Remedies. Endemic Corruption Exposure validates the Reverse Procedure. It uses Framing Fraud Trials to get Victim Identification and Case Remedies that is Remedy Proof for the Judiciary.

The UK is the Corruption Remedy Test Case for the Peace Plan. Framing Fraud Cases with Hearing Dates on 2nd and 6th July 2026 are Qualifying Cases for the Reverse Procedure. The Oral Representations Request dated 1st July 2026 explains it. They will get Hearing Audio Records for Remedy Publicity or Trial Fraud Proof for Demonstration Dismissal Executions in July 2026 and the Summer Recess for Mass Dismissals.

Remedy Delivery in the summer of 2026 by the UK might influence the November Elections enough to get a Treason Majority in the USA Senate.

Let us prepare for Mass Remedies. It needs a Smooth Transition from Dictator Governance Frauds that serviced Market Frauds to a Just World Order. It needs use of the Common Law Integrity Controls.

One uses Fraud Proof for Justice Process Contempt Liability for the Fraud Victim against the Fraud Manager and the Fraud Beneficiary. It vests Blanket Remedy Powers in the Adjudicator for the Fraud Victim.

Another Integrity Control uses Fraud Proof of anything for a Proof Burden Reversal for the Remedy Process. It is a Fraud Presumption of Everything Else for the Fraud Victim against the Fraud Manager and Fraud Beneficiary subject to Rebuttal Proof Positive. Everything Else includes the Legislation + Regulation + Policy + Precedent that serviced Dictator Governance and Market Frauds.

Good Case Management for the Fraud Victim is a Settlement Incentive for the Fraud Managers and Fraud Beneficiaries. In 2011, the Corruption Remedy Process used a Fraud Liability Findings to force the UK Banks to allocate £8 Billion Remedy Budget for a Remedy Budget with Mass Advertising for Remedy Claims by Fraud Victims. It was a Test Case to discover whether it stopped Bank Frauds by Bankers and how much Remedy Claim Support the Fraud Victims. It did nothing to stop Bank Frauds by Bankers. It discovered that Remedy Claim Support was not enough for most Fraud Victims. They needed Remedy Claim Management. The Genuine Claims got the Case Evidence for Claim Frauds by Bankers. Bank Policy required Claim Records Retention for 3 years and then destruction. It enabled Corrupt Bankers to keep Claim Records and make Repeat Claim Frauds. In 2023, Peace Plan Commitment Deliveries by Japan and the USA got Remedy Enforcement against Fraud Profiteers that financed the Remedy Budgets for the Post Office Scandal and the Contaminated Blood Scandal. Costs Frauds by Corrupt Lawyers got Remedy Delays.

The Best Advice is a Test Case Plan. It needs It needs Negotiation Arrangements for Immunity Terms in exchange for Remedy Co-operation including Full Disclosure. It needs Repeat Claim Fraud Proof for Banks against Bankers + Lawyers and Remedy Denial Costs Fraud Proof for Scandal Victims against Scandal Defence Lawyers. Observe what happens. The Integrity Controls will get a Total Reversal from Remedy Denial Frauds to Justice Management.

The Sex Crime Entrapment + Faming Frauds got Blackmail Victims. Appointment Frauds for Blackmail Victims got Puppet Officers and a Reliable Supply of Fraud Services at No Profit Share Cost. Protection Frauds for Notorious Celebrities provided Protection Fraud Reassurance for Puppet Officers. In 1999, Murder Protection Frauds for Norfolk Police used the Murder Framing Fraud against Mr Tony Martin. The Sex Crime Protection Frauds motivated the 1st Ruin Fraud Series, and the Norfolk Murder Framing Fraud motivated the 2nd Ruin Fraud Series against Citizen Mr Pead. The Performance Enhancing Drugs Expansion Plan for Sports Professionals and Fitness Fanatics, and the Land Theft Expansion Plan for Network Agents against the State classified Citizen Mr Nkrumah as an Exposure Risk. They motivated the 1st and 2nd Ruin Fraud Series against him. They are Notorious Cases linked to the Mandelson Scandal.
