  - 4.3. A Remedy Management Investigation Order to identify the Fraud Managers and Fraud Beneficiaries and decide the Indemnity Obligations

1. The UK Protection Fraud Network that used Cabinet Office and the Judiciary to provide Protection Frauds for Crime Businesses managed by State Officers and Law Court Judges?
2. The Costs Control Policy of the UK Protection Fraud Network that used Sex Crime Entrapment and Sex Crime Framing Frauds to get Blackmail Victims. The use of Key Office Appointment Frauds for Blackmail Victims to get Puppet Officers and Reliable Fraud Services at No Profit Share Cost. The use of Sex Crime Protection Frauds for Notorious Celebrities to provide Protection Fraud Reassurance Proof for the Puppet Officers?
3. The Tobacco + Drug Crime Business of Top Police, Top Customs and Top Judges used Police Officers and Customs Officers as Local Distribution Managers. Top Drug Sales went with Protection Frauds that include Child Prostitution?
4. The use of Local Drug Wholesalers to provide Local Bribery Money Laundering Services?
5. The Business Expansion Plans for Court Frauds on an Industrial Scale?
6. The Case Management Research to discover what was needed for Industrial Scale Court Frauds?
7. The Research Discovery that Industrial Scale Court Frauds needed a change from Honest Business Systems that serviced the identification and remedy or problems with Corrupt Business Systems that service Evidence Exclusion Frauds needed to get Protection Frauds from the State and Law Courts?
8. The replacement of Honest Business System Standard with the Corrupt Business System Standard?
9. The use of the Corrupt Business Standard by UK Authorities?
10. The use of Fundamental Flaws in Design Requirement Specifications for Doomed Business Systems to get Development Budgets that finance Top Level Bribe Payments and then used Development Failures to get Records Destruction of everything that serviced the Bribe Payments?
11. The Land Frauds Business Expansion Plan:
  - 11.1. Stage 1: Land Frauds for Big Owners against Small Businesses
  - 11.2. Stage 2: Land Thefts for Network Agents against the State
12. The Land Fraud Business Expansion Test Cases that got Fraud Services from the Land Registry?
  - 12.1. Test Case 1. Minium Value Land Theft by Corrupt Officers against the State [Hackney Council]. It used a Long Lease Sale Pretence Fraud + Council Tenancy Discount Fraud and the Lease Details Fraud as a Test Case to get a Leasehold Title Registration Fraud by the Land Registry using: Date 1986 + Lessor [Hackney Council] + Lessee + Address: 7 Barclay House, Well Street, London E9 7RA. Immediate Marketing that got the Sale Fraud in 1987 that needed a Good Title Certification Fraud by the Buyer Lawyers against Victim Buyer Mr Lee Cant and Mortgagee and Within 3 Years Discount Forfeit + Repayment Obligation. Maintenance Account Frauds that Mr Cant documented for 39 years from 1987 until he died in 2026. The Missing Lease + Maintenance Account Frauds got Unsaleable Status for the Registered Title. Mr Cant and

Hackney Council could not rid themselves of the Registered Title or each other. The Council used Repeat Maintenance Enforcement Frauds + Repeat Costs Frauds to get Charge Frauds against the Unsaleable Title but dare not get Possession Frauds because it would expose All Frauds from 1986 to the Sale Effort Date. The Fraud Proof Set is the Lee Cant Legacy?

- 12.2. Test Case 2. Middle Value Land with Ransom Strip Value for about 1,500 acres. The construction of the line from Chester to Birkenhead got Spoil Deposits on a narrow piece of land at Capenhurst Railway Station. The shape and size limited its use to Small Scale Waste Disposal. A Business Licence got use of it for Road Stone Recycling + Metal Recycling + Connected Works Processing for Mr Bob Davies and Valued Revenue + Off Loaded Nuisance Management for Railway Managers. The preparations for Railway Privatisation included Redundant Land Disposals. Rail Managers were given a Disposal Timetable. They needed to avoid a Sale Failure. They were pleased to make a Private Sale to Mr Davies. Corrupt Officers made a Business Plan. It needed Private Sale Sabotage Frauds + Auction Purchase to get Railway Sidings Ownership + Planning Conditions that required Extra Car Parking got Ransom Strip Value. The Private Sale Sabotage Fraud used Service Negligence by the Regulated Lawyer that missed the Contract Exchange Date and got an Auction Sale. The Corrupt Officers had True Price X 3. Mr Davies was furious, outbid them and used the Price Increase for a Negligence Claim that got Fraud Proof against the Buyer Lawyer. Dispossession Frauds Conspiracies by Corrupt used every combination of Legal Action and Fraud Agents. Competent Case Management by Mr Davies delayed Possession Fraud Completion for about 35 years. The Fraud Proof Set is the Bob Davies Legacy?
- 12.3. Test Case 3 High Value Land Theft for Network Agents against Successful Immigrant Twin Brothers, Cyril and Claude Rapose. They acquired the row of buildings across the road from Earlsfield Station. They were worth about £6,000,000 when the Theft Conspiracy Started in or about 1989. Corrupt Officers used every combination of Legal Action and Fraud Agent for Dispossession Frauds. Competent Case Management by the Rapose Twins delayed Fraud Completion for about 30 years until a Compulsory Purchase Pretence Frauds got a Title Transfer Fraud by the Land Registrar. The Fraud Proof Set is the Rapose Twins Legacy?
13. In 1997, the General Election Landslide Majority got the Premier Office for MP Mr Blair and Cabinet Officer for Network Agent Mr Peter Mandelson. He used it for a Network Business Expansion Plan. It was Performance Enhancing Drugs for Sports Professionals and Fitness Fanatics.
14. In 1999, Murder Protection Frauds for Norfolk Police used the Victim's Body for a Murder Framing Fraud against Mr Tony Martin, who died in 2026. Corruption Outrage forced an Early Release Plan. It used Diminished Capacity Trial Issue Waiver Fraud for a Conviction Change from Murder to Manslaughter + Early Release?
15. In 2004, the preparations for the European Referenda got Election Fraud Conspiracy Proof against European Leaders. The Election Fraud Concealment Plan got Criminal Conspiracy Proof against them. Equity Lawyer Mr Ellis and Queen Elizabeth used it to revive active service of the Coronation Oath Enforcement Authority and start a Corruption Remedy Process. It used Research Investigations to discover the structure and strength of the Protection Fraud Network that managed Endemic Corruption. Remedy Delivery needed Dismissal Executions against the Judiciary by a United Parliament, Victim Identification, Case Remedies and the World War III Peace Agreement for Democratic States and a Just World Order?
16. In 2006, Corruption Proof got a Forced 10 Month Resignation from Prime Minister Mr Blair. A Leadership Contest Deal got Support Votes from Prime Minister Mr Blair for Candidate Mr Brown and Cabinet Office + Ennoblement Fraud for Network Agent Mr Peter Mandelson. He used it for Network Business Expansion Plans. One was Land Frauds Stage 1. Another was the Blackmail Business. It used Blackmail Expertise got by the Costs Control Policy, Sex Crime Minimum Sentence Frauds from the USA Authorities for Mr Epstein to get Hosting Services from Mr Epstein, Blackmail Service Contracts from World Top Financiers against the Accountants, Lawyers and Managers of Takeover Targets and Election Campaign Contributions that got Protection Frauds?
17. In 2006, a Sex Complaint by a Disabled Teenager got an Investigation Reference to Headmaster Mr Brian Pead. It was a Corruption Exposure Risk that motivated the 1<sup>st</sup> Ruin Frauds against him from 2006 to 2012 when they stopped because of Jim Saville Scandal. In 2013, Mr Pead met Mr Martin and wrote the book Murder Hoax. It motivated the 2<sup>nd</sup> Ruin Fraud Series from 2013 that continue in 2026?
18. In 2016, the European Referenda Leave Majority got an Honourable Resignation from Prime Minister Mr Cameron. Leadership Frauds got the Premiership for Mrs May, and Land Frauds Stage 2 by Lord Mandelson. It used many thousand Forged Council Tenancies. Forgery Complaints by Citizen Mr Nkrumah were an Exposure Risk that motivated a Ruin Fraud Conspiracy against him?
19. In 2023, King Charles used the Endemic Corruption Proof against the Judiciary to negotiate the World War III Peace Plan for Democratic States. The UK is the Corruption Remedy Test Case. The Peace Plan States have Interested Party Status.
20. Citizens Mr Pead and Mr Nkrumah have agreed Case Management that enables use of their cases as Demonstration Cases by Peace Plan Leaders?
