#### Justice Process Fraud Contempt Allegations Schedule

1. All Authorities developed Standard Corrupt Practices. Local Authorities used Council Tax Liability Order Forgeries for Enforcement Frauds.
2. In 2004, the preparations for the European Constitution Referenda got Election Fraud Conspiracy Proof against European Leaders They wanted Inconsistent Things. They wanted Referenda Acceptance of Dictator Powers. They needed Dictator Power Concealment Frauds to get it. They wanted Blackmail Powers for State Officers with Financial Asset Loss Threats using Electronic Signature Dictator Powers to get Immediate Absolute Obedience from the Citizen. Blackmail Powers Exposure would get a choice between Dictator Powers for the State and Financial Security for the Voter and a Landslide Rejection of the European Constitution. The Lawful Business of UK Citizens made inevitable exposure of the Election Frauds. The European Leaders made an Election Fraud Concealment Plan. It used Sabotage Frauds against the Lawful Business. They were Drug Crime Framing Frauds + Imprisonment Frauds against two Lawful Business Managers. One was a Netherlands Citizen and the other a UK Citizen. They used Netherlands Judge Trial because UK Jury Trials were an Exposure Risk. They did not have an Extradition Treaty or time to make one. The 1<sup>st</sup> Election Fraud Concealment Effort used Armed Netherlands Police on UK soil to supervise UK Customs and Kent Police for a Kidnap Extradition Fraud against the UK Citizen. The EU Leaders and the Netherlands Investigators did not know that a complex series of events had discovered the UK Citizen would have nothing to do with drugs for profit, when threatened with violence or under police supervision. It got Incredible Target Status for him in Drug Investigations. Top Police, Top Customs and Top Judges were the Top Drug Dealers. They used the addresses of the UK Citizen on the Carrier Movement Records for more than 70 Drug Shipments. They did so because, if anything went wrong, the Incredible Target Status would ensure the Decoy Address Enquiries would get dead End Results. UK Customs knew a Crime Complaint by the UK Citizen got the Incredible Target Status. The knew that All States had used Kidnap Extradition Frauds. It was the first Joint European Kidnap Extradition Fraud. They did not believe that is what it was. They believed he had discovered the Decoy Address frauds, made a Crime Complaint and was assisting a Decoy Address Fraud Investigation. They

made a Decoy Address Fraud Investigation Sabotage Plan. It used News Coverage of a Big Drugs Bust and International Co-operation and then a Powers Usurpation for Investigation Sabotage Frauds. The UK Citizen was in a UK Prison with UK Jury Trial Rights and an Investigation Record that was Innocence Proof for him and Guilt Proof against the Case Investigators. It exposed the Protection Fraud Network that used Cabinet Office and the Judiciary to provide Protection Frauds for Crime Businesses by State Officers and Law Court Judges. The 2<sup>nd</sup> Election fraud Concealment Effort got Immunity Frauds for the Top Drug Dealers, an Extradition Treaty for the UK and Netherlands, the 1<sup>st</sup> Extradition Arrest Warrant that was against the UK Citizen, a Network Business Profit Share for Prime Minister Mr Blair, Cabinet Control for the Protection fraud Network, Criminal Conspiracy Proof against a serving Prime Minister, use of it by Equity Lawyer Mr Ellis and Queen Elizabeth to revive active service of the Coronation Oath Enforcement Authority and a Corruption Remedy Process for the People.

3. The Corruption Remedy Process needed Research Investigations to discover the structure and strength of the Protection Fraud Network. It included use of the Extradition Fraud Proof + Imprisonment Fraud Proof and the Commonwealth Conference for Remedy Co-operation Tests of World Leaders that got 40,000 Political Prisoner Releases worldwide. The Standards Procedure for Remedy Delivery is Dismissal Executi9ons against the Judiciary by a United Parliament, Victim Identification, Case Remedies and the World War III Peace Plan for Democratic States to get a Just World Order. A Parliament Unity Failure gets a Special Procedure. It uses Endemic Corruption Proof against the Judiciary to get the World War III Peace Agreement, and uses of it for Support Services from World Leaders for Dismissal Executions against Corrupt UK Leaders.
4. Remedy Co-operation between 2010 and 2015 by Prime Minister Mr Cameron, Deputy Prime Minister Mr Clegg and Opposition Leader Mr Miliband validated Remedy Delivery Conditions with a Test Case Year in the 2015 Parliament Session Grant. The European Referenda Commitment got an Election Victory for Prime Minister Mr Cameron. He wanted to avoid Corruption Exposure got by Remedy Delivery increasing the Leave Vote. He used the Test Case Year for the European Referenda, led the remain Campaign, lost and resigned. It was an Honourable Resignation. The Protection Fraud Network bought Support Votes for Leadership Candidate Mrs May because she was a Network Agent. It got Remedy Delivery Delay that has lasted 10 years to date. The Remedy Process needed New Proof Sets. In 2019, they got the Forced Resignation from Prime Minister Mrs May and the Parliament Dismissal that got the Forced Winter General Election.
5. In 2021, the Parliament Session Grant had Remedy Delivery Conditions. Remedy Failures were Condition Breaches that got Fraud Findings against the Cabinet and the Default Dismissal Penalty against Prime Minister Mr Johnson. Dismissal Failures got Fraud Findings against Opposition Leader Sir Keir Starmer and Parliament
6. Profession Governance Frauds by the General Osteopathic Council against Citizen Ms Davies got Corruption Complaints by Citizen Ms Davies, a Corruption Investigation by the Coronation Oath Enforcement Authority and Corruption Investigator Status for Equity Lawyer Mr Edward Ellis. In 2023, Bribery Management by Lord Peter Mandelson for the General Osteopathic Council and Pharmaceutical Industry got Osteopath Misdescription Trial Frauds from the Supervision Judges and Case Judges of Worcester Criminal Courts. Judge Mr Salmon sat as Crown Court Plea Hearing Judge. The Crown Court Appeal Judges used Court Officers and West Mercia Police for the Assault Framing Fraud 22CA1074323 against Equity Lawyer Mr Ellis to stop him attending as Legal Assistant and Jurisdiction Witness. The Court Room was the Crime Scene, and the Audio Record were Event Proof. Good Case Management by the Equity Lawyer got Confidence Collapses by Court Officers. Budget Fraud Complaints by Citizen Ms Davies got Remedy Denial Fraud Proof against All Relevant Authorities and use of the Fraud Proof for a Council Tax Payment Refusal by Citizen Ms Davies. It got the Council Tax Liability Forgery Proof for the Citizen against Worcester Council. Enforcement Frauds got Competent Resistance that enabled the Tax Fraud Proof to service the Peace Plan. In 2026, Bankruptcy Fraud Enforcement Order from Prime Minister Sir Keir Starmer the Council Tax Enforcement Bankruptcy Petition 2026 0012 of Worcester City Council and the Justice Perversion Contempt Fraud Response Case of Citizen Ms Davies got Bias Fraud Proof + Appeal Process Denial Fraud Proof for her against Worcester County Court. The Leadership Contest Farce Fraud got a Confidence Collapse + Conflict Disqualification Admission + Appeal Issue Denial Fraud + Appeal Papers Return Fraud by the Judge Mr Salmon.
7. Meanwhile, Crime Evidence Offers by Citizens against Top Network Agent Mr Mandelson got Protection Fraud against All Relevant Authorities. The 22CA10974323 Original Frauds and a Bench Warrant Forgery Arrest Fraud against the Equity Lawyer get Trial Denial Fraud Proof against Worcester Magistrates and Chelmsford Crown Court Judges.
