Wrongs:

1. The Statutory Demand Revocation Application 2026 0012 Refusal Fraud dated 03/03/2026 by Deputy District Judge Redmond got Appeal Jurisdiction to the Circuit Judge. The Fraud Appeal dated 13/03/2026 got a Case Allocation + Conflict Jurisdiction Disqualification + Remedy Only Jurisdiction Limit for Judge Salmon because he managed the Plea Hearing Frauds on Osteopath Misdescription Trial 2022 0062 in the Crown Court. It got Conflict Jurisdiction Qualification Frauds + Appeal Process Denial Frauds until a Confidence Collapse got a Conflict Disqualification Admission + Admission Proof Denial Fraud + Remedy Denial Frauds evidenced by the Conflict Notice + Appeal Return + Fee Return Denial Fraud + High Court Appeal Filing Proposal Fraud with County Court Fee Payment Notice evidenced by the letter dated 18th June 2026 from the County Court

6. Investigations Resource References to Parliament for Citizen Ms Davies and the World War III Peace Plan States
7. Pending Remedies Enforcement Stay Protection + Order Breach Contempt Penalty Warning for Citizen Ms Davies against the State in general and Worcester City Council in particular
8. Remedy Investigations + Protection Publicity Order for Citizen Ms Davies + All Relevant Witnesses against Worcester City Council and the Ministry of Justice
9. Relevant Witness Status Presumption for All Individuals against the State subject to Rebuttal Proof Positive
10. Publicity Accountability + Remedy Investigation Directions Hearing at noon on 31st July 2026

Reasons:

1. The Court has Case Records and Judicial Knowledge that are Justice Process Fraud Conspiracy Proof. It got Fraud Victim Status Proof for the Citizen Ms Davies and Fraud Manager Status Proof against Worcester City Council Officers and Ministry of Justice Officers + Fraud Beneficiary Status Proof against Worcester City Council and the Ministry of Justice.
2. The Court has Judicial Knowledge of the World War III Peace Plan got Corruption Remedy Test Case Status for the UK, Test Manager Status for the UK Coronation Oath Enforcement Authority, Interested Party Status for the Peace Plan States and Common Law Governance for a Just World Order
3. The Peace Plan needs discovery whether the Premier Office Transfer from Sir Keir Starmer to Mr Andy Burnham gets Victims Identification and Case Remedies by the Law Courts and Budget Fraud Test Cases + Common Law Training Material for the Peace Plan Leaders.
