1. Invalidity Allegation Finding + Validity Investigation Order for Citizen Ms Davies against Worcester City Council.
2. Discovery Order for Citizen Ms Davies against Worcester City Council that the Chief Executive, Chief Lawyer and Chief Tax Collector do within 7 days file and serve Statements that respond to the case that the Council Tax Enforcement Bankruptcy Petition 2026 0012 of Worcester Council vested in the County Court the Conflict Jurisdiction and the Response Case needed to decide:
  - 2.1. whether the Council Tax Liability Orders are the Crime Proceeds of Forgery + Perjury + Justice Perversion Fraud that get Fraud Victim Status for Citizen Mrs Davies + Fraud Manager Status for All Relevant Council Officers + Fraud Beneficiary Status for Worcester City Council + Contempt Remedy Rights for Citizen and
  - 2.2. whether the Statutory Demand Fraud Revocation Application 2026 0012 + Remedy Denial Fraud dated 03/03/2026 by District Judge Redmond + Revocation Denial Fraud Appeal Grounds and Notice dated 13/03/2026 + Conflict Qualification Fraud and Remedy Only Jurisdiction Limit Denial Fraud and Case Process Denial Frauds committed by Judge Salmon because of the Plea Hearing Frauds by him in Osteopath Misdescription Appeal 2022 0062 until the Confidence Collapse evidenced by the Conflict Disqualification Admission + High Court Appeal Reference Fraud evidenced by the letter dated 18/06/2026 from the Council
  - 2.3. whether the Council Tax Summon Forgery dated 22/06/2026 got Pending Remedies Protection Breach Contempt Liability for Worcester City Council and All Relevant Officers
  - 2.4. whether the Profession Governance Frauds + Court Frauds + Taxation Frauds that validate Test Case Budget Fraud Investigations + Test Indemnity Cases for the World War III Peace Plan States
3. Validity Investigation Directions Hearing at noon on July 2026

REASONS: The Context – UK Corruption Remedy Process

1. In 2004, the preparations for the European Referenda got Election Fraud Conspiracy Proof against European Leaders including Prime Minister Mr Blair. The Lawful Business of UK Citizens made inevitable exposure of the Election Frauds. The European Leaders made an Election Fraud Concealment Plan. It used Sabotage Frauds against the Lawful Business. They were Drug Crime Framing Frauds + Imprisonment Frauds against two Lawful Business Manages. Everything that could go wrong for the European Leaders did go wrong. It got Criminal Conspiracy Proof against them. Equity Lawyer Mr Edward Ellis and Queen Elizabeth used it to revive active service of the Coronation Oath Enforcement Authority and start a Corruption Remedy Process. Research Investigations discovered the Protection Fraud Network used Cabinet Office and the Judiciary to provide Protection Frauds for Crime Businesses managed by State Officers and Law Court Judges. It got Endemic Corruption. The Standard Procedure for Remedy Delivery is Dismissal Executions against the Judiciary by a United Parliament, Victim Identification, and an International Agreement for a Just World Order. A Parliament Unity Failure gets a Special Procedure. It uses Endemic Corruption Proof against the Judiciary and Budget Fraud Damage to get the International Agreement, Corruption Remedy Test Case Status for the UK, Test Case Manager Status for the Coronation Oath Enforcement Authority and International Support for Corruption Exposure to get Power Transfers to a Parliament that manages Remedy Delivery.
2. The Corruption Remedy Process needed Investigation Discretion. There was Mass Publicity for Remedy Process Successes without disclosure that is what they were. Most people did not know about the Coronation Oath Enforcement Authority or the Corruption Remedy Process.
3. Equity Lawyer Mr Ellis provided Investigation Services for the Coronation Oath Enforcement Authority. He recruited Citizens, provided Case Management Services. He used the truth, whole truth and nothing but the truth of the case facts for Integrity Tests of the Authorities. They got Proof Sets that met the Corruption Remedy Proof Standard. It is Official Records that are Justice Proof for Honourable Officers or Guilt Proof against Corrupt Officers and Credibility Irrelevance Proof for the Victim

The Context: The World War III Peace Plan for Democratic States

4. Russia and China made a World War III Plan: 2021 Ukraine Invasion + Blitzkrieg Success + Arms Stock Exhaustion by NATO + Cyber Attack Sabotage against Arms Replacement + Dictated Peace Terms that bled the

Democratic States. The Defence Plan needed to avert a Total Collapse of the Democratic States. The Blitzkrieg Failure + Arms Stock Exhaustion Failure was a Plan Failure for Russia and China. They made a Plan Revision: a Bought Raid by Hamas against Israel + 250 Hostages for Response Crippling + War Escalation. The Raid Response was Ignore Hostage Safety + Demand Hostage Returns + Massive Bombardment including Hostage Prisons + World War III Taunts of Middle Eastern States that deterred War Escalation. The Democratic States needed a World War III Leader.

5. Meanwhile, in 2021, Corrupt Judge Dismissal Failures got Remedy Denial Fraud Findings against the Cabinet and the Default Dismissal Penalty against Prime Minister Mr Johnson. The Premier Dismissal Failure got Remedy Denial Fraud Findings against Opposition Leader Sir Keir Starmer and Parliament. It created the need for the Special Procedure to get International Support for Corruption Remedies.
6. World War III made got Absolute Priority for a Democratic States Peace Plan. It needed Endemic Corruption Proof against the Judiciary that got Budget Fraud Proof for the Cabinet. The Peace Plan Negotiations needed to make the best of the Osteopath Profession Governance Fraud Debate. It was Problem Admission Proof that got Remedy Denial Frauds Proof against every Parliament since 2000. Also, it needed Liability Fraud Proof + Enforcement Fraud Proof Contempt in which Top Judges were responsible for all major decisions.

Citizen Ms Davies + New Fraud Proof against the General Osteopathic Council

7. A Patient Satisfaction Internet Publicity Prohibition by the General Osteopathic Council was a Market Fraud for Market Competitors against Registered Osteopaths. Market Fraud Complaints + Conflicted Interest Denial Frauds + Remedy Only Jurisdiction Limit Denial Frauds + Conflict Jurisdiction Qualification Frauds were used by the General Osteopathic Council for a Mental Illness Presumption Fraud + Pending Investigation Practice Suspension Fraud against Citizen Ms Davies. Citizens informed her about the Coronation Oath Enforcement Authority and Corruption Remedy Process and referred her to the Equity Lawyer. He provided Case Management Services. Fraud Remedy Action by the Citizen got Court Fee Extortion Proof + Process Denial Fraud Proof against the High Court.
8. The Osteopath Profession Unfitness 2855 139 Disqualification Fraud enabled the Osteopath Misdescription Crime Prosecution Fraud by the General Osteopathic Council against the Citizen. Bribery managed by Lord Peter Mandelson for the General Osteopathic Council and the Pharmaceutical Industry got the 22 00069636 Trial Frauds by Worcester Magistrates Court. Bribery managed by Lord Mandelson got the 2022 0062 Appeal Frauds in Worcester Crown Court. The Appeal Judges used Court Officers for Court Room Exclusion Frauds against the Equity Lawyer to stop him serving as Defence Assistant and Jurisdiction Witness. The Court Room was the Crime Scene and the Audio Records Event Proof. Competent Case Management by him got Assault Complaint Fraud by Court Officers and 22CA1074323 Arrest Fraud + Investigation Frauds by West Mercia Police
9. Meanwhile, the Contempt Cases 2022 002595 + 003098 of the Equity Lawyer and Cabinet in the High Court and Fraud Appeal 2023 000569 + 0174 of the Equity Lawyer in the Court of Appeal and Supreme Court got Liability Fraud Proof + Enforcement Fraud Proof against Top Judges. It completed the Endemic Corruption Proof Set against the Judiciary. King Charles used it to negotiate the World War III Peace Plan for Democratic States. He functioned as World War III Leader for Democratic States.
10. The Peace Agreement required Sovereign States to destroy the Protection Fraud Networks that manage Endemic Corruption, recover control of State Budgets, resource World War III Defences and resource a Just World Order. The Management Agreement got Test Case Status for the UK, Test Manager Status for the UK Coronation Oath Enforcement Authority, Interested Party Status for Peace Plan States and the Common Law for the Top Corruption Controllers of Peace Plan States. The Remedy Agreement got Remedy Enforcement against Fraud Profiteers and Penal Enforcement against Corrupt Leaders. The Delivery Agreement got Delivery Commitments, some of which were conditional. The Publicity Agreement got Whole Plan Secrecy and Mass publicity for Plan Stage Successes without disclosure that is what they were, until there were enough for Whole Plan Publicity.
11. The Case Histories validated Budget Fraud Complaints that got Remedy Denial Fraud Proof for the Citizen against All Relevant Authorities. The Council Tax Payment Refusal Protest by the Citizen discovered Council Tax Liability Frauds + Enforcement Frauds by the Council got Budget Fraud Victim Status for the Cabinet.
12. Protection Frauds got Victim Status Forfeits against Previous UK Cabinets. Remedy Delivery by the UK Cabinet of Prime Minister Mr Burnham will get Victim Status Revival + Budget Fraud Remedy Test Cases for the World War III Peace Plan.
