The Equity Governance Recovery Plan needed Jurisdiction Separation that denied Central Control. It created the need for Remedy Intent Notices from Any Jurisdiction to All Other Jurisdictions and then Remedy Delivery.

The Endemic Corruption Manager need Identity Sacrifice to achieve Remedy Intent. Few manage it. Some used False Remedy Intent Notices but the Remedy Failures revealed that is what they were.

The Disability Budget Fraud Remedy Commitments by Prime Minster Mr Burnham is either a False Notice or a Remedy Intent Notice.

The Common Law starts a Just Process with a Validity Presumption for the Citizen and Credibility Presumption for the State both of which are subject to Rebuttal Proof Positive.

Let us make the Risk Decision to ignore Internet Publicity that might be Rebuttal Evidence, give him a Remedy Intent Proof Period and prepare to make the best of it.

The document entitled World War III Peace Plan + Remedy Proposal for a Budget Fraud Success to trigger a Remedy Co-operation Wave dated 13th July 2026 serves the purpose.

Polite Request for Cuning Plan Gossip and Remedy Successes and anything else to trigger a Corruption Remedy Wave.

The Tax Claim Fraud 2600026217 Hearing on Harassment Framing Fraud 36CT1485825 Hearing on 28th July 2026 are Remedy Co-operation Opportunities for the Magistrates Court and the Crown Court. Citizen Ms Davies and Citizen Mr Pead have Peace Plan Representative Status in those cases. The Case Documents do the work.

They have 2 Valid Choices. One is a Hearing Appearance. The other is an Appearance Refusal.

Polite Request for a Hearing Appearance by Citizen Ms Davies and a Hearing Report from her.

Polite Request for a Hearing Appearance by Citizen Mr Pead to get the Audio Record + Hearing Report from him.

Both Cases got Excellent Material for Ridicule Publicity and Budget Fraud Investigations.

Meanwhile, the Equity Lawyer will prepare Budget Fraud Claim Precedent for Citizens against the Cabinet + Former Prime Ministers Mr Blair + Mr Brown + Mrs May + Mr Johnson + Ms Truss + Sir Keir Starmer + Their Attorneys General. The Remedy Applications will include Indemnity Liability Orders for the Cabinet against the Former Prime Ministers.

Precedent Claim Priority Notice for Citizen Mr Nkrumah. REASON: Citizen Mr Pead does not have a Local High Court and needs Charity Donations for Travel Costs. Citizen Mr Nkrumah lives in London, can afford the Travel Cost to the Royal Courts. He can make an Urgent Interim Remedy Application for Pending Remedies Enforcement Stay Protection for himself, Citizen Mr Pead and All Other Witnesses against the State.
