Grateful Thanks for the Peace Plan Agreements and the Plan Stage Successes so far. They needed Resource Management that provided Remedy Belief in Viable Quantities to develop the Plan Idea, negotiate the Plan Agreement and service Plan Stage Successes.

The Plan Agreement got Corruption Remedy Test Case Status for the UK, Test Manager Status for the Coronation Oath Enforcement Authority and Test Results that were Corrupt Governance Proof that needed Dismissal Executions against Prime Ministers Mrs May, Mr Johnson, Ms Truss, and Sir Keir Starmer. It got Premiership Test Conditions for Mr Andy Burnham in which, hopefully, everyone in Parliament wants to avoid Another Corruption Dismissal Process.

The Plan Success so far is a Perversity Confidence Collapse by the Corrupt Governors. The Plan Challenge is Change Management from the Perversity Confidence Collapse to Justice Confidence Recovery and use it for a Just World Order.

The Test Case Managers have a Massive Advantage. It is the Resource Management needed to get the Plan Agreement and Perversity Confidence Collapse. It will service the Change Management. It needs an end to Budget Frauds and use of Budget Savings for Just Management.

It needs three things. It needs Budget Fraud Recognition + Budget Fraud Deterrent Penalties + Recovery Successes.

Budget Frauds have Perversity Drivers. The Common Law provides Perversity Classifications. They are Incapacity, Incompetence, Carelessness, Recklessness and Malice.

Budget Fraud Perversity Drivers deliver Unjust Enrichment of some and Unjust Impoverishment of others. The Unjust Enrichment of Waste Frauds is False Credibility for the Waste Managers. The Unjust Enrichment of Plunder Frauds is Fraud Benefits. They are either Fraud Profits for some or Fraud Losses for others or both.

The Dictator Governance Plan was a Governance Fraud. It needed a Priority Reversal for Perversity Management against Justice Management. A High Recognition Requirement is the Key Quality needed for Governor Status. The easiest way to get Recognition Satisfaction was to service Perversity Management. Many who did so knew it was a Doomed Governance Model. They did not have the Remedy Belief needed to manage Governance Doom Remedies. They did what they could to get Recognition Satisfaction. Some understood it was Remedy Failure but did not know what to do about it. All of them were on a Guilt Spectrum. It ranged from Intense Guilt to Total Apathy. Intense Guilt got Personal Stress for whoever had it. Some of the Personal Stress did Stress Damage to others. Total Apathy got No Stress for whoever had it and Stress Damage for everyone else.

The Common Law provides Remedy Methods. The Standard Method uses Problem Acknowledgement + Remedy Opportunities for whoever has Remedy Powers to get Voluntary Remedies. A Voluntary Remedy Failure creates the need for a Special Method for Forced Remedies. Voluntary Remedies have a Contagious Potential. It can create a Remedy Wave that reduces or eliminates the need for Forced Remedies.

The Remedy Managers have a Cunning Plan. It has worked in the past. It can work again. In 2004, the preparations for the European Referenda got Election Fraud Conspiracy Proof against Europe Leaders. The Lawful Business of UK Citizens made inevitable exposure of the Election Frauds before the 2005 Referenda. The European Election Fraud Concealment Plan used Drug Crime Framing Frauds + Imprisonment Frauds against two Lawful Business Managers. Everything that could go wrong for the European Leaders did go wrong. Equity Lawyer Mr Ellis and Queen Elizabeth used the Criminal Conspiracy Proof to revive active service of the Coronation oath Enforcement Authority. Political Prisoner Trafficking Findings by the Parliament Session Court enabled Queen Elizabeth and Charles, Prince of Wales to use the Commonwealth Conference and the Cunning Plan to get Remedy Co-operation from World Leaders. Most People find Wrong Exposure against others easier than Wrong Admissions by themselves. World Leaders are the same. Wrong Exposure against the European Union and USA that got 40,000 Political Prisoner Releases was easy. It was a Remedy Wave with a Narrow Focus. The Corruption Remedy Process needed Research Investigations to discover the structure and strength of Endemic Corruption Managers, get Confidence Collapses against New Corruption and then Confidence Collapses + Dismissal Executions against Top Corruption Managers as Set Up Conditions for a Remedy Wave. It needs Cunning Plan Gossip + Deterrent Precedents + a Budget Fraud Remedy Trigger and a Remedy Wave.

The Ruin Fraud Series against Citizen Mr Nkrumah got Excellent Material for Deterrent Precedents. They are Unfitness Ridicule + Career Damage + Budget Fraud Liability. The Framing Frauds 20220043 + 2023 1180 Trial Records are Case Closure Fraud Conspiracy Proof that is Ridicule Material against All Relevant Judges.

The Disability Budget is as good a place to start as any. It got a Priority Decision from Prime Minister Mr Burnham. Budget Reallocations for Employment Support has potential to trigger a Budget Fraud Remedy Wave + General Justice Remedy Wave. The Tax Claim Fraud 2600026217 in Worcester Magistrates Court and the Harassment Framing Fraud 36CJ2485825 in Norwich Crown Court have hearings on 17th and 28th July 2026 that will get Ridicule Material or Remedy Co-operation.
