Justice Process Contempt Damage Limitation Reasons

1. Bribery Management by Lord Peter Mandelson got the Osteopath Profession Unfitness Case 2855 139 by the General Osteopathic Council + Osteopath Mis-description 2200069636 Trial Frauds by the General Osteopathic Council and Worcester Magistrates Court + Appeal 2022 0062 Retrial Frauds by the General Osteopathic Council and Worcester Crown Court. The Worcester Judges knew that the Coronation Oath Enforcement Authority is the Profession Authority of Parliament, Equity Lawyer Mr Ellis provided Investigation Services for the Coronation Oath Enforcement Authority, Lord Peter Mandelson was a Corruption Investigation Target and Citizen Ms Davies had given him use of her cases. His attendance as Legal Assistant and Jurisdiction Witness at the 2022 0062 Plea Hearing got Validation Investigation Denial Fraud Proof against Judge Salmon. Investigation is needed to discover whether that got an increase in Retrial Bribes. The Retrial Judges issued Court Room Exclusion Fraud Orders against the Equity Lawyer. Ideal Management needed an Unofficial Agent to stop the Equity Lawyer reaching the Court Building. Good Management needed the Contact Event using a Security Officer to deny entry to the Court Building, or if that failed, deny entry to the Court Room. It did not get Ideal Management or Good Management. It got Bad Management with the Contact Event in the Court Room. It got Crime Scene Status for the Court Room and Event Evidence Status for the Audio Records that were Court Room Exclusion Fraud Proof + Legal Assistance Denial Fraud Proof. The Public Gallery was not in the Court Room but viewed it from above. It had a separate entrance. The Retrial Judges issued a Public Gallery Exclusion Order Fraud. A Court Officer stood in the Court Room. The Court Officer gave a Public Gallery Vacation Order. It got a Vacation Refusal by the Equity Lawyer. He did what he could to explain the General Rule is that Citizen has Trial Observation Rights from a Public Gallery. There is a Rule Exception if the Citizen has Fact Witness Status. It is a Risk Control against Evidence Changes. The Rule Exception does not apply to Jurisdiction Witnesses because Official Records are the Jurisdiction Facts and cannot be changed.
2. The Audio Record will discover how much of the Vacation Refusal Reason was explained before West Mercia Police committed Public Gallery Criminal Trespass for an Assault Arrest Fraud against the Equity Lawyer. The Citizen has Court Process Observation Rights. The Public Gallery is the Observation Facility. State Officers need either a Personal Invitation from the Citizen or a Court Order to enter the Public Gallery. If they accept a Personal Invitation, they surrender State Powers and enter as Citizen. West Mercia Police did not have a Personal Invitation or Court Order. They committed Criminal Trespass by entering the Public Gallery. The Arrest Fraud is the Crime Proceeds of an Assault Complaint Fraud 22CA1074323 by Court Officers + Criminal Trespass by Police Officers. The Arrest Fraud + Custody Fraud removed the Equity Lawyer from the Public Gallery part of the Court Room. The Audio Records are Fraud Proof against the General Osteopathic Council Prosecutor and the Appeal Re-Trial Judges. The Court Room Audio Records + Body Cams + Police Custody Reception Audio Records + Interview Records Audio Records are Kidney Failure Vulnerability Proof + Fraud Notice Proof + Budget Fraud Proof for the Equity Lawyer against West Mercia Police. The 22CA1074323 Investigation Records + Charge are Fraud Conspiracy Proof against West Mercia Police + Crown Prosecution Service.
