Chief Administration Officers of the Crown Courts at Snaresbrook + Central Criminal Court do within 7 days file and serve Statements that explain the Case Management so that it be used to discover whether the Investigation Resource Case Reference to Parliament gets Case Management that is Fraud Ownership Proof against the Cabinet and Parliament

REASONS:

1. The World War III Peace Plan Leaders needed to destroy the Protection Fraud Networks that manage Endemic Corruption, recover control of State Budgets, resource World War III Defences and resource a Just World Order. They needed the Corruption Remedy Test Case to reach the Budget Fraud Stage as soon as possible.
2. The Peace Plan Management Agreement got Test Case Status to the UK, Test Case Manager Status for the Coronation Oath Enforcement Authority, Interested Party Status for the Peace Plan States and the Common Law for the Just World Order. Delivery Commitments by Japan and the USA financed the Remedy Budgets for the Post Office Scandal and Contaminated Blood Scandal. Corruption Exposure did Terminal Damage to the Network Agents who used the Conservative Party to get a Cabinet Majority and got a Power Transfer from Network Agents who used the Labour Party to Network Agents get a Cabinet Majority and the Premier Office for Sir Keir Starmer.
3. The 2024 Parliament Session Grant contained Corruption Remedy Conditions. They got Conditions Breach Proof against the Cabinet and Dismissal Execution Default Penalty against Prime Minister Sir Keir Starmer. The Landslide Majority with many Novice MPs created the need for International Support for Dismissal Execution against the Prime Minister. The Peace Plan Leaders needed Dismissal Execution against him to get a Power Transfer, and end to Budget Frauds and recovery of the State Budget. They extorted 3.5 Defence Budget Commitments that needed and end to the Budget Frauds. They supported the UK Opposition Leaders using the Child Prostitution Scandal to extort Remedy Delivery Commitments in July 2025 that would have achieved Total Destruction of the Protection Fraud Network. They were Commitment Frauds. Their Absolute Priority was Remedy Denial Frauds. They appointed Lord Peter Mandelson the UK Ambassador to the USA. He negotiated the Treason Deal. It got Big Bribes for USA President Mr Trump, Epstein File Concealment Frauds for the UK Cabinet, Defence Sabotage frauds for Russia against Ukraine, Western Europe and NATO and Money Laundering for Trump Family Members. Deal Failures got the Iran Frauds in hope they would get War Hero Status + Treason Immunity.
7. Dismissal Failures got the UK Leadership Farce Scandal and then the Leadership Deals. They traded No Contest Support Votes for Candidate Mr Burnham to get Protection Fraud Commitments for Endemic Corruption Managers. The Truth Rights Act Budget Fraud + Kind Words from Mr Burnham for Sir Keir Starmer and Protection Fraud Proof. The World War III Peace Agreements got Common Law for the Just World Order. It vests Discovery Rights in the Victim and Citizen for Past Wrongs. The Truth Act reduces the Common Law Rights. It is the Lead Budget Fraud for the Peace Plan States.
