The Peace Plan Leaders need an end to Budget Fraud to recover control of State Budgets. Top Network Agent Sir Keir Starmer used the UK Premier Office to manage Remedy Delay Frauds.

Equity Governance needs Ordinary Competent People with Common Law Training to staff Little System Justice.

Change Management needs a few Explanation Documents most of the population can understand. The only difference between them is how much help they need to understand them.

Dictator Governance rewards Copycat Cleverness most of which Resources Cowardice. Equity Governance rewards Insight Cleverness most of which Resources Courage.

Mr. Peter Mandelson, Sir Keir Starmer and Top Financiers thought the Remedy Delay Frauds were clever. What matters is not what they think in the 2026 Summer Recess, but what Jury Judgments got by Remedy Delivery. Frankly, the Delay Frauds have made Massive Wealth Transfer from Top Fraud Managers and Top Fraud Beneficiaries much easier to manage.

Summer 2026 UK Corruption Exposure could have influenced the USA Elections in November 2026 and got a Treason Impeachment Majority in the USA Senate against President Mr. Trump. The UK Exposure Denial Frauds that get Remedy Delays for President Mr. Trump against everyone else will get Mass Anger.

In 1998, UK Citizens got the World Lead for Advanced Electronic Signatures. It was an Identity Proof Transfer for the Citizen against the State. Oppression Frauds by the Democratic Dictates denied use of it. In 2023, the Peace Plan Delivery Agreement got use of it. The preparations included Wacom Brand Marketing that used Advanced Electronics Signatures that were not yet available. The Identify Proof Transfer is a Power Transfer for the Individual against Big Systems. It enables Relation Rebalancing for the Individual against Market Managers on a Massive Scale. There will be Mass Anger when people know Market Frauds denied them use of it from 1998 until they get it.

Mass Anger will fuel Confidence Transfers for Remedy Managers + Confidence Collapses against Corruption Managers that get Asset Freezing + Asset Forfeits and speed up the recovery of State Budes for the Peace Plan Leaders.
