Upon the Case Papers containing Corruption Allegations that:

1. The Coronation Oath Enforcement Authority needed Endemic Corruption Proof against the UK Judiciary to get International Support for Remedy Management,
2. Bribery Management by Lord Peter Madelson for the General Osteopathic Council, Pharmaceutical Industry that got Osteopath Misdescription 2022 0062 Trial Frauds by Worcester Judges was part of the Endemic Corruption Proof Set used to get the 2023 World War III Peace Agreement for Democratic States
3. The Delivery Commitments from Japan and the USA got Remedy Enforcement against Fraud Profiteers that financed the Remedy Budgets needed to for the Post Office Scandal and Contaminated Blood Scandal and the Bribery Proof against Lord Peter Mandelson was particularly useful getting it.
4. Scandal Exposure enabled the 2024 General Election to do Massive Damage to the Protection Fraud Network, but it retained control of the Cabinet and Parliament
5. The 2024 Parliament Session Grant contained Corruption Remedy Conditions that required Total Destruction of the Protection Fraud Network. Condition Breaches got Remedy Denial Fraud Findings against the Cabinet and the Default Dismissal Penalty against Prime Minister Sir Keir Starmer. The Landslide Governing Majority had many Novice MPs. It created the need for the Peace Plan States to service the Dismissal Process against him. It needed the Child Prostitution Scandal + Treason Deal Scandal + Epstein Scandal + Mandelson Scandal + Starmer Scandal + Leadership Contest Deal Frauds Scandal that No Contest Support Votes for Candidate Mr Burnham had Protection Fraud Conditions for Sir Keir Starmer + Mr Mandelson + Others.
6. Cases 2026 00112 + 2600026217 + CA1074323 are three of the Remedy Test Cases that got the Leadership Deal Fraud Proof and prepared for Integrity Tests of Prime Minister Mr Burnham.
