

Council Tax 2600026217 Liability Order High Court Appeal Case Statement Application

19th July 2026

Applicant: Ms Davies v Respondent: Worcester City Council + Interested Parties: UK Cabinet + Ministry of Justice

REASONS: The World War III Peace Plan got Corruption Remedy Test Case Status for the UK. It got the Epstein Scandal + Mandelson Scandal + Starmer Scandal + UK Leadership Contest Deals Scandal. No Contest Support Votes for Candidate MP Mr Burnham had Protection Fraud Conditions for Keir Starmer + Peter Mandelson + Others. The Test Case needs Integrity Tests of Prime Minister Mr Burnham using the Taxation Fraud Scandal + Budget Fraud Scandal

1. Honest Citizen Ms Davies is a Talented Healer and was a Registered Osteopath. She did not know the Protection Fraud managed Endemic Corruption or that Mr Mandelson was a Top Network Agent. In 2023, Bribe Management by Lord Mandelson for the General Osteopathic Council and Pharmaceutical Industry got Osteopath Misdescription Trial Frauds from Worcester Law Courts. Equity Lawyer Mr Ellis provided Corruption Investigation Services for the Coronation Oath Enforcement Authority. The Trial Judges issued a Court Room Exclusion Fraud Order to Court Officers against him. Crown Court 1 was the Crime Scene and Audio Records were Event Proof. The Public Gallery was not in the Court Room. It was an Elevated Viewing Gallery with a separate entrance. He went in the Public Gallery. The Assault Complaint Fraud CA1074323 by the Court Officers got an Arrest Fraud + Detention Fraud + Investigation Frauds + Charge Fraud by West Mercia Police that stopped him being Public Gallery Witness to the Trial Frauds. Case Management by him got Audio Record Concealment Fraud Proof + Other Fraud Proof against them. The Defence Statement + Production Demand + Bail Surrender Refusal by him got Confidence Collapses by the Worcester Judges and Case Closure Frauds. It added to Endemic Corruption Proof against the Judiciary. The Equity Lawyer gave it to the Crown. King Charles used it to negotiate the World War III Peace Plan for Democratic States. The Peace Agreement required Sovereign States to destroy the Protection Fraud Networks that manage Endemic Corruption, recover control of State Budgets, resource World War III Defences and resource a Just World Order. The Management Agreement got Corruption Remedy Test Case Status for the UK and Test Manager Status for the Coronation Oath Enforcement Authority.
2. Lord Mandelson as one of the Obvious Targets for the Corruption Remedy Test Case. He procured the appointment of Keir Starmer as Director of Public Prosecutions and managed a series of Business Expansion Plans for the Protection Fraud Network. One was a Blackmail Business that used Mr Epstein for Hosting Services that enabled Sex Crime Entrapment and Sex Crime Framing Frauds against Business Managers of Takeover Targets Top Financiers used Blackmail Services to make Takeover Profit Frauds and pay Election Contributions to get Protection Frauds. Remedy Enforcement by Japan and the USA against fraud Profiteers financed the Post Office Scandal and Contaminated Blood Scandal. Corruption Exposure damaged the Protection Fraud Network
3. The Protection Fraud Network used Cabinet Office and the Judiciary to provide Protection Frauds for Crime Businesses managed by State Officers and Law Court Judges. They managed Endemic Corruption. They needed Honest Officers for Honest System Pretence Frauds and a Risk Control against Unauthorised Corruption by Renegade Corrupt Officers. They made a Records Fraud Plan. It used Record Proof Denial Frauds against Victims and Records Verification Denial by Officers to get Record Fraud Powers in the State. A Potential Victim Classification for everyone made it Standard Practice. It needed Honest Officers for Honest System Pretence Frauds. It needed Management Systems that forced Honest Officers to choose between Fraud Exposure that was a Career Ruin Risk and Enforcement Frauds for Self-Preservation. The Records Fraud Plan vested Delegation Powers in the Magistrate Court for Summons Issue by Local Authorities. They used Records Verification Denial to develop the Corrupt Practice of Delegation Record Failures. It enabled Extortion Crime Partnerships of Local Officers and Local Judges to use Tax Liability Pretence Frauds to get Tax Liability Orders. They made Extortion Profits and Financial Instability Service Profits.
4. Budget Fraud Complaints by Citizen Ms Davies and Remedy Denial Frauds by All Relevant Authorities motivated a Council Tax Payment Refusal Protest by her. They discovered the Records Fraud Plan. Tax Liability Order Proof Demands by her got Confidence Collapses + Enforcement Failures by Worcester City Council. The Corruption Remedy Test Case got the Epstein Scandal + Mandelson Scandal + Starmer Scandal + Leadership Farce Scandal and Angry Fraud Orders from Prime Minister Sir Keir Starmer. The Bankruptcy Fraud Order against got the Statutory Demand Revocation Application 2026 00112 Refusal Fraud Appeal dated 19th March 2026 by Citizen Ms Davies and Confidence Collapse evidenced on Day 90 by the Bribery Conflict Disqualification Admission by Judge Mr Salmon evidence by the Appeal Return + High Court Reference Letter dated 18th June 2026 from the County Court. The Summon Forgery dated 22nd June 2026 and Validation Enquiries by Citizen Ms Davies got Delegated Authority Power Admissions + Authority Proof Denial Frauds that are Summons Forgery Proof. All of it supports Budget Fraud Investigations for the Coronation Oath Enforcement Authority.
