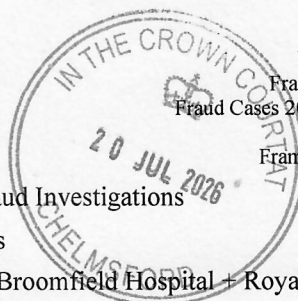

Best Advice:

1. Accountability Guidance Applications to the General Medical Council Ethic Committee by GP Dr Nancy Mangemba + Renal Consultant Dr Abeygunasekara and Professor Ali in the circumstances:
 - 1.1. The NHS Patient 6328556020 Medical Records of Broomfield Hospital from 18th April 2020 to date are Murder Conspiracy Proof + Murder Concealment Fraud Proof + Murder Survival Proof.
 - 1.2. At all times the Renal Team has had more than 50 doctors and nurses who know they have Murder Witness Status
 - 1.3. Governance Frauds forced the choice of Notice Nothing + Do Nothing or Legal Capacity Deprivation Frauds to do Remedy Denial Damage using Mental Health Frauds or Effective Treatment that is Career Suicide.
 - 1.4. Corruption Exposure by NHS Patient 6328556020 motivated a Kill Order in August 2018 from Prime Ministers Mrs May that a Sussex GP, Sussex Renal Team and London Transplant Team tried to service with a Murder Management Plan. It needed Mental Illness Diagnosis Frauds + Lethal Prescription Fraud using a Side Effect that binds urea to red blood cells that does Fatal Sabotage to Renal Failure Dialysis Treatment. A Mental Illness Case Reference Call by the Sussex Hospital Doctors got an Unauthorised Case Reference by the Sussex GP, Mental Examination Refusal by the Patient, Blackmail Frauds by the London Organ Transplant Professor Drage that made a Mental Examination a Treatment Condition got a Priority Decision by the Patient for the Corruption Investigation against Personal Welfare and use of the Medical Records for a Blackmail Investigation that got Liability Findings against Prime Minister Mrs May and Dismissal Decisions that got the Forced Resignation from her and the Forced General Election before the Year End.
 - 1.5. The Patient moved to London, enrolled as New Patient with the Fencepiece Surgery, asked for an Enrolment Appointment, got it for Forced Resignation Publicity Day and used it for a Kidney Failure Treatment Services that got Blood Tests. It motivated Influence Frauds that got Mental Health Fraud Efforts by the GP, Service Refusals by the Patient got an Urgent Renal Treatment Appointment in a Local London Hospital, use of it for Treatment Blackmail Fraud by the Hospital Consultant that got Service Refusals by the Patient, a Mental Health Arrest Fraud Service Call Disappearance by the Hospital Consultant that the Patient, a Rapid Escape by the Patient who was chased by a Young Male Doctor. When they were in the street the Patient turned round, told him not to be so stupid, got in the car, was driven away and went into Half Hiding. The Secret Service knew where he was but did not tell the Medical Team or the Mental Health Arrest Warrant Fraud Officers. He managed the Leadership Contest Integrity Tests. Leadership Deals got Support Votes for Candidate Mr Johnson on Protection Fraud Conditions. The Arrest Warrant was Timed Out. Prime Minister Mr Johnson made a Poison Kill Decision conditional upon an Election Victory. The Patient managed Election Integrity Tests. It discovered Election Deals by Prime Minister Mr Johnson and Opposition Leader Mr Corbyn used Mental Health Detention Frauds to stop Corruption Remedy Independents standing. ON 12th December 2019 the General Election Victory gave Prime Minister Mr Johnson the confidence to issue the Poison Kill Order to the Secret Service using Poisoned Tea in the café across the road from the Royal Courts of Justice on 18, 19 or 20 December 2021. The 1st Crisis was in week 6 – 7. It was Big Molecule Excretion that needed Sweat Gland Ruptures. Breaking 2,500 Rupture Scabs on the back and thighs enabled reuse of Ruptured Glands that saved the rest of the skin and the life. The 2nd Crisis was Reducing Blood Pressure until Total Collapse. End Stage Kidney Failure got an Emergency Admission to Broomfield Hospital on 18th April 2020, Secret Mental Illness Diagnosis Fraud + Lethal Prescription Fraud by the Renal Team + Lethal Side Effect Questions by the Patients + Mental Health Murder Termination + Low Blood Pressure Remedy Denial Murder by the Renal Team. In 2022, Forced Resignation Anger motivated a 2nd Poison Order from Prime Minister Mr Johnson that got Immediate Treatment from Broomfield Hospital. On 24th November 2025 a Cancer Test Request got a Test Refusal + Mental Illness Case Reference Fraud by GP Dr Nancy Mangemba + Fraud Complaints by the Patient. The Low Blood Pressure Total Collapse on 6th January 2026 was onto a Dialysis Bed and got Immediate Treatment and a Day 4 Release. Mental Health Arrest Warrant Fraud Orders from Prime Minister Sir Keir Starmer got Personal Responsibility Refusals by All Relevant Officers.
