This Immunity Negotiation Offer will be sent by Royal Mail Recorded Delivery Post to the Governor on trust to give it to Sir Jeffery.

A Remedy Co-operation Request dated today will be sent Royal Mail Recorded Delivery Post to Sir Jeffery. It mentions the Immunity Negotiation Offer.

In 2004, the preparations for the European Referenda got Election Fraud Proof against the European Leaders including Prime Minister Mr Blair. The Lawful Business of UK Citizens made inevitable the exposure of the Election Frauds before the 2005 Referenda. The EU Leaders made an Election Fraud Concealment Plan. It got Criminal Conspiracy Proof against them. The Equity Lawyer gave it to Queen Elizabeth. One was a Stop Failure Framing Fraud against Patrick Coyle. He and David Barr helped the Equity Lawyer get the Corruption Proof Set against Northern Ireland.
