On got creation of the General Osteopathic Council to manage Market Frauds for Drug Use Competitors against Registered Osteopaths. One was a Patient Satisfaction Internet Publicity Prohibition. Fraud Complaints by Citizen Ms Davies motivated Conflict Jurisdiction Disqualification Denial Frauds + Conflict Jurisdiction Qualification Pretence Frauds + Mental Illness Presumption Frauds + Pending Investigation Suspension Frauds by the General Osteopathic Council. Fraud Remedy Appeals by the Citizen got Court Fee Extortion Frauds + Case Process Denial Frauds by the High Court that enabled completion of Osteopath Practice De-registration Frauds + Osteopath Misdescription Crime Prosecution Frauds by the General Osteopathic Council against the Citizen. Standard Bribery got the Profession Authority Frauds. Special Bribery was needed for Criminal Court Frauds. Special Bribery Management in 2022 and 2023 by Lord Peter Mandelson for the General Osteopathic Council and Pharmaceutical Industry that got Osteopath Misdescription 22 00069636 Magistrates Court Trial Frauds + 2022 0062 Crown Court Appeal Re-Trial Frauds by Worcester Judges. The Crown Court Appeal Re-Trial got Plea Hearing Audio Records that are Fraud Proof against Judge Mr Salmon. Equity Lawyer Mr Ellis attended as Legal Assistant and Jurisdiction Witness and filed a Plea Hearing Fraud Report. The Re-trial Judges issued a Re-trial Exclusion Fraud Order against him in expectation it would prevent him filing a Retrial Fraud Report. Court Officers executed the Exclusion Fraud Order. They managed it badly. The Court Room was the Crime Scene and the Audio Records were Evet Proof. The Public Gallery had a separate entrance. The Equity Lawyer took a seat in the Public Gallery. An Assault Complaint Fraud by the Court Officers and an Arrest Fraud + Custody by West Mercia Police removed the Equity Lawyer but did not stop a Re-Trial Fraud Report with the Audio Records the Fraud Proof. Audio Record Production Demands by the Equity Lawyer got Evidence Concealment Frauds + Charge Frauds by the Case Investigators + Release Delay Frauds that got a Late Arrival for Dialysis Treatment at Broomfield Hospital, Chelmsford, Essex. The Defence State + Audio Record Production Demand + Contempt Fraud Counter Charge + Bail Surrender Refusal of the Equity Lawyer got a Confidence Collapse + Case Closure Fraud. Corruption Complaints by the Citizen got Process Denial Fraud Proof against the Authorities. A Council Tax Payment Refusal Protest from the Citizen discovered Council Tax Claim Management Frauds by the City Council and Magistrates Court + Liability Order Forgeries by the City Council. Order Proof Production Demands by the Citizen got Bailiff Enforcement Terminations. The Epstein Scandal + Mandelson Scandal + Starmer Scandal motivated an Enforcement Fraud Order by Prime Minister Sir Keir Starmer and the Statutory Demand Fraud Revocation Application 2026 00112 Refusal Appeal by the Citizen. On Filing Day 90 it got the Bribery Conflict Disqualification Admission + High Court Reference by Judge Mr Salmon + Case Process Delay Frauds by the High Court. Meanwhile, the Stop Failure NX18MZZP Case Management motivated a Framing Fraud Investigation by the Equity Lawyer and the use of a CA1074323 Warrant Forgery for an Arrest Fraud + Custody Fraud + Peter Mandelson Crime Evidence Rejections Frauds by Herford Police + Essex Police + Magistrates Courts + Crown Court. Budget Fraud Complaints force Prime Minister Mr Burnham to choose Just Remedies or Enforcement Frauds.
