Fraud Motive Reasons

1. In 2004, the preparations for the European Referenda got Top Level Corruption Proof against European Leaders including Prime Minister Mr Blair. Equity Lawyer Mr Ellis and Queen Elizabeth used it to revive active service of the Coronation Oath Enforcement Authority and start a Corruption Remedy Process. The Equity Lawyer has provided Support Services ever since. It discovered the Protection Fraud Network managed Endemic Corruption.

2. Citizen Mr Patrick Coyle [the Son] is the eldest son of Mr John Coyle [the Father]. The Son did not know the Father managed Paedophile Entrapment Frauds + Paedophile Framing Frauds for the Northern Ireland Protection Fraud Network. The Father thought he did know. In 2014 the Corruption Remedy Process had made so much progress the Protection Fraud Network needed a Business Expansion Plan to avoid Total Collapse. They used Family Sabotage Frauds + Child Thefts to get Big Budgets + Budget Fraud Profits and Expatriation Frauds to get Money Laundering Services from Sovereign States for Cabinet Officers and the Judiciary. The Plan Commitment Proof from Northern Ireland was Family Sabotage Frauds + Ruin Frauds managed by the Father against the Son. The Son fled to England. In June 2016 he discovered the Coronation Oath Enforcement Authority. He has provided Support Services for them when needed ever since.

3. In 2023, the World War III Peace Plan for Democratic States needed Endemic Corruption Proof against the UK Judiciary. In 2023, Bribery Management by Lord Peter Mandelson for the Pharmaceutical Industry got Osteopath Misdescription 2022 0062 Trial Frauds from Worcester Judges for the General Osteopathic Council against Citizen Ms Davies. Exclusion Fraud Orders from Trial Judges against Equity Lawyer Mr Ellis got Execution Services by Court Officers and West Mercia Police and Assault Framing Fraud 22CA1074323. Crown Court 1 and the Public Gallery were the Crime Scene. Crown Court Audio Records were Event Proof. Audio Record Concealment Frauds were Framing Fraud Proof. It was part of the Endemic Corruption Proof that King Charles used to negotiate the Peace Plan. In December 2023, the G7 Summit got Agreement Signatures. It got Corruption Remedy Test Cases Status for the UK and Test Manager Status for the Coronation Oath Enforcement Authority. Commitment Deliveries by Japan and the USA got Remedy Budgets for the Post Office Scandal and Contaminated Blood Scandal. Corruption Exposure enabled 2024 General Election to service a Power Reduction for the Protection Fraud Network Agents and a Minority Vote to get a Landslide Majority led by that used the Conservative Party to control Parliament and a Minority Vote to get a Landslide Governing Majority for the Remaining Network Agents in Parliament led by Sir Keir Starmer. In January 2025, the Peace Plan States and UK Opposition Leaders used the Child Prostitution Scandal to extort Remedy Delivery Commitments from the UK Cabinet. They were Commitment Frauds. They gave Lord Peter Madnelson the office of UK Ambassador to the USA. He negotiated a Treason Deal. In January 2025 the Peace Plan States and UK Opposition Leaders extorted Remedy Delivery Commitments from the UK Cabinet. They were Commitment Frauds. They appointed Lord Mandelson the UK Ambassador to the USA. He negotiated the Treason Deal. It got Big Bribes for USA President Mr Trump, Epstein File Concealment Frauds for the UK Cabinet and Defence Sabotage Frauds for Russia against Ukraine, Western Europe and the North Atlantic Treaty Organisation. and Money Laundering for Trump Family Members [because US Officers and Trump Employees were an Exposure Risk].

4. Treason Deal Failures motivated Oppression Frauds against Citizens. A Treason Defence Plan by USA President Mr Trump needed Iran War Frauds + Massive Bombardment + Total Victory + Dictated Peace Terms + War Hero Status + Treason Immunity. It failed. It got War Fraud Liability. Leadership Frauds by the UK Cabinet created the need for Local Authority Election Defeats to get an MP Resignation + Makerfield By Election and Leadership Contest. **Corruption Remedy Negotiations Offer** from Equity Lawyer Mr Ellis to the Metropolitan Police Commissioner, Director of Public Prosecutions and Attorney General in England and the Attorney General and Premier of Northern Ireland for Immunity Terms in exchange for Remedy Co-operation.

Negotiation Invitation to the Attorney General and Premier of Scotland in the interests of Sovereign Unity. Equity Lawyer Mr Ellis regrets he cannot recommend Scottish Lawyer Mr Jim Friel as the Remedy Negotiator for the Scotland People because he died in July 2014. Mr Friel got Compelling Proof that Sex Crime Framing Frauds by the State against Citizens enabled Blackmail Frauds by Scottish National Party Leaders against Political Opponents. Emigration Advice from Lawyer Mr Friel got Advice Acceptance and 2011XC513 Case Use Authority from the Key Victim that was conditional on him getting Residence Rights in a Middle Eastern State. Mr Friel died. The Key Victim got Residence Rights a fortnight later. No Scotland Lawyer had the confidence to use the Corruption Remedy Process and Blackmail Fraud Proof against Scotland Authorities to influence Independence Referenda in September 2014.
