Polite Request + Best Advice for Remedy Co-operation for the World War III Peace Plan:

1. In 2023, Kings Charles used Endemic Corruption Proof to negotiate the World War III Peace Plan for Democratic States. The objective is to end Budget Frauds, recover control of State Budgets and use Fraud Savings to resource World War III Defences and resource a Just World Order.
2. It needs Change Management of Business Systems from servicing Dictator Governance to servicing Equity Government. Evidence Exclusion Frauds + Dismissal Frauds + Case Closure Frauds service one and Problem Identification + Remedy Delivery service the other.
3. The Just World Order needs Top Level Corruption Controllers that are Credibly Independent of the State, Law Courts, Cabinet and Parliament. The UK is unique. It is a Peace Plan Signatory that has a Credibly Independent Top Corruption Controller. It is the Coronation Oath Enforcement Authority.
4. It has a Fundamental Flaw. Everyone knew the Crown was Head of State and Lord Bishops sat in the House of Lords, and they had Corruption Control Responsibilities. The Fundamental Flaw was that very few knew how they did it, or that they were part of the Coronation Oath Enforcement Authority. The Law Professions adapted to enable development of the Integrity Test Skill Set needed to function as Equity Lawyers in sufficient numbers to service the Crown, staff the Judiciary and provide 1 in 50 Regulated Lawyers, 1:100,000 of the population, to service the Citizen. Most of the Regulated Lawyers knew that someone would be able to do something, asked around and eventually were referred to an Equity Lawyer. Sometimes they knew them but not that is what they were. The Fundamental Flaw did Lifelong Damage to the Two Brothers. They suffered State Care Abuse. Between them they had the intelligence and drive to overcome the Fundamental Flaw and get Corruption Remedies. Events prevented them from doing so.
5. In 1956, the Suez Scandal was a disgraceful end to the Colonial Era for the UK and France. It motivated then to make the Dictator Governance Plan for Western Europe. It vested Dictator Powers in the Cabinet. It used Sabotage Frauds against Leadership Competitors.
 - 5.1. Sex Crime Investigation Denial Frauds were the Sabotage Frauds against Religious Leaders.
 - 5.2. Evidence Frauds and Education Frauds were the Sabotage Frauds against the Coronation Oath Enforcement Authority. Evidence Frauds denied a Reliable Supply of Admissible Evidence for Parliament Session Decisions. Education Frauds omitted any mention of it so that everyone would forget it existed.
 - 5.3. Mental Illness Classification Frauds + Drug Remedy Development Frauds were Sabotage Frauds against the Personality Range that could manage Corruption Remedies against a Dictator Regime. The Ice Age created a Food Shortages that forced the Northern Populations to live in Small Groups. They were very dependent on whoever could find food in harsh conditions. Isolate Personalities coped better than Herd Personalities. Most people can recognise a Chronic Complex Challenge. A few will make a Remedy Attempt. Most people will do something provided they do not consider it too much. Herd Personalities need Group Support for a Remedy Attempt. Isolate Personalities can make Lone Efforts. A tiny minority have Bridge Personalities. They can cope with Deep Focus and Social Engagement and have Commitment Control needed for Chronic Complex Challenges. They can engage, persevere, disengage, review best management, and re-engage as often as necessary until Remedy Delivery. The Ice Age might have increased the range of Isolate Personalities and increased the proportion of Isolate in the population. The Ice Age ended. The Food Supply increased. It supported Large Groups. They favoured Herd Personalities and marginalised Isolate Personalities.
6. Endemic Corruption has created the need for Corruption Remedies. The Corruption Remedy Process got Proof Positive that Bridge Personalities and Isolate Personalities are better qualified to cope with Remedy Management.
7. The Peace Plan Leaders need everyone to understand the Personality Spectrum and the Health Frauds + Propaganda Frauds against Isolate Personalities. Some of the Peace Plan Leaders are Bridge Personalities and Isolate Personalities. They used Herd Personality Pretences to succeed in the Governing Class Herd.
8. The Peace Plan got Corruption Remedy Test Case Status for the UK, Test Manager Status for the Coronation Oath Enforcement Authority, Interested Party Status for Peace Plan States and Common Law for the Just World Order. It resourced Remedy Budgets for the Post Office Scandal and Contaminated Blood Scandal. They enabled the 2024 General Election to get a Power Transfer from the Network Agents who used the Conservative Party to Network Agents that use the Labour Party. The Child Prostitution Scandal + Epstein Scandal + Mandelson Scandal + Starmer Scandal + Treason Deal Scandal + Leadership Contest Denial Fraud Scandal + War Frauds Scandal + Taiwan Betrayal Scandal + Leadership Deal Scandal that got No Contest Support Votes from the Network for Candidate Mr Burnham conditional upon Protection Frauds for Mandelson + Starmer + Trump + Others.
