Immunity Negotiation Management Proposals

Internet Publicity and Email Service of the Document Set got No Objections to Immunity Negotiations from Interested Parties. Immunity Negotiations need Confidential Exchanges that Prison Authorities do not control. Best Management needs an English Open Prison that is local to the Equity Lawyer. Sir Jeffery was a Northern Ireland Politician from before the 1997 Peace Settlement until after the 2023 World War Peace Plan for Democratic States. He held High Office in periods when the Protection Fraud Network had Cabinet Control. The Immunity Negotiations Proposals force Sir Jeffery, Prime Minister Mr Burnham and the UK Cabinet to choose between the Peace Plan and Protection Frauds.

The Circumstances

Sir Jeffery was a Northern Ireland Politician from before the 1997 Peace Settlement until after the 2023 World War Peace Plan for Democratic States. He held High Office when the Protection Fraud Network dominated UK Governance. Full Disclosure Immunity will get what he knows for the Peace Plan. The Co-operation Request dated 22nd July 2026 is enclosed with this letter. The Prison Governor holds the other documents listed below on trust for Sir Jeffery.

Research Investigations got Case Management Sabotage Fraud Proof against English Prisons. Test Cases discovered Access Controls denied Appeal Papers + Other Papers. They denied a Postage Stamp Allowance for Case Management including Appeals. It forced use of the Social Postage Stamps that had a 2 Per Week Limit. Access Controls denied use laptops and printing for some but not others. It forced handwriting of Multiple Documents for filing with Authorities and service on Interested Parties. Communication Thefts limited what went in or came out of the Prison Cell.

In 2004, Queen Elisabeth received Endemic Corruption Proof. She used it to receive active service of the Coronation Oath Enforcement Authority and start a Corruption Remedy Process. It has continued ever since. It uses Research Investigations to discover the structure and strength of the Endemic Corruption Managers and then Remedy Delivery. The Standard Process is Dismissal Executions against the Judiciary by a United Parliament, Victim Identification, Case Remedies and an International Agreement to resource a Just World Order. A Parliament Unity Failure gets a Special Process. Corruption Proof from the Citizen get Case References by the Crown, Remedy Priority Findings by the Parliament Sessions Court, Remedy Demands by the Crown get the No Budget Refusal Reason by the Cabinet. The Political Prisoner Release Demand got a very bad Refusal Reason. It was the Release Costs exceeded the Imprisonment Cost. It enables Scandal Selection. Meanwhile, the Special Procedure gets Endemic Corruption Proof Set against the Judiciary Alone. The Crown uses it to negotiate the International Agreement and uses that to get International Support for Corruption Remedies in the UK.

In 2004, the Endemic Corruption Proof was European Reference Frauds by EU Leaders. They needed Concealment Frauds. It used Extradition Frauds against a UK Citizen and Imprisonment Frauds against him and a Netherlands Citizen. The 1st Effort used Armed Netherlands Police in UK soil to supervise UK Customs and Kent Police in a Kidnap Extradition Fraud that failed. The 2nd Effort used an Extradition Treaty for Warrant Frauds and Court Frauds. The Coronation Oath Enforcement Authority used the 2nd Effort for the 1st Research Investigation. It got Extradition Fraud Findings + Imprisonment Fraud Findings. Queen Elizabeth and Charles, Prince of Wales, used the Commonwealth Conference for a Remedy Co-operation Test of World Leaders. It got 40,000 Imprisonment Fraud Releases.

The Remedy Process got Remedy Sabotage by the UK Cabinet from the Corruption Notice to the Crown and Parliament in October 2004 to the General Election in 2010. It got Remedy Co-operation from Prime Minister Mr Cameron, Deputy Prime Minister Mr Clegg and Opposition Leader Mr Miliband between the General Elections of 2010 and 2015, and then from Prime Minister Mr Cameron. The 2015 Parliament Session Grant required Set Up Conditions for Remedy Delivery and a Test Case Year. Mr Cameron used the Test Case Year for the European Referenda because he feared Corruption Exposure would increase the Leave Vote. He led the Remain Campaign, lost and resigned. Leadership Contest Deal Frauds used Big Bribes to get Support Votes from Key Influencers for Candidate Mrs May and Cabinet Control for the Network. It got a Remedy Delivery Delay of 10 years so far. It proved the Constitutional Balances that the Peace Plan States need to manage a Just World Order.
