Best Advice is Voluntary Disclosure by Essex & Suffolk Water make the Water Direct Evidence. REASONS:

1. The 2026 Leadership Deal got No Contest Support Votes that were, in effect, a UK Premier Office Appointment Fraud by the Protection Fraud Network for Candidate Mr Burnham. The Budget Fraud Investigations force him to choose before the end of the Summer Recess between Corruption Remedies and Protection Fraud Enforcement.
2. The circumstances raise Reasonable Suspicions of Forgery + Accounting Frauds.
3. The Coronation Oath Enforcement Authority manages the Profession Governance responsibilities of Parliament. In 2004 the Equity Lawyer got Endemic Corruption Proof and gave it to Queen Elizabeth. She used it to revive active service of the Coronation Oath Enforcement Authority used it to manage a Corruption Remedy Process. The Equity Lawyer has provided Investigation Services ever since.
4. The Research Investigations discovered that the Protection Fraud Network uses Cabinet Office and the Judiciary to provide Protection Frauds for Crime Businesses managed by State Officers and Law Court Judges They require Business Systems that manage the Evidence Exclusion Frauds needed to get Protection Frauds for Plunder Frauds.
5. The Network Agents tried to stop the Research Investigations by managing Ruin Frauds against the Equity Lawyer. They used Market Exclusion Frauds + Asset Thefts + Asset Freezing Frauds. He used them to get Corruption Proof against the State and Remedy Denial Fraud Proof against the Law Courts and Protection Fraud Proof against Cabinets and Parliaments. It made everything an Investigation Opportunity.
6. In August 2021 a Residential Tenancy from Chelmsford Housing Partnership to the Equity Lawyer enabled him to conduct Research Investigations of the Water + Sewage and Gas + Electricity. He resents waste. He has a Low Consumption Policy. He did nothing and waited to see what happened.
7. In September 2021, Corruption Proof validated Dismissal Executions against the Judiciary by Parliament. Dismissal Failures were Protection Fraud Proof against the Cabinet. It got the Default Dismissal Penalty against Prime Minister Mr Johnson. The Dismissal Failure was Protection Fraud Proof against Opposition Leader Sir Keir Starmer. He used the Covid Regulation Breach Party Scandal for Dismissal Effort Pretence Frauds while keeping him in office. Corruption Remedies need the Special Process. The Coronation Oath Enforcement Authority gets Endemic Corruption Proof against the Judiciary. The Crown uses it to negotiate an International Agreement for Democratic States to resources a Just World Order.
8. Endemic Corruption Research Investigation:
 - 8.1. Expiry of Restraint Frauds against the Equity Lawyer enabled Fraud Claim filing in the Law Courts.
 - 8.2. The Contempt Fraud Claim filed on 18th March 2022 got Issue Denial Fraud Proof against the High and J00RM833 Issue Fraud Proof + Restraint Fraud Proof against Romford County Court that got
 - 8.3. Meanwhile, No Gas Supply + Gas Charge Frauds and an Electricity Supply + Electricity Charges by British Gas got Electricity Payment Refusals by the Equity Lawyer pending Gas Charge Fraud Remedies by the Equity Lawyer to stop use of Electricity Payments as Gas Payments and Electricity Enforcement Frauds to get Extortion Profits. Enforcement Action by British Gas motivated the Gas Debt Fraud Harassment Claim filing on 25th April 2022 by the Equity Lawyer against British Gas. It got Case Reference J00CM673 + Process Denial Fraud Proof against the Chelmsford County Court
 - 8.4. The Contempt Fraud Claim got Process Denial Fraud by the High Court + Issue Orders to the County Court that got J00RM833 Issue Frauds by Romford County Court + Restraint Fraud Case Reference to Higher Rank Judges that was a Fraud Ownership Transfer Effort by Lower Rank Judges against Higher Rank Judges.
 - 8.5. In June 2022, two By Election Defeats got Mass Resignations from Ministerial Office and a Forced Leadership Contest + No Contest Support Vote Offers on Protection Fraud Conditions by the Network and Offer Refusals by Honourable Candidates + a Forced Party Membership Vote + Election Frauds that were, in effect, a Premier Office Appointment Fraud by the Network. Election Integrity Tests by the Equity Lawyer got a Confidence Collapse in the Judiciary that is evidenced on 16th August 2022 by the Contempt Claim Fraud 2022 002575 Issue + Without Hearing Restraint Fraud.
 - 8.6. In 2023, King Charles used it, and much more, to get the World War III Peace Plan for Democratic States.
9. The Do-Nothing Decision by the Equity Lawyer motivated Water Direct Application Pretence Frauds + Process Frauds evidenced by the Refusal Decision dated 9th June 2026 with Response Failures by the Department of Work and Pensions the Refusal Decision.
10. The Water Direct Case got Confidence Collapses + Power Transfers for the Peace Plan States that support a Desertion Decision by Prime Minister Mr Burnham against the Doomed Protection Fraud Network.
