Application for:

1. Validity Investigation Order for the Citizen against Worcester City Council.
2. Disclosure Order for the Citizen that Worcester City Council, acting by the Chief Executive and the Chief Lawyer, do within 7 days file and serve Statements that admit, deny or require proof that: Council Tax 2600026217 Email Communications between 18.57 on 5th July 2026 and 17.00 on 16th July 2026 between the Citizen and Worcester Magistrates Court Officers and the Liability Trial Validity Application on 17th July 2026 by the Citizen are Conflict Jurisdiction Disqualification Proof + Conflict Jurisdiction Qualification Conspiracy Proof + Summons Issue Delegated Authority Deficit Proof + Summon Fraud Conspiracy Proof + Liability Trial Fraud Conspiracy Proof for the Citizen against Worcester City Council + Worcester Magistrates Court + Council Tax 2600026217 Case Records are Similar Fact Fraud Conspiracy Proof to that got by the Council Tax Liability Orders used for the Insolvency Enforcement Case 20026 00112 + the Conflict Disqualification Admission in the letter dated 17th July 2026 from the County Court is a Bribery Admission by Judge Mr Salmon + everything validates Fraud Findings + Contempt Liability Order + Remedy Orders for the Citizen against Responsible Individuals + Liable Parties
3. Validity Investigation Directions hearing at on September 2026

REASON:

1. The Coronation Oath is for Equity Governance using the Common Law. The Coronation Oath Enforcement Authority is the Top Corruption Controller. They use Corruption Proof for Remedy Processes: Research Investigations to discover the structure and strength of Endemic Corruption Managers + Remedy Delivery. The Standard Process is Dismissal Executions against the Judiciary by a United Parliament, Victim Identification, Case Remedies and an International Agreement for a Just World Order using the Common Law. A Parliament Unity Failure gets a Special Process. The Coronation Oath Enforcement Authority gets Endemic Corruption Proof against the Judiciary alone. The Crown uses it to negotiate the International Agreement. It gets International Support for Remedy Management in the UK. Budget Frauds by Endemic Corruption Managers deny the resources to finance Remedy Budgets needed for Scandal Exposure. It enables General Elections to get a New Governing Majority. The cycle of Corruption Exposure + Power Transfer continued until Remedy Delivery.
2. In 2021, a Parliament Unity Failure created the need for the Special Procedure. It got Endemic Corruption Proof against the Judiciary. Many cases got it.
The background to the cases of Citizen Ms Davies
3. Special Bribery by the Pharmaceutical Industry bought Market Frauds for Drug Treatment against Other Treatment. One was creation of the General Osteopathic Council to manage Profession Governance Frauds against Registered Osteopaths.
4. The 1997 General Election got a Landslide Majority, Premier Office for Mr Blair and the 1st Cabinet Office for Mr Mandelson. Both were Totally Corrupt. Prime Minister Mr Blair used Cabinet Officer Mr Mandelson as Marketing Manager for Policy Waiver Frauds. They used the £1,000,000 Tobacco Advertising Waiver Fraud for Formula 1 Car Racing as a Marketing Tool. Everyone involved knew that Prime Minister Mr Blair would demand an Extortionate Profit Share if he knew about the Crime Businesses managed by the Protection Fraud Network. No one told him. The Pharmaceutical Industry had developed Performance Enhancing Drugs for Sport Professionals and Fitness Fanatics. Mr Mandelson used Cabinet Office to manage the Performance Enhancing Drugs Expansion Plan. It used Ruin Frauds against Honest Competitors who had Influencer Status.
5. In 1998, the Finance Disclosure Denial Fraud Scandal got the 1st Forced Dismissal of Mr Mandelson. He had Cabinet Influence and continued as Policy Wavier Fraud Sales Manager for Prime Minister Mr Blair.
6. In 2000, Fraud Complaints against the General Osteopathic Council in more than 200 Constituencies got the Osteopath Profession Corruption Debate + Investigation Commitment + Pending Investigation Adjournment + Investigation Denial Fraud Special Bribery by Mr Peter Mandelson for the Pharmaceutical Industry + Investigation Denial Frauds + Adjourned Debate Denial Fraud + Routine Bribery by Mr Mandelson for the Pharmaceutical Industry that got Remedy Denial Protection Fraud by Parliaments for the General Osteopathic Council from 2000.
7. The 2001 General Election got the 2nd Cabinet Office for Mr Mandelson. Before the year end the Passport Scandal got the 2nd Forced Dismissal against him. He had Cabinet Influence and continued as Policy Wavier Fraud Sales Manager for Prime Minister Mr Blair.
8. In 2004, the preparations for the European Referenda got Election Fraud Conspiracy Proof against European Leaders including Prime Minister Mr Blair. The Lawful Business of UK Citizens made inevitable the exposure of the Election Frauds before the 2005 Referenda. The EU Leaders made an Election Fraud Concealment Plan. It used Sabotage Frauds against the Lawful Business. They were Drug Crime Framing Frauds + Imprisonment Frauds against two Lawful Business Managers. They used Netherlands Judge Trials because UK Jury Trials were an Exposure Risk. It needed Extradition Frauds against one who was a UK Citizen. The Netherlands and UK did not have an Extradition Treaty. The 1st Efforts used Armed Dutch Police on UK soil to supervise UK Customs and Kent Police for a Kidnap Extradition Fraud against the UK Citizen. Everything that could go wrong for the European

Leaders did go wrong. A complex series of events had discovered the UK Citizen would have nothing to do with drugs for profit, or when threatened with violence or under police supervision. It got Incredible Target Status for him in Drug Investigations. Top Police, Top Customs and Top Judges were the UK Top Drug Importers. They used the addresses of the UK Citizen as Decoy Addressees on the Carrier Movement Records of more than 70 Drug Shipments. They did so because if anything went wrong the Incredible Target Status would ensure Decoy Address Enquiries would get Dead End Results. It got Criminal Conspiracy Proof against them. Equity Lawyer Mr Ellis and Queen Elizabeth used it to revive active service of the Coronation Oath Enforcement Authority and start the Corruption Remedy Process. The Parliament Protection Frauds got Special Target Status General Osteopathic Council and the Pharmaceutical Industry.

9. Influence Frauds by Mr Mandelson got the Dismissal Frauds against the Mid Bedfordshire MP and replacement of him by Nadine Dorries so that she could be a Market Fraud Minder for the Pharmaceutical Industry in Parliament.
10. In 2006, the Corruption Remedy Process got the Forced 10 Months Retirement Notice from Prime Minister Mr Blair. The Notice Period enabled use of the Leadership Contest for an Integrity Test of the Governing Majority. It discovered that Cabinet Control + Party Control enabled Endemic Corruption Managers to use the Leadership Contest + Bribery + Blackmail to get UK Premiership Appointment Fraud for Sole Candidate Mr Brown on Corruption Management Conditions: Protection Frauds + Cabinet Office for Mr Peter Mandelson. The fact no one wanted him as Constituency MP created the need for an Ennoblement Fraud in 2008 to get a seat in the House of Lords as the Ministerial Office Qualification. He used Cabinet Office for Business Expansion Plans:
 - 10.1. Land Frauds for Big Owners against Small Businesses
 - 10.2. Blackmail using Sex Crime Minimum Sentence Protection Frauds from USA Authorities for Mr Epstein and Hosting Services by him for Sex Crime Entrapment and Sex Crime Framing Frauds against Business Managers that enabled Top Financiers to make Take Over Profit Frauds and use Election Campaign Contributions to buy Protection Frauds
 - 10.3. Family Sabotage Frauds + Children Thefts to get Big Budgets + Budget Fraud Profits + Expatriation Frauds to get Money Laundering by Sovereign States
 - 10.4. Land Thefts for Top Endemic Corruption Managers against the State
 - 10.5. ...more...
11. Top Endemic Corruption Managers had Target Status. Business Expansion Managers had Special Target Status.
12. Parliament Protection Frauds got Target Status for the General Osteopathic Council and Pharmaceutical Industry. Business Expansions got Special Target Status for Mr Mandelson.
13. Remedy Delivery needed whatever remained of the Proof Set that got the 2000 Corruption Debate + Recent Corruption Cases against Registered Osteopaths. The Remedy Process prepared for Remedy Delivery in 2007, 2016 and 2021. The Recent Cases were respectively those of Dr Julia Spivak [although she did not know it until 2014] + Citizen Ms Tracey Wilkinson alias Lewis + Citizen Ms Michelle Davies.
14. Everyone involved knew that the Parliament Protection Frauds got Target Status for the Pharmaceutical Industry in the Corruption Remedy Process. Routine Bribery managed by MP Nadine Dorries and Lord Mandelson got the Patient Satisfaction Internet Publicity Prohibition that was a Market Fraud by the Profession Authority for Market Competitors against Registered Osteopaths. It motivated Market Fraud Protests by Citizen Ms Davies made her a Disqualification Fraud Target. Routine Bribery managed by MP Nadine Dorries and Lord Mandelson got the Practice Disqualification Frauds by the Profession Authority against her. They enabled the Osteopath Misdescription Criminal Prosecution Frauds by the Profession Authority against her. The Pharmaceutical Industry needed a Conviction Fraud Guarantee. Special Bribery managed MP Nadine Dorries and Lord Mandelson got the Conviction Fraud Guarantee from Worcester Judges. Crown Court 2022 0062 Appeal Retrial Preliminary Hearing + Retrial in January and March 2023 enabled Citizen Ms Davies and Equity Lawyer Mr Ellis to get Audio Records that are Personal Responsibility Proof against Identifiable Individuals for Known Court Frauds. They are part of the Endemic Corruption Proof Set against the Judiciary. In May 2023, the Fraud Appeal 2023 000568 got completion of the Endemic Proof Set. King Charles started the World War III Peace Plan Negotiations. It got a Confidence Collapse + Forced Resignation in August 2023 from MP Ms Dorries. The December G7 Summit got Agreement Signatures. The Management Agreement got Corruption Remedy Test Case Status for the UK, Test Manager Status for the Coronation Oath Enforcement Authority, Interested Party Status for the Peace Plan States and the Common Law for a Just World Order.
15. Remedy Enforcement by Japan and the USA against Fraud Profiteers financed the Post Office Scandal and Contaminated Blood Scandal. The 2024 General Election to get Partial Destruction of the Protection Fraud Network that manages Endemic Corruption. The Dismissal Process against rest started immediately. The 3.5% Defence Budget Failure Scandal + Epstein Scandal + Mandelson Scandal + Starmer Scandal + Leadership Contest Denial fraud Scandal + Premiership Appointment Fraud for Mr Burnham on Protection Fraud Conditions Scandal got Set Up Conditions for the Budget Fraud Test Cases to force the choice by Prime Minister Mr Burnham before the end of the 2026 Summer Recess of a Just World Order or the Peace Plan.
16. The Budgets Frauds that financed All Frauds against the Citizen are excellent for the Budget Fraud Tests.
